#### MRS. CLOYD HAFFNER DIES OF INJURIES

Mrs. Cloyd O. Haffner, wife of "Doc" Haffner, head of the Crawfordsville, Indiana Horseshoe Club, died of injuries received in an auto accident on May 28.

"Doc" Haffner has for many years been connected with the horseshoe game in Indiana and is an N.H.P.A. member. He was Secretary-Treasurer of the Indiana Division of the N.H.P.A. in 1953. Mrs. Haffner was 60 years of age.

#### MONASMITH, WASHINGTON ACE. WINS BRYANT MEMORIAL MEET

Horseshoe pitchers from Oregon, Washington and Idaho gathered at Laurelhurst Park in Portland for the sixth annual Bryant Memorial Tournament, Sunday, June 1st. It was the largest turnout ever for this event, as

thirty-seven men turned in qualifying scores.

John Monasmith of Yakima, Washington, the defending champion, picked up where he left off last fall and once again showed us how ringers should be thrown. In his game against Chapelle, he pitched ninety percent ringers. While percentages are not yet available, he averaged about seventy-seven or seventy-eight percent for the tournament. By winning this year, he made it his third win in six years and thus retired the beautiful Bryant Memorial Trophy.

Pitching conditions were excellent and scores good for so early in the season. Monasmith, the Washington and Northwest champion, lost to Getchell in a 112 shoe game. Bob West, the Oregon champion, was defeated by Chapelle. So West and Monasmith went into the last game with one defeat each. West pitched a good game but Monasmith nosed him out for the

championship.

Action was just as hot in Class B, where Hampton and Harvey came into the last game with identical records. In a seventy-five percent game, Hampton nosed out Harvey. Both of these men are former state champs and had to be content with playing in Class B this year.

#### OPEN HORSESHOE TOURNAMENT TO BE HELD AT MACON COUNTY FAIRGROUNDS. DECATUR. ILLINOIS

Frank Cotton of Decatur, Illinois will superintend a new Open Tournament to be held on the Macon County Fairgrounds courts, on Tuesday, July 29th, at Decatur, Illinois.

The qualifying round will begin at 8:00 A. M. and close promptly at 12:00 o'clock. Each entrant will have the privilege of pitching two series of 50 shoes each taking his highest total count as his qualifying score. There will be two classes, the top eight highest qualifiers will form Class A and the next eight will constitute the Class B division. Round robin style of play will begin at 1:00 P.M. and the cancellation method of scoring will be used.
