### Kuchcinski Winner At North Dakota Show

Danny Kuchcinski of Erie, Pa., won six of seven games to capture the second annual North Dakota Winter Show horseshoe tournament championship March 9, Valley City, North Dakota.

Danny's only loss came at the hands of the only other lefthander in Class A, Leigh Dunker of Warner, S. D., 52-31. Dunker finished third behind Frank Stinson of Minneapolis.

Both Dunker and Stinson posted 5-2 records, but the Minnesota champ notched a higher ringer percentage.

Andy Paglarini of Hibbing, Minn., was fourth followed by Harvey Peterson of Havana, N. D.

Kuchcinski, who won the 1967 World Tournament at Fargo, amazed a crowd of 3,500 spectators with his ringer accuracy. He pitched 70 per cent ringers for the day on a sand-clay mixture courts.

Gene Lykken of Kindred won Class B with a 7-1 record, dropping his final game to Lee Sharff of Jamestown. Wally Rislov of Cooperstown also was 7-1.

Henry Filzen of Minneapolis won Class C followed by Merlin Enderson of Aberdeen and Ed Thorstad of Buffalo, S. D. Stan Johnson of Ladner, S. D., won Class D followed by Helmer Jallen of Fargo and Erling Erickson of Moorhead.

### Greenville Ringer Classic — July 4-5-6-7, 1968

The annual Greenville Ringer Classic will be held at the City Park Courts in Greenville, Ohio, from July 4 thru July 7. The tournament will be sponsored by the Darke County Horseshoe Club and the City Park Commission and will be sanctioned and conducted by the Ohio Buckeye Association.

All entrants must be registered in by 11:30 a.m. on Saturday. The entry fee will be \$6.00 with those who qualify for Class A paying an additional \$5.00.

There will be a Ladies Tournament and a Junior Tournament on Thursday, July 4. All entrants for these tournaments must be registered by 1:00 p.m. on July 4. There will be an entry fee of \$4.00 for women but none for the juniors. No qualifications.

### Dan Kuchcinski's Winter Tour Report

#### By Will Gullickson

#### (En route with Dan Kuchcinski, 1967 World Horseshoe Champ)

The Kid with a world of poise and pride for the game of horseshoe pitching 18-year-old Dan Kuchcinski — appeared before more than 12,000 spectators on the first leg of his wide-spanning winter tour.

A model teen-ager with extremely excellent manners on and off horseshoe court, the 1967 World Tournament Champion from Erie, Pa., is raising the game's popularity by leaps and bounds.

The 12-day tour starting in Chicago Feb. 22 and winding up in St. Paul March 4 was a sparkling success as Danny thrilled his viewers with a dazzling display of trick shots along with incredible ringer accuracy.

A round of television, radio and press interviews gave Danny a whirlwind start in Chicago. In charge of the arrangements for the first exhibition were Ralph Dykes and Jack Stout, who put their shoulders to what turned out to be a super start. More than 200 packed the Garfield Park indoor courts to watch Danny perform. Stout presented Danny with an engraved and valued silver horseshoe, regulation size.

The horseshoe, beautifully inscribed for the occasion was fabricated thru the efforts of Jack Stout and his associates at Ace Metal Craft.

Thrilled with his first taste of the big city, Danny was interviewed by such famous sports columnists as Dave Condon of the Chicago Tribune and Bill Gleason of the Sun-Times. Gleason's column appeared two days before Danny's exhibition and gave wide acclaim to his feats as well as the sport.

Sig Sakowicz, well-known radio personality, interviewed Danny over WMAQ and later in the evening took the champ to dinner and a show.

Kuchcinski was also interviewed by Patty Parker, the Dodge Fever girl, over a Chicago television station. This took place on Jack Eigen's show, which spans over 35 states.

Danny was interviewed on two radio stations also, one which took place in Jimmy Wong's Restaurant. He pitched some ringers outside the studio for Wendell Smith's WGN television show.

Danny went by air to Fargo, N. D., returning to the scene of his 1967 World

Tournament accomplishment to be greeted by another flurry of engagements. During the Fargo-Moorhead stay, Danny appeared at six colleges, high schools and junior high schools, displaying his skill with trick shots.

The trick shots, which he developed while at Bradenton, Fla., earlier in the winter, keep the audience in constant suspense. They are climaxed by his

pitching a ringer while a person holds his chin on the stake. Other favorites are pitching ringers over a blanket and while a person straddles the stake.

Wayne Lubenow, popular columnist of The Forum, Fargo-Moorhead, placed his chin on the stake for the exhibition at Moorhead Central Junior High. He devoted his entire column to the experience and lauded the cool champ for his feats.

While appearing at Moorhead State College, Rick Stuyvesant, another Pennsylvanian, helped with the exhibition. At Dilworth a cheerleader placed her foot on the stake while wearing a short skirt, but the situation failed to hinder Danny's accuracy.

Kindred, long-time hotbed of horseshoe pitchers, welcomed Danny at the high school with more than 300 students cheering wildly following each ringer pitched.

Wally Rislov, former North Dakota state champ, arranged for Danny to pitch immediately following a basketball tournament game at Cooperstown. Rislov got into the act by placing his chin on the stake.

One girl at one of the exhibitions asked if Danny could pitch a ringer while not wearing his hat, which became a trademark of the champ at the tourney and on the tour. Danny promptly went out and fired a ringer.

Next came a 600-mile flight to Billings, Mont., where E. O. (Red) Roland, long-time horseshoe pitcher and booster, arranged for an exhibition at the YMCA. More than 300 turned out and Danny was his usual self while pitching ringers.

The Billings visit was one of the highlights of Kuchcinski's winter tour.

Arrival at Billings offered some anxious moments, however, as the Dixon portable courts had been forgotten in Fargo. They were shipped out on the next flight in time for the exhibition.

Herbert Shellenberger presented a beautiful red, white and blue jacket with the 1967 World Champ encircled in the front. Morris Wold and Don Rutt helped Roland with the arrangements at Billings. They arranged for interviews by press, radio and television.

Ira Jensen of the Montana State Ass'n., pitched in \$25 for the Billings appearance.

Next it was back to Fargo-Moorhead to prepare for the North Dakota Winter Show Tournament at Valley City.

Irv Koslofsky, winter show manager, invited Danny to pitch his exhibition the night before the tournament as well as the day of the tourney.

More than 5,000 watched Kuchcinski perform before the rodeo March 1. A turnout of 3,500 watched Danny capture the Class A title in the largest field of pitchers ever assembled for the event.

Kuchcinski's only loss came to another lefthander, Leigh Dunker of Warner, S. D., a 19-time state champ. Danny met many of the people who had watched him win the World Tournament.

Danny received a traveling trophy as well as a cash prize at Valley City. The trophy is donated by Allard Trophy Co., of Valley City.

The Red River Valley League of Fargo-Moorhead presented the champ with a leather notebook.

Kuchcinski's schedule the next two days provided a fast stepping and fitting windup.

He traveled to Hibbing, Minn., and appeared at the Moose Lodge before 70 people. A 30-point exhibition game was pitched against Andy Paglarini before the trick shot exhibition in which Harry Benson placed his chin on the stake.

the trick shot exhibition in which Harry Benson placed his chin on the stake. Among those at the Hibbing exhibition was Arnold Maki, former World Tournament player and a former trick shot artist. Also on hand were Leo LaBrosse and his three horseshoe pitching sons who have entered the World Tournament several times.

Kuchcinski and the writer went on to Duluth on March 4 where it was arranged to meet with officials of the Diamond Horseshoe Co., the largest manufacturers of horseshoes.

George Clarke, sales manager for the company, gave Danny a tour of the plant and the champ actually saw horseshoes made for the first time in his life. Diamond officials presented Danny with several gifts, including a silver horseshoe, tie tack, wrench and paperweight.

It was decided to have Danny give his exhibition in the company parking lot since the weather warmed to 40 degrees at noon. Danny pitched the Diamond shoes with excellent marksmanship during the exhibition which was watched by most of the company's 500 employees. Some of them watched from atop the company building, others lined the exhibition court and others watched from windows.

Hots Anderson of Duluth, a prime leader of the sport, helped Danny during the trick exhibition.

Among those impressed with Danny's performance was the company's president, John Sahlstrom. Diamond officials said they would participate in

the sponsoring of Danny during the upcoming tour schedule.

Danny went by air to St. Paul where John Yernberg arranged a big night at the Moose Lodge. Kuchcinski pitched exhibition games with Frank Stinson, Minnesota champ, and Joe Anzaldi of St. Paul.

The turnout at St. Paul was another capacity crowd which enjoyed Danny's performance right to the last ringer. Yernberg and Frank Schneider arranged for a television interview by Dan Allen of KSTP-TV.

Danny flew home to Erie, Pa., the next day, a happy young man who had thrilled thousands.

Meanwhile exhibition appearances are being scheduled from now until Sep-tember. Those interested are asked to write Will Gullickson, 1608 17th St. S., Moorhead, Minn.

## Clink! Clank! Danny Pitches Another Ringer

#### By BILL GLEASON

Clink! Clank! Clangg! That ringing sound which will echo across the hills, valleys and footpaths of Garfield Park Sunday afternoon will be caused by Danny Kuchcinski, the most popular ringer in modern sports.

Back home in Erie, Pa., 18-year-old Danny is highly regarded for his athletic versatility. During three seasons in high school baseball, this 140-pound, 5-9 wraith struck out only once, which won't come as any surprise to those of you who journey to Garfield Park at 2 p.m. to watch him do his thing.

When he's not playing baseball or basketball, Kuchcinski pitches horseshoes. He pitches so well he now reigns as the youngest horseshoe hurling champion in modern history.

If you've ever been around horseshoe courts, you tend to think of the competitors as old gaffers of 40 and upward, too old to do almost anything else except ruminate. That's why Danny is generating so much new interest in what has to be one of the world's oldest pastimes. He is young; he is good looking; and he is astonishingly skillful.

"This boy threw 84.4 per cent ringers to win the world championship at Fargo, N.D. last August," said Will Gullickson, assistant sports editor of the Forum of Fargo-Moorhead. "He won 34 of 35 matches and had a run of 32 straight victories before Elmer Hohl, a former champion, won a game from him.

"In addition to being the youngest champion in memory, Danny is one of the few great lefthanded pitchers."

Horseshoe pitching has been referred to disdainfully as "barnyard golf" but Gullickson, who is a topflight competitor himself, argues that throwing those ringers demands far more concentration and exerts much more pressure than golf does.

"Let's say that Danny is pitching against Curt Day, who was runnerup in the world tournament," Gullickson supposed. "Danny pitches two ringers and Curt comes right back to top him. That round then won't count. It's just wiped out. You can see why matches between great players can be marathons."

### **Danny Great: But I'm** Not **His Father** By Wayne Lubenow

All the young people at Moorhead's Central Junior High school screaming in great glee as I put my chin on the stake.

You could hear young voices shouting, "Yeah, cut him up." And than I started to think: Here I am at the junior high school and I am on my knees and I had my chin over an iron stake and some young 18-year-old from Pennsylvania was going to toss 2½ pounds of iron at me. How do I get into these things? I asked myself.

Never mind, keep the chin on the stake and hope that kid knows what he's doing.

The 2½ pounds of iron, a horseshoe, came flying through the air. I couldn't see it. I was on my knees with my chin on a metal stake.

There was a horrible clatter, metal meeting metal. The kid missed. I didn't move. Too petrified. The next shot was on target - a ringer.

And when it was over I decided to talk to that boy I put all my trust in.

He's Danny Kuchcinski, a lanky 18-year-old kid who is the world's champion horseshoe pitcher.

That is small consolation when he is aiming at your chin.

It is even smaller consolation when you have never met Danny before and you get conned into coming to the junior high school and Danny is going to do some trick shots that you don't know about.

Big crowd. Promoter Will Gullickson of The Forum stands in front of a microphone and tells everybody how Danny is going to pitch horseshoes over a blanket and make ringers.

They get two kids from the crowd to hold the blanket over the box and Danny proceeds to miss six horseshoes in a row.

He's a little excited because, apparently, he never missed that much before. Well, Danny had the two junior high kids move back about six inches and then tossed on two ringers over the blanket.

And then Gullickson got on the microphone and announced me and said I would straddle the box while Danny tossed on ringers from 40 feet away.

Danny tosses two ringers on and then they announce that I will put my chin on the horseshoe stake.

I was okay, no qualms, until Danny sauntered over and said, "Don't worry. I hit 85 per cent ringers."

That, I said, is outstanding - but what happens on the other 15 per cent

and how come you blew the bit with the blanket? Well, Dan said, I can usually tell when I throw a bad shoe and if I do, I will holler and it will give you enough time to get out of the way. So I kneel down and put my chin on the stake and the junior high school

crowd is screaming for blood and then I hear this clank and I look down and Dan has missed.

But he put the next one on and I didn't even see it and right away I figure Dan is the best horseshoe pitcher in the world because he didn't hurt me.

He is not only the world's champion horseshoe pitcher. He is as fine a lad as I ever hope to meet.

### Knisley Winner of Greenville "Snowball Open"

Jim Knisley, Bremen, Ohio, pitched a composite 81.8% ringers on his way to winning the third annual "Snowball Open" tournament, conducted by the Darke County Horseshoe Club of Greenville, Ohio. This year's tourney, held on the Club's three indoor courts, attracted a record field of 69 entrants and was held on three successive weekends.

Knisley won all 5 of his games to regain the title he won in 1966. Stan Manker, defending champion, won but one game but had over 40 points in each of his losses. Dick Carpenter of Union City, Indiana, threw the top game of 92.1% in defeating Berdine Scholl of Greenville by 55-4.


