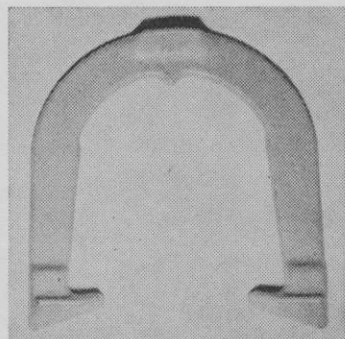

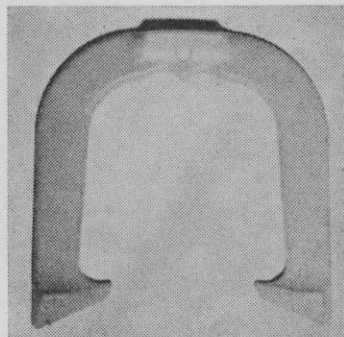

Mississippi Valley Fair Open Tourney — Davenport, Iowa

This tournament will be Sunday, August 3, and is open to all adult contestants. Mississippi Valley Fairgrounds, Davenport, Iowa.

Qualifying round to start at 9:00 A.M. and close at 12:00 P.M. Match play to start at 1:00 P.M. All participants are eligible to two qualifying rounds at a fee of \$2.00 for the first round and \$1.00 for the second, if desired.

All contestants must check in with the tournament clerk and will be assigned to a court and 45 minutes time for the qualifying round, including "warm up."

There will be five classes: A-B-C-D-E. Each class will consist of six men who will play a round robin to determine the winners of that class. Ribbons awarded, First thru Sixth places, all classes. Trophy awarded in each class.

All games shall be for 50 points a game, except class E which shall be 35.

Grounds keepers have been retained to keep the courts in top shape throughout the tournament. Due to the increase in participant interest over the past few years, this will speed up play and have the courts in equal condition for all competitors.

The 24 qualifiers for classes A-B-C-D are required to pay entry fee of \$1.00 each to participate in the finals.

All contestants not qualifying for the official matches will be eligible to participate in a consolation match, Class E, at no additional entry fee.

Premium checks for winners will be mailed promptly after the tournament if preferred.

Admission to the Fairgrounds is \$1.50 for all 12 and over. Children, accompanied by adult, free. Car parking is 50 cents.

A Salute to "Red" Roland of Montana

ERNOLF "RED" ROLAND, 618 Avenue D, Billings, Montana, 59102, operates his own business, Roland's Accounting service. He can handle any task in the field of accounting. If we said that Red could handle any task in any field we would not be far from the truth.

The background with which he opened his business included 20 years in the oil business including auditor, cashier, and other capacities with Mobil Producing Company, experience as accountant for 60 IGA Stores in Montana, executive director of the Montana Division of the American Cancer Society and Physical director of the Billings YMCA for four years.

In sports his accomplishments are legend. Red won the 1933 North Dakota State horseshoe pitching championship at the age of 15 replacing Art Engebretson; was an all-state high school choice as co-captain and star of the 1936 North Dakota basketball champs, Minot High School; owns titles in handball, bridge, checkers, golf, pocket billiards, bowling, tumbling, track, baseball, volley ball, and diving; played both basketball and baseball on a professional level; played basketball for Gonzaga University and was a second team all-america choice in 1940, and worked many years with Legion baseball in Billings which produced 14 state championship teams in a row and 12 professional players including Dave McNally.

Roland is 51, has a wife Clarice and a daughter Virginia, who is a graduate of the University of Colorado in medical technology and works at the Children's Hospital in Denver. Red does a great deal of public speaking, has done play by play broadcasting, and boosts horseshoes whenever he can. His honors and awards fill a room. The list of civic, fraternal and business organizations he has headed is long. No trophy marks this accomplishment but he is very proud that he married his high school sweetheart and that he and Clarice were both confirmed in the Zion Lutheran Church in Minot. But let's get back to horseshoe pitching.

Under not too good conditions Red averaged 43% ringers in the 1933 state tournament but later built his percentage to a best of 72%. He pitched exhibitions with the late Guy Zimmerman. Accepting cash awards in horseshoe pitching cost him his eligibility as a high school sophomore. Red served on the 1967 World Tournament Committee which hosted the Fargo tournament. While he pitched Red was a perfectionist, practicing two hours a day, hanging wire to nail down his height, and trying all sorts of things to better his game. When he won the state crown Roland was five feet two inches tall and weighed exactly 100 pounds. Consequently, he represented Dakota Maid Flour in North Dakota sports programs because his weight was exactly the same as a sack of flour.

Ernolf Roland came from high stepping Norwegian stock. His father, Syver Roland, was voted the outstanding individual dancer in Norway in his youth but I doubt that he made more steps than has Red. If I had the authority to order horseshoe people around, I would order Red Roland to get back into the game on an active basis or be stripped of everything including his citizenship. We need more people with his kind of spirit and dedication.

Another requirement of the fair association is that all players qualifying and playing in the top 24 MUST purchase an exhibitor's ticket for \$2.50. Cash prizes and trophies will be awarded.

There will be a 4 class tournament for second 24 men immediately following the semi-finals on Tuesday evening under lights. Trophies will be awarded.

The annual Illinois state Boy's championship will be held on Wednesday, August 13. Qualifying from 8 A.M. until noon. Top 8 qualifiers will play a round robin starting at 1:30. Trophies and fair premiums will be awarded. Entry fee will be \$1.00 each. No card required.

Third Annual Carson, N. D. Open — August 23-24

The Carson, North Dakota club will hold its third annual open tournament on Saturday and Sunday, August 23-24 in that city.

The lower classes will play on Saturday with classes A and B playing on Sunday. The club's 12 brand new courts complete with canopy and fencing will be the scene of this annual affair.

Alaska N.H.P.A. Chapter Organized

Seventeen charter members of the newly formed chapter in Fairbanks has brought the N.H.P.A. into Alaska and the far north for the first time.

Several years ago Paul Toole became the first Digest subscriber from Alaska and a year ago Harold Samuelson appealed to the NHPA for aid in setting up a horseshoe program in the city of Fairbanks. Printed "info", Manuals and the NHPA World Tourney film supplied by Secretary Bob Pence, helped the group get underway.

With the aid of the Park Dept. the first formal competition was held in May of 1969. Count all scoring was used and champions decided in four divisions in a program held in connection with an All America city sports activity day.

NHPA Representative Harold Samuelson won the "Professional" Class with 58.5 ringer percentage followed by Marvin Johnson with 56 percentage. "Semi professional" honors was captured by Bjarne Aune with 42 percent, Gordon Anderson placing 2nd. Amateur class title was won by Jack Townshend followed by Clarlain Seals. The Novice class honors were shared by Chuck Clutts, Bob Seals and George Loundsbury.

Now that an official charter has been received from the NHPA the group will elect officers in July and hold a tournament during the annual Golden Days celebration July 22 and another tourney will be held during the Alaska State Fair, August 14-17, Hez Ray, director of parks and recreation, is assisting the horseshoe club.

The NHPA wishes its newest chapter the very tops in horseshoe pleasure and success in the future. Digest readers will look forward to reading of future activities in our largest state. Fairbanks has only three frost free months — June, July and August — so the season will be short but interesting.

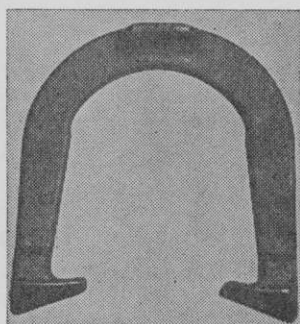

Film of Kuchcinski On Carson Show Now Available

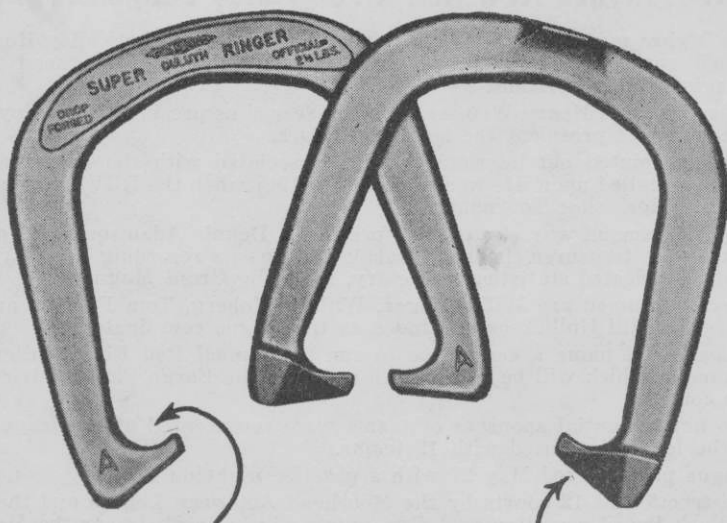
