



# 1969 World Tournament Information Saturday, July 26 Through Tuesday, August 5 Glenwood Park, Erie, Penna.

Entry Fees — The 1968 NHPA Convention raised the entry fees in the Men's Division to \$12.00 with the provision that all entrants who act as score-keepers for two or more other entrants will receive a refund of \$2.00.

Entry fees in the Women's, Senior and Intermediate Divisions will be \$5.00 each. There will be no entry fee for Junior Boys and Girls. NHPA membership cards will be required for all except the Junior Boys and Girls.

Successful qualifiers in the Men's Division will pay an additional fee of \$10 in the Championship 36 man Class A, \$5.00 in Class B and \$1.00 in Class C.

Qualifying Round — 200 shoes in the Men's Division, 100 shoes in the Women's, Senior and Intermediate Divisions and 50 shoes in the Junior Boys and Girls. Only one qualifying attempt will be allowed each entrant in all divisions.

Deadlines — The Men's Division deadline for entries will be 10 A.M., Wed. morning, July 30 and all qualifying shoes must be pitched by noon of that day. The deadline for qualifying and entries in all other divisions will be 10 P.M., Tuesday evening, July 29.

Men's Division — Will consist of a 36 man Championship Class A, 32 man Class B, 32 man Class C and 16 man Class D.

Senior Division — for players over 65 or who will reach their 65th birth-day anytime during the calendar year of 1969. There will be an eight man Class A, a six man Class B and in case of a heavy entry list a six man Class C.

Intermediate Division — for players between 60 and 65. Players who will reach their 60th birthday anytime during the calendar year of 1969 will be eligible. There will be an eight man Class A, six man Class B and six man Class C.

Special Note — Players may enter and pitch qualifying shoes in both the Men's Division and the Senior or Intermediate Divisions. But they can pitch in ONLY ONE of the round robin finals. The choice of which one will be theirs.

Women's Division — Will consist of Class A and B, eight players each and Class C and D, six players each.

Junior Boy's Division — for players who were under 17 at the start of the calendar year of 1969. Classes A and B eight players each, Classes C and D six players each.

Girl's Division — for players who were under 17 at the start of the calendar year of 1969. Classes A and B will consist of six players each.

# A Salute to the Great Jimmy Risk

It was the unheralded Risk, a lad in his 'teens who came out of Montpelier, Ind., and electrified the horseshoe pitching world in the 1927 world championships in St. Petersburg, Florida. He swept 25 straight games in the preliminary round robin and then finished second to Davis in the triple round robin finals, in which he beat Davis two out of three.

Although Risk never did win the world's championship tournament, he was a strong contender for several years and after Army service himself in World War II, he traveled more than half a million miles in that conflict and later in the Korean War entertaining our servicemen with his spectacular horseshoe pitching.

Risk once gave 80 horseshoe pitching exhibitions in 29 days for our servicemen, accompanied by his pretty wife, Norma. He made seven trips to Japan, six to Korea, four to the Philippines and 12 to Hawaii as a USO entertainer, delighting men in all branches of the armed forces with his horseshoe pitching prowess. He once performed within 2,000 yards of the battlefront trenches in Korea, ahead of the artillery. He also toured service bases in Europe and Africa.

He pitched ringers before cheering servicemen from the aisles of theaters, over the orchestra pits and onto stakes on the stages. And he pitched aboard Navy ships on the high seas.

Risk brought international publicity to horseshoe pitching when he pitched before then President Harry Truman and Admiral Nimitz on the White House lawn.

Risk has appeared in sports shows the length and breadth of the land, cofeatured with such athletic greats as Ted Williams, Sammy Snead and Jack Sharkey; he appeared with Roy Rogers, Chick Autry, Andy Devine and Smiley Burdette on rodeos; gave exhibitions of horseshoe pitching on the Art Baker and Mike Douglas TV shows and made horseshoe pitching movie shorts for Bill Stern and the late Grantland Rice.

From 1927 through 1933, when he finished third behind Ted Allen and Davis in the world tournament at Chicago, Risk was a consistent contender in horse-shoe pitching competition.

His service to his country, was both as a soldier and as a USO entertainer, pitching before servicemen on or near the war battlefronts.

Jimmy and his wife Norma own their own home in St. Petersburg, Florida, and have made this city their home for some 20 years. And Jimmy still never refuses a request to give benefit exhibitions, appearing often at the Bay Pines Hospital of the U.S. Veterans Administration here in St. Petersburg to entertain the disabled war veterans.

Dear Ellis:

I enjoy boosting, playing and thinking horseshoes as a hobby and recreation.

The satisfaction I get is immense.

As a relatively new-comer in the game, I am not aware of all the background and ideas originated by others. With this understanding, I am submitting the following article.

#### SCOREKEEPERS

Locating horseshoe scorekeepers is quite a task in some areas. One obvious way to easily solve this problem is to modify a standard round robin playing schedule.

When 6 players alternately play on 2 courts, 2 of the players are available for keeping score during the games. On this basis, the following 8 game schedule (6 Man Round Robin) offers a simple built-in scorekeeping feature or "Do-it-yourself KIT."

Dear Ellis:

Most of you know it takes a lot of time to get the names on the paddles, ready for the scoring devices. So this is what I have in mind. All it takes in a piece of plywood ¼ in. thick, 1% inches wide, and 18 inches long, painted white, put your last name on in black, in letters 1¼ or 1½ in. If you have a name which is common such as Smith, then put on letter of first name, so the score keeper will know who is who. Leave about 1½ in. from bottom to fit in scoring devices.

Then when you go to a tournament and sign in, give the paddle to the man or woman in charge and then when tournament is over, get your paddle and put it in your car with your shoes and you are ready for the next

tournament.

If your paddle doesn't fit your local score boards, then each state should have their members make what will work in scoring devices. This alone will save several persons a lot of time for other details.



Prime locations for tourneys are Valley City and Fargo, N.D., Middlesex, N.J., Greenville and Columbus, Ohio, Muncie, Ind., Erie, Pa., Salt Lake City, Utah; Duluth and Mineapolis-St. Paul, Minn., and Winston-Salem, N.C.

Matches will be pitched on portable courts unless other arrangements are made, making it possible to move the matches indoors in case of bad weather. The tour will not interfere with the National Horseshoe Pitchers Assn. World Tournament to be staged in Erie, Pa., in August.

It is hoped that prize money for each tourney will be upwards of \$2,500. Pitchers are in need of sponsors and anyone who is able to sponsor a pitcher is invited.

A committee is being formed to help conduct the tour. Pitchers responding to the tour feel it will be a big boom for the sport.

Coordinator of the tour is Will Gullickson, 1608 17th St. S., Moorhead, Minn., 56560.

Sue Gillespie, youngest women's World Horseshoe Tournament champion and a three-time winner, is joining Danny Kuchcinski for appearances during the coming year.

The attractive 20-year-old Miss Gillespie, a senior at Purdue University, will team with Kuchcinski in performing impossible pitching tricks on port-

able horseshoe courts.

Sue won the hearts of horseshoe tournament fans by claiming her first title as a 15-year-old in 1962, averaging 65 per cent ringers. She also won in 1964 and 1965, establishing an all-time record of 30 successive ringers and a 93 per cent single game mark.

Kuchcinski, who won the World men's title in 1967 at 18 to become the youngest champ, is the travelingest champ on record. He made a nation-wide tour in 1968, appearing on the Johnny Carson Tonight Show, the Minnesota State Fair plus other fairs and sports shows.

Both employ the regulation 21/2 pound horseshoes, Danny pitching 40 feet

and Sue 30 feet.

Series of tricks include pitching ringers over the blanket, with one or the other straddling the stake and placing a foot a top the stake. Kuchcinski also pitches ringers while Miss Gillespie lies only a foot from in front of the stake.

Sue, who has appeared on major network TV and other large audiences,

gives an acrobatic dancing routine as an added attraction.

## "Count All" Handicap System

The handicap system for "Count All" scoring is based on points pitched in a 50 shoe game with 100 points considered the "scratch" score.

Each player's individual handicap is figured on the difference between his

average points for 50 shoes and the "scratch" score of 100 points.

The "scratch" score can and should be set higher than 100 if there are players in the group who consistently score more than 100 points in 50 shoes. There are many mathematical variations of this system in use, but basically they are the same.

Some clubs use the full difference between the player's average and the "scratch" score of 100 as the handicap. Others use 3/4 or 75% of the difference. The most common variation in usage is 4/5 or 80% of the difference and this

is the one illustrated by the chart below.

Thus under this variation a player who has an average of 80 points for 50 shoes will receive a handicap of 16 points which is 4/5 or 80% of the difference between his average of 80 points and the "scratch" score of 100. Therefore if he pitches an actual score of 85 in a 50 shoe "Count All" game he will receive 101 points (85 plus his handicap of 16 points.)

For example, if the difference in ringer percentage between two players is 10% that figures to a difference of 30 points in 100 shoes. Since it is impractical to give the lower percentage player 30 points at one time because one does not know the eventual length of the game one tenth or three points of the handicap is applied every ten shoes or five frames. These three points are distributed one each in the first, third and fifth frames. This process continues each ten shoes as long as the game lasts.

Here is a chart on how to figure the number of handicap points for each ten shoes followed by a chart showing how to distribute those points in each ten

shoes of each game.

#### Chart for Figuring Handicap

#### Chart To Apply Handicap Each 5 Frames (10 shoes)

1 point handicap in each third frame.

2 point handicap — 1 point in 2nd and 4th frames. 3 point handicap — 1 point in 1st, 3rd and 5th frames. 4 point handicap — 1 point in the 1st, 2nd, 4th and 5th frames. 5 point handicap — 1 point in each frame.

#### Count-All — (Continued)

6 point handicap — 2 points in the 1st, 3rd and 5th frames.
7 point handicap — 2 points in 1st and 5th frames, 1 point in the 2nd, 3rd and 4th frames.

8 point handicap - 2 points in the 1st, 3rd and 5th frames, 1 point in the 2nd and 4th frames.

9 point handicap - 2 points in the 1st, 2nd, 4th and 5th frames, 1 point in the 3rd frame.

10 point handicap — 2 points in each frame.

In order for a player to receive his handicap in any given frame he must have one shoe within counting distance.

With this system a tie game is possible and in that case the game is extended to five additional points until the tie is broken.

Prior to tournament or league play scoresheets are made up in advance for each possible handicap situation with the handicap points being marked in the designated frames in red pencil. Then only the name of the players need be added to the proper scoresheet at the start of each game.

#### Michigan Institutes Its Own Hall of Fame

The Wolverine State Horseshoe Pitcher's Association now has established it's

own WSHPA State Hall of Fame committee.

Joe Latsko, Flint, Michigan, now deceased, was the first to be unanimously selected to the Hall of Fame. He died in July, 1966. He was Michigan's most illustrious horseshoe tosser, having won the State title 13 times during his 20 years of domination. Other players selected, included Carl Lundgren and Bob Hill. Both these fine men contributed in other areas besides just horseshoe

pitching, per se, such as promotional development of the sport.

Jonas Otto, Ann Arbor and Lee Jacobs, Belleville, practically neighbors and friends of long standing and now President and Vice President of the WSHPA respectively, were elected as non Pitcher's to the exalted body now reposing on this high pedestal of recognition and distinction. We, in Michigan are

tremendously proud of these fine gentlemen and competitors.

Competent and experienced leadership, a practical and workable constitution, extensive and enthusiastic participation, close national affiliation, we in Michigan conclude, is the formula for a bright future for horseshoe activity in Michigan.


