The Illinois state fair tournament will be held at the Illinois state fair-grounds at Springfield, Illinois on Tuesday and Wednesday, August 17 and 18. The Boy's tournament will get underway on Wednesday, August 18, starting at 8 a.m.

The 24 highest qualifiers will be divided into four groups of 6 men each. They will play a 5-game round robin on the first day. The top two from each group will make up the 8-man class to play for the State Fair trophy on the second day. Cash premiums will be awarded as in the past, together with the Governor's Trophy to the winners, including the Boys. THIS TOURNAMENT WILL NOT BE NHPA SANCTIONED.

All pitchers in the men's division will pitch 200 shoes for qualifying score, taking their best 100 shoe count. A registration fee of \$2.50 will be required for this event. Exhibitors (pitchers) have the option of paying the daily gate charges (admission and parking) or may purchase EXHIBITORS TICKET for \$5.00. Season Auto Stickers, \$5.00 tax included. There will be NO REFUNDS. The Boys' tournament will be governed by the same rules as the Men's tournament. The above is a rule of the Illinois State Fair Board.

Boys' tournament will play on Wednesday, August 18, beginning at 8 a.m. Each boy will pitch 50 shoes for qualifying score. Top 8 will play in the finals.

### Midwest Ringer Round-Up, July 17-18, Burr Oak, Mich.

The annual Midwest "Ringer Round-Up" will be held July 17-18 at Burr Oak, Michigan with divisions for Women, Junior Boys and Girls in addition to the Men's division. There will be both cash prizes and trophies in all classes.

Burlington, Ia., May 13, 1971

Dear Ellis: Just a line to let you know I made a trip to Statesville, North Carolina, and took part in their first Dogwood Open Horseshoe Tournament held there. I did all right as I won nine games while dropping six in Class A. It was cool on Saturday night, but the next day was perfect. I made the trip by bus, and as I had never been east of Ohio I enjoyed every bit of it. In my estimate it was next to the World Tournament.

There were 65 players from 17 states. Everything went off just fine — all the games were on time and it was well managed. I never met a finer group of people. Everywhere I went I was really treated swell. I averaged 63% in all 15 games which wasn't bad considering how cool it was on Saturday night. I qualified at 243 points and 73 ringers. In the first 50 I had 42 ringers, 134 points. I fell down in the last 50 as I got in the mud, or something.

But all in all it was a fine trip and I intend to go again next year if I am around. Ellis, you can print this in the Digest if you care to.





There were three locations suggested, they being Quincy, Galesburg and Peoria. After some discussion, a vote was taken and the Peoria site was selected. August 20-21 and 22 was chosen for the date.

It was to be up to the host club to raise the necessary prize money, but the State Association would conduct the tournament as has been the custom in the past years. The State Association would furnish all the trophies as before. The host club would handle the courts and see that scorekeepers were available.

Therefore, for the 1971 State Tournament the entry fee will be \$2.00 plus a State and National card. Each entrant should pitch 200 shoes on his own court, being witnessed by another State member. He should send in his two best 50's of the 200 to the State Secretary, F. Ellis Cobb, P. O. Box 1606, Aurora, Illinois 60507 together with the fee. This will be the official NHPA Sanctioned State Championship.

### **Specifications Of Official Horseshoes**

The official rules read as follows:

OFFICIAL SHOE: A shoe shall not exceed 7¼ inches in width, 7½ inches in length and weigh 2½ pounds with a two ounce tolerance to allow for any variations in the forging process. On a parallel line ¾ of an inch from a straight edge touching the open ends of a shoe the opening shall not exceed 3½ inches.

Players in sanctioned tournaments, especially the World Tournament, should

make sure the shoes they use conform to these rules.

Sometimes the forging process will produce a slight variation in weight due to the expansion of the dies, so shoes used in the tournament should be checked for weight before they are brought to the tournament.

In any case where the opening of 3½ inches is more than ¾ of an inch from a line connecting the extreme tips of the shoe, the player should grind or file enough off the tips to make the shoes conform with the specifications.

The tournament committee at the World Tournament will have both a set of scales and a gauge to check the shoes of any entrant whose shoes are protested.

Any protest or question of an opponent's shoes must be made prior to the

start of a game.


