## "LET'S GO TO STATESVILLE" By Bernard Herfurth

#### "Front Man for the 1979 W.T."

With the economy and possible gas rationing in the future, all members enjoying attending annual world meets are suggested to make plans to attend this year's meet. Who knows what the future holds?

All Statesville's committments are being fulfilled on schedule and everything points towards a most successful world meet.

At the 1978 convention, Ed Domey, owner of the 14 indoor court Heritage Recreation Center in Sutton, Massachusetts, suggested that we have a "front man" for the world meets, Bernard Herfurth, Chairman of the Hall of Fame, volunteered to serve for this year's meet and was elected.

The "front man's" job is to look after the best interests of the membership at a world meet concerning "off the court activities", "publicity", "motel accomodations," "eating places" and "places to go and things to do."

Herfurth will be accompanied to Statesville by Ed Domey. Together they plan to meet with Donnie Roberts and the Statesville's host committees headed by Jack Springer. They will ask for cooperation with their plans and also taking it on themselves to accomplish some of their plans.

PUBLICITY: Arrangements will be made to send "press releases" to the newspapers prior to the meet, made up of histories and pictures of prominent participants in the meet. Anyone wishing to help out with such material should write Bernard Herfurth, 17 Fort Street, Northampton, Massachusetts 01060 by June 15. A reporter will be asked to be on hand daily at the conclusion of daily events to give better newspaper coverage than we have been getting in the past. Concerning "mail in" requests for daily results by members unable to attend, a special effort will be made to get this coverage which has been poorly done in the past. The newspaper and costs should be in the June issue of the Digest. We are planning an attractive poster to be placed in motels, eating places and other places of business. It should have the schedule of "champion-ship matches" included. We hope for signs posted from all main arteries to Statesville with arrow directions to the courts. Plans will be made to contact all Television and local Radio stations with advertising material. All daily, weekly and shopping news, papers will be covered. If spectator crowds are small it won't be on account of lack of publicity. We run world meets to expose our sport to the public. This being a public service, meaning no charge, we should not be denied good publicity.

MOTEL ACCOMODATIONS: We hope to have a list of all presentable motels in the June issue of the "Digest" with update information on prices and "special rates" if any can be obtained. We will ask for special rates. Salesmen get them. We are all Salesmen trying to sell our sport to the public. I will check on "senior citizen's discounts" also. I will also offer information concerning the "American Association of Retired People" (A.A.R.P.). Some motels honor the A.A.R.P. cards. We bring thousands of dollars worth of business to a community during a world meet and we see no harm in trying to get "special rates" in return, especially during these times of excess inflation.

EATING PLACES: Visitors should not have to ask around where to find eating places. We hope to publish a list of the finest eating places down to the quick service sandwich spots. We will perhaps ask for a \$.99 breakfast special for the membership as an appreciation gesture. We will suggest that a local church or civic club put up a tent offering "home cooking" such is done in Greenville, Ohio. Some members would prefer staying at the courts, rather than hopping in the car to go get a meal. We don't want a measly little hot dog stand but a place to sit down and eat. We will push this item with the host committee.

PLACES TO GO AND THINGS TO DO: We were prevented from putting up a poster telling of places to go and things to do in Des Moines. The reson being that we would be infringing on the "Hospitality Man". The result being just about nothing happened to offer any activity away from the courts. Some of our members would like a little diversion from being at the courts 12 hours a day. For many it is their summer vacatin and would enjoy seeing points of interest at the world meet site. We hope to have a complete list of such places within a radius of 50 miles of Statesville with directions and price of admission.

We will also look into the possibility of getting 1979 "World Meet Buttons." People often collect buttons as souvenirs.

We plan to suggest a "Smorgasbord" rather than a catered dinner at the annual party.

We will also ask for a "Red Cross Volunteer Service" with an ambulance service.

With chances of plenty of good hot sunny weather in Carolina, perhaps it would be a good idea to bring some type of umbrella for protection.

We hope to talk over these items with the host committees and get cooperation for the best interests of our membership which makes the Annual World Meet possible. To get the spectators to circulate, and also to get them closer to the action, vestibules 18 feet wide separate the 12 courts into three groups of four. Colorful benches provide seating in the vestibules. Fences have 10 feet wings on each end.

## **BOB GRAHAM CANDIDATE FOR N.H.P.A. PRESIDENT**

Bob Graham, Veteran Pitcher from Houston, Texas, has announced his candidacy for the post of N.H.P.A. President. Graham has been a member of the N.H.P.A. since 1963 and has held a host of responsibilities including president, secretary, and editor in the Texas association. He also served as chairman of the regional directors and is a member of the Texas Hall of Fame. Bob graduated from Texas A & M University, is married, a U.S. Navy Veteran, and has followed a career in personnel and industrial relations.

Bob admitted that if elected, the job won't be easy. "It is an awesome responsibility, not only in the administrative work and detail required, but the president, together with the elected officers will be called upon to help shape policies and ideas that could affect the ultimate direction of the sport." "We have made some progress, but basically have fallen short in capturing the imagination of the news media, and the tremendous number of people who should be pitching horseshoes on an organized basis." "One of our primary goals should be to evaluate the sport from a back yard concept to a place where it is organized and played on the level of golf, tennis and bowling.

When you have great numbers of people who pitch and will pay to attend tournaments, the news media will provide comprehensive coverage." "No sport or game has achieved much without broad spectator interest and support."

Graham maintains that the present youth and sanctioned league programs are definitely steps in the right direction. "Horseshoes may be at the crossroads in its development; the direction we take now and the dedicatin we put forth will largely determine the amount of spectator interest generated later; I'm confident we will meet the challenge."

"If elected, I pledge to seek out ways to improve the integrity and image of horseshoes. I make no campaign promises to anyone than to do my best, work hard for horseshoes, and keep an open mind to new ideas. I solicit your ideas, encourage and support, and look forward to Statesville."

## THREE PLAYOFFS FEATURE MID-FLORIDA OPEN MARCH 17

Tightly matched contestants produced pitchoffs in thre of the five classes run off at Orlando's Mid-Florida Open March 17.

"Pete" Peterson, the Orlando club's president and Tournament Director had to hit a new personal high of 58.7% to beat our Paul Scheub of Sarasota and Walter Deuster of Hampton Bay, New York, in Class A, all three with a 6-1 record for the 7-game class.

At the other end of the totem pole, Joe Berrall, Orlando Club Secretary, was also forced into overtime to break a 3-way tie and take first place in Class E against Skip Demaree of Clermont and Clyde Falk of Pennsylvania.

In the third pitch-off (Class B) Ken Reeb, FHPA Prexy this year was nosed out by his buddy from Winter Haven, Joe Steimer. Unrated dark horse from Ohio, Dale Buckingham, tore up Class C with a 7-game 55.7% ringer average better than any in Class B.

Vito Filiccia of New York passed away very suddenly from a heart attack, March 29. He was one of the great horseshoe pitchers in the state of New York. Starting to pitch in 1928, Vito's "heydey" was largely during the 1930's and 40's. His fame spread all over the East as he won between 100 and 125 tournaments. His long swing, with a looping 1-3/4 turn was a familiar sight everywhere.

In 1936 Vito became the official State Champion with the highest ringer percentage ever thrown for this title, 75.2%. Vito consistently threw between 70 and 75% ringers. In 1949 he again won the State Title, 73.8%.

Vito entered all the big open tournaments in Jersey, Penn., Conn., and the Eastern Open, nearly always taking first or second place. At all times he was a real sportsman, with a ready smile and an encouraging word.

In his early days Vito played with the Ft. George Club of New York City and the DeKalb Club of Brooklyn. He also played in the Knickerbocker League of New York which presided over by the legendary Tom O'Gara. Vito remained an active pitcher up to 1968, when he pitched in the Westchester Master's Invitational.

To his loving wife, to whom he was married for 36 years, the sincere sympathy of the New York Association and that of the National Association is extended in this sad hour of bereavement.



## **REGIONAL DIRECTOR'S REPORT**

## Delaware, Maryland & New Jersey

**DELAWARE** — Once again I am more than happy to report that our sport has not stopped growing in this area. Willard Sammons, Ass't RD and State Secretary has indicated that Delaware is coming on stronger than ever with the addition of six new courts in Lewes, Delaware and with more players joining the NHPA. Willard, as usual, has done a good job, excellent in fact, by taking a State that just two short years ago was dormant in horseshoes and only because they had a late start last year, decided not to have a State Championship; however, they plan to have one in 1979. That, my friends, is called coming back a long way!

MARYLAND — As always, with her tournaments running from May to September, singles and doubles, Maryland is doing well. They had a total of 49 singles (men, women and juniors) and 17 pair of doubles in the A and B Classes for their 1978 State Championship. They have also increased their membership in the NHPA.

Some of our players from New Jersey entered some of their tournaments, trying to hold their own against those intrepid residents of the Old Line State. Maryland has a concession stand which sells game related items at their tournaments, which reportedly made money for their Club; they also have an on-site trailer that doubles as an office and storage area for their supplies. It seems that horseshoes are a 'way of life' in Maryland with Parker Sturgis of Fruitland, President and Secretary, leading the way.

**NEW JERSEY** — This is the only bit of unhappy news relating to horseshoes I have to report; for the first time in the history of our State Association we have had to suspend a member. This resulted form events which started at our State Championship tournament and culminated in a legal suit filed against the NJSHPA and which, subsequently, was won by our Association. I find a remark made by Phil Zozzaro, our President, very apropos, "Our players belong on the courts." Walter Pruiksma's suspension for one year was because of his unsportsmanlike conduct, harassment of officers and conduct unbecoming a member.

As our '79 season approaches we have invited all the State Clubs and Leagues to participate in our tournament schedule, which has been expanded to enable all Clubs to participate and to run their own tournaments entirely. We also plan on having more open tournaments to accommodate all the out-of-state pitchers who may wish to participate. Al Ward, our Tournament Director, has undertaken the job of putting this all together. We have a total of seven active Clubs this year and the potential for more is increasing.

Our Northwest H.P.A. and the Northwest Jersey Independent League have an ever-increasing membership all due, in the main, to Al Ward. Al was responsible for initiating those entities and with the help of Paul Stille, Don Ferrer and many others who love the game, have made horseshoes a sport in this area. In just two and a half years, from no organized horseshoe players to over 100 all serves to point out that with the proper ingredients (right locale and dedicated people) an awful lot can be accomplished.

We have initiated a system whereby instead of having our regularly scheduled meetings in one location, we are asking each Club to be the host for the month designated so that we will have a better cross-section of members attending and voting on any and all matters. We're hoping this will be a shot in the arm for our Association and give each member a sense of participation, particularly for those who previously have found it difficult to attend meetings many miles away.

For the first time this past year, our State Tournament was held at the Flemington Agricultural Fair, Flemington, August 29 through September 4. The Middlesex HPC initiated the request which led to the Flemington Fair Association installing horseshoe courts in the Fair grounds. The first several Invitational Tournaments, held only during Labor Day Week, were run by Middlesex HPC. Thereafter, the Hunterdon County-HPC began cohosting this annual week-long affair during the last four or five years, until our State Singles last year. During this Labor Day Week, over 100,000 tickets were sold, making this one of the largest exposures to horseshoes (excluding TV coverage) that I am aware of.

Through the initial efforts of Marty Hoffman, Treasurer of the Hunterdon Club, we were made aware of the tremendous possibilities at the Fair. Marty's wife, Blanche, is the Secretary and Manager of the Fair, where Marty worked 17 hours every day during Labor Day Week, assisting greatly in the day-to-day operations of the Fair, along with handling most of the financial aspects with his wife. This is a great team to have on your side and the NJSHPA and Hunterdon County Club are proud of them and gives them a 'tip of the Halo Hat'. Blanche has invited our Association back again for 1979, for which we are grateful.

Thanks to the Flemington Fair and Hunterdon Club for co-hosting this event with special thanks to Clarence Moss, President; Donn Grady, Secretary; Larry Cimirro, VP; Bill MacIntyre, Tournament Director; Al Cherry, Jim Burd, Hal Hanania, Jim Reed, Phil Zozzaro, plus all of the Hunterdon and State members who helped to run this seven day affar.
