


Dear Mr. Shipley:

During the past several months I have been in communications with several members of your organization concerning what has come to be known as the Togo horseshoe pitching project. My contacts have been with Bernard Herfurth, your Publicity Director, Lee Davis, your Florida Regional Director and Oscar Gaudette of New Smyrna Beach, FL.

The project background revolves around the desire of the horseshoe pitchers of the French West African country of Togo to establish contact with some American horseshoe pitchers and to get information on acquiring additional sets of shoes so that the game can be expanded in Togo. Briefly, I served as U.S. Ambassador to Niger in Africa in the late 1960s, and brought with me two sets of horseshoes to use for recreational purposes. I taught several Africans the game. One of them Afantsao Agoudavi (Andre) worked for me in the embassy residence. When I left Niger I gave the shoes to Andre. He returned to his native country, Togo, in the late 1970s. He carried the two pairs of shoes with him and inaugurated the game in Lome, the capital of Togo. In 1979 I donated six pairs of shoes to Togo. With this additional equipment they established a league. The inauguration of the league was covered by Togo television, radio and newspapers. More Togolese want to play the game and the Ministry of Sports in Togo has given its support to this undertaking.

Your representatives informed Mr. Henry St. Pierre, President of the St. Pierre Manufacturing Company of the Togo horseshoe pitching activities. As a result of discussions between Mr. Herfurth and Mr. St. Pierre, the St. Pierre Manufacturing Company has generously offered to donate twelve pairs of horseshoes to the Togo Horseshoe pitchers. I have been in contact with the U.S. Ambassador in Togo, and she has agreed that the embassy will participate in the official presentation of this gift to the government of Togo from the St. Pierre Manufacturing

Company and the National Horseshoe Pitchers of America.

Those of us who have been involved in this project are most grateful to the St. Pierre Manufacturing Company and to your organization for this much appreciated gesture in international understanding. We especially appreciate the interest and support which we received from Messrs. Herfurth, Davis and Gaudette.

## GEORGE NICK OF MINNESOTA ANNOUNCES HIS CANDIDACY FOR 1ST V.P.

You can say that I have literally been involved with horseshoe all my life (a half century). My father was a blacksmith and farrier and needless to say, horseshoe pitching was not foreign to our family.

It wasn't until 1969, that I became active in the organized sport of horseshoe pitching. Since then I have been involved in the Wayzata League, Minneapolis League, St. Paul League (indoor and Ramsey County) and the Bloomington League. I have served as League Secretary, 1st Vice-President, and President along with being on the Constitution and By-Laws Committee of the Minneapolis League, Bloomington League, MGSHPA and the NHPA.

I have served as a delegate of the Minnesota Gopher State Horseshoe Pitcher's Association of the NHPA conventions held in Keene, NH in 1974; Lafayette, Ind. in 1975; Briston Twp., Pa., in 1976; Greenville, OH. in 1977; Des Moines, Ia. in 1978; Statesville, NC in 1979 and Huntsville, Ala. in 1980.

In 1979, I was selected as Chairman of the 1981 World Horseshoe Tournament Committee. We have been very busy ever since, anticipating the largest WHT turnout in history. Having planned a variety of activities, we are certain this year's event will be a success, especially by having the PREIMESBERGER ARENA available with excellent blue clay, no worries about inclement weather, the new qualifying process and the expanded Championship Classes.

Many valid ideas to improve our sport have been presented by our membership; unfortunately, most of them fell on deaf ears. If elected, and with your support, I will do my utmost to improve and promote the sport of horseshoe pitching.

## Publication Report on WHO'S WHO IN HORSESHOE PITCHING

Ottie W. Reno submits this report on his new book WHO'S WHO IN HORSESHOE PITCHING: "Over 2000 people have been included in one huge volume which has taken over a year to complete. The book consists of a picture and biographical sketch of each one and they appear in alphabetical order.

"Sending a notice to each of 2000 people costs about \$500 per mailing so it is hoped that this notice will save at least one mailing. I will try to answer the questions which biographees will likely have.

"The book has been finished by me. The manuscript has been delivered to the publisher. The only thing which I can do or those people who are waiting for a copy of the book is to wait as patiently as possible for the book to be released. As soon as that date is learned you will be notified.

"Golden Cockerel (Canada) Ltd., a subsidiary of A. S. Barnes & Co. of Cranbury, New Jersey, is the publisher. They are a very good and reputable company.

"The book will cost \$25.00 per copy when released. During the pre-publication period a prepublication price of \$18.75 was offered and many people took advantage of the discount. This money was deposited in a special account and has been paid to the publisher. The prepaid copies will be the first copies to be mailed out.

"The unedited manuscript delivered to the publisher contained 3,300 pages and over 2,000 pictures. It is estimated that the book when published will contain 700 to 800 pages. It is the largest collection of material on the sport ever assembled.

#### STEINFELDT EASY WINNER OF FLORIDA POW WOW OPEN

Seminole, Florida Horseshoe Club, Pinellas County's oldest club sponsored the Seminole Pow Wow in conjunction with the Pow Wow Festival.

Two days of delightful weather graced the 63 individuals from many states and Canada who had arrived in Seminole for this gala event. For 15 hours the ring of iron could be heard as horseshoe peppered the 14 inch high by 1 inch diameter stakes. Considered an average tournament by size one must consider the following: A total of 20,352 shoes weighing 50,880 pounds (254.4 tons) were pitched 407,040 feet (approximately 78 miles). There were 8,274 ringers for a tournament average of 40 percent and each man walking distance of 1.22 miles.

The overall tournament champion was Carl Steinfeldt of Clearwater, a past World Champ and two time Pow Wow Camp. Carl left little doubt from the start as to who would be the winner by pitching a blistering 81.5 ringer percent, the highest ever pitched in a Seminole tournament.

Seminole's Mayor Jaunita Gesling and Concil President (1981 Mr. Seminole) William Cheetham were present to welcome all the pitchers pryor to tournament play. The Mayor's Plaque will be engraved with Carl Steinfeldt's name and returned to the Mayors Office until next year's tournament.

In tournament play Class B ended in a tie between Omer Blacketer, Ky and Ed Resley, NY. Winning the playoff game was Ed Risley. Class C was won by Ralph Rose, NY. Royce Wruck, Wis., had little trouble mastering Class D winning all five games. Class E was won by local terror Seminole's Ray Arthur who had to win a hectic playoff game with Clearwater's George Buskey. Bill Rowse of Clearwater won his last five games to tke top honors in Class F. While Everette Shippee, RI ran rough shod over all opponents in Class G. Henry Hostetler had a perfect record in winning all seven games in Class H. Class I required a playoff between Tom Keltner, Clearwater and Roger Sutor, Tampa before Sutor could emerge victor.



#### 1980 SANCTIONED LEAGUE NATIONAL AWARDS

By Russell Gadoury, League Coordinator

Among my more pleasant duties as NHPA League Coordinator is the announcing of those sanctioned league pitchers who stood alone, who finished NUMBER ONE, among their fellow pitchers. I compiled records in three categories: High Game, High Average, and High Game Over Average. The first two are self-explanatory. For the High Game Over Average award I look at each pitcher's high game and compare it with his or her season average. The pitcher with the greatest difference, such as +34.4% is the pitcher with highest game over average. I have a fourth category, the Sportsmanship award, that I will announce separately.

This year we are making ringer percentage awards for men, for women, and for juniors. All pitchers got tossed into the same pot for 50 shoe countall scores. Some leagues pitch games less than 50 shoes long, the Under 50 Shoe category. The leaders in that section were also compiled.

#### The Champions

**High Game** — OPAL RENO and MIKE COCHRAN shared high game honors in both percentage and countall among the women and men. Both pitchers hit high games of 94%. While pitching 47 ringers out of 50 shoes they were also scoring two single points and missing one shoe, for countall scores of 143. In a separate 50 point scratch league MIKE also pitched a 95% game, on 19 for 20.

Young DONNIE B. ROBERTS pitched a beautiful 80% game, tops among the juniors. In third place, and tops among the girls, was LORNA RENO with a 64% game. These were 50 shoe games. In a 20 shoe doubles league BRENDA McNEILL pitched a 70% game.

**High Average** — Not too surprisingly, the same pitchers who pitched the highest games also carried the highest averages. OPAL RENO averged 82.3% ringers and 127.2 countall points. MIKE COCHRAN averaged 80.8% and 127.5 points. DONNIE B. ROBERTS averaged 56.7% among the boys and LORNA RENO averaged 42.2% among the girls.

High Game Over Average — Little did Jim Woodson suspect, as he was composing his "apology" regarding some remarks (March 1981 Digest) he had made when the NHPA's Sanctioned League Program was just emerging from the conception to the implementation stage (thanks for the program plug, Jim), that several of those same Lakeside Club pitchers would figure prominently in the national awards, and that one, JOHN OLIVE, would head the High Game Over Average list in two categories, percentage and countall.

But that is what JOHN OLIVE did. JOHN carried an average of 7.5%, but in one memorable game pitched a big 40%, or +32.5%. At the same time, he was piling up those close shoes and finished with 72 points, +48.2 points over his 23.8 average. In the Under 50 Shoe section ART GRAVES was head and shoulders above the crowd. ART pitched a 70% game over an 18.4% average for +51.6%.

JENNY RENO, at +34.4% (70% over 35.6% average) was the clearcut 50 shoe woman. Just slightly ahead in the Under 50 Shoe was CHERYL STONE at  $+35.7 \circ$  (70.8  $\circ$  game over 35.1  $\circ$  average).

MIKE ARMITAGE was top star among the juniors, at +26.7% with a 50 shoe game of 58% over a 31.3% average. In a 20 shoe game BRENDA McNEILL pitched a 70% game over her final average of 32.7%, for +37.3%.

My congratulations to everyone. Again, my thanks to all league directors for providing me with the verifications necessary to insure fairness and accuracy of the standings.

#### MARY VAN SANT WINS "C" HANDICAP-SO. CALIF. ASSOC.


