NHPA PRESIDENT'S MESSAGE

The Chief Charley's V.S. Invitational Horseshoe Tournament held in Clearwater, Florida on March 27, 28 and 29th was as FANTASTIC SHOW as the Los Angeles Invitational.

Congratulations to the winners Mark Seibold and Opal Reno.

Mark Seibold and Walter Ray Williams game went into overtime (4 extra shoes). Mark won 45-44.

In the men's two days of round robin (14 games), Williams averaged 91.1.

After my observations, I am even more convinced that 50 point games are too long. Even the players, members and general public gave favorable comments on the method of play.

The method and scoring was 50 shoes each player and count all ringers only. Each ringer counted 1 point. If a tie at 50 shoes (and there were several), each player pitched a group of four additional shoes until there was a winner. The winner of each game was awarded a bonus of 3 points. The total points were accumulated to determine the ladder position for the finals. Positions 7 and 8 were eliminated from further competition. Player 6 played player 5; winner then played position 4, etc. A single game was played for the championship.

The Clearwater Club incorporated other changes for this tournament.

- 1. Players alternted
- Foul line commenced at base of stake (a line was drawn). Both feet had to be behind the foul line before lat step forward was taken in the delivery of the shoe.
- Dress code was required. White pants, shirts or slacks and blouse with the NHPA insignia on the front and names on the back.

I liked the foul line rule. It takes away all doubt on whether a person fouls. The alternate pitch has merit. It didn't seem to bother the players and helps make the game more even. Each player has an equal amount of 1st pitches.

It was really nice seeing 16 players so nicely dressed. It improved our sports image. I wish more players would consider improving their dress at our World Tournaments as well as all tournaments.

They had very good coverage from four television stations. Newspapers even gave them coverage on front page of the sport section in living color.

Mayor and other city officials attended open ceremonies. During this time I had the honor in presenting to the "Nunamaker" family Blair Nunamaker's NHPA Hall of Fame Plaque. Blair was inducted in 1970 but the NHPA was unsuccessful in locating the family until now.

Thanks and congratulations to the Clearwater Club for their hard work and efforts in putting together a most enjoyable tournament.

A "Special Super Thanks" to the chairman, Norm Gaseau, for his outstanding leadership and contribution in improving the game and image of horseshoes.

Five of the seven NHPA Executive Council were present. We had a productive meeting. Claude and Earl were the two absences. All of our expenses were out of our own pockets.

I had a "Brain Storm" that will shorten the 1981 and future World Tournament conventions. It's been approved by the council.


WORLD TOURNAMENT INFORMATION By Donnie Roberts

At Huntsville last August 150 horseshoe pitchers just like yourself voted almost unanimously not to have qualifying at the 1981 World Horseshoe Tournament. This was a clear mandate that you pitchers were tired of qualifying. So, the 1981 tournament does not call for qualifying. All you have to do is turn in your average and entry fee to me by June 1. An entry blank can be found in this issue. Also, all state secretaries and regional directors have entry blanks.

Every baseball player knows his batting average, every bowler knows his average, every golfer knows his handicap, every basketball player knows his shooting percentage, and 1'm sure that all of you know your ringer percentage. I want you to turn in accurate figures because I already know most of them and all will be varified by your own state officers.

About June 25 I will mail a complete schedule of pitching times to every entrant so that you can plan your travel accordingly. So that you can make tentative plans how groups will pitch is as follows: Women, Juniors, Seniors, and Intermediates will complete all competition on July 30 through August 3 and entrants in the mens top class will complete August 3 through August 9. Classes B, C, D, and E of the men will compete August 3 through August 9. Classes of men below E will play at times throughout the tournament so unless you plan to be present for the entire event you should wait until you receive the schedule before you make reservations or travel plans.

Entries have really been coming in so this should be a fantastic event. As you know in the past we have always had Class A players in Class B in all groups. This year we shall avoid this. The Class A men's class shall be expanded to 96 pitchers. They will be evenly divided into 8 groups of 12 and will play 11 games. The first and second place winners in each group will advance to the final round robin for the world title. This gives us 16 finalists. The other eight finalists will be the top eight ringer percentages that did not finish first or second. Just like the wild card spots in football. Using this method we will have the top 24 competing in a round robin for the title.

HORSESHOES FOR TOGO, AFRICA

Readers may update the "Horseshoes for Togo Project" by reading the article on pages 36 and 37 in the March Digest.

Robert J. Ryan, former ambassador to Niger, Africa and retired Assistant Secretary General to the United Nations contacted NHPA Publicity director Bernard Herfurth in regards to establishing a contact between the NHPA and the Togolese Horseshoe Pitchers. Mr. Ryan suggested that perhaps sending a set of professional horseshoes would be a friendly gesture by the NHPA. He had previously donated six pairs of Sears-Roebuck shoes.

NHPA Publicity took the suggestion. Herfurth made calls to President Henry St. Pierre and Peter Shepard, Manager of St. Pierre Mfg. Co. Peter is also New England Regional Director. They are the makers of the "American Shoe." Both were pleased with the cordial correspondence from Mr. Ryan. As a result St. Pierre has sent twelve (12) pairs of American Shoes to the Togo Government in behalf of horseshoe company and the NHPA as a gesture of Good will.

The shoes were to be shipped the week of April 6th, to the Lady Ambassador, Marilyn F. Johnson, and Irwin Hicks, who has been given the title of "Horseshoe Attache" by the Ambassador. The embassy is in Lome, Togo.

The Ambassador is planning a special ceremony with the presentation of the shoes by the embassy in behalf of this country. Togo the "minister of youth" in Togo is interested in our sport that only recently has been introduced. Lome TV — radio — and newspapers have previously given coverage to the six team horseshoe leagues.

In slightly over a year six teams have been organized, with the players wearing uniforms with the colors of Togo. They were taught the sport by Andre, who formerly worked in the Niger Embassy residence for Mr. Ryan. He has done an excellent job.

The Togolese players desire contact with the NHPA membership. The membership is asked to write to (Andre) whose adress is Mr. Agoudavi Afantsao; B.P. 541, Lome, Africa. Although French is the Togo Languae, Andre understands and speaks english. Write a "friend of horseshoes" letter giving andre news of the sport in your part of the country.

From Mr. Ryan's experience in government positions, he is convinced that more organizations, such as ours, should make contact with other countries, sending out "grass-rots" good will, such as our project "Horseshoes For Togo".

Togo, is an island off to the West Coast of Africa with a population of around 2,500,000.

NHPA ELECTION FOR 1981

Three NHPA officers are running for re-election. As of this date, they are running unopposed. This is not a healthy situation.

There are many members who would make excellent officers. They will not run for office because the know that it's almost impossible to become elected especially if the candidate is from either coast. No new officers have been elected running against an officer seeking election since Wally became president in 1973 and Donnie Roberts in 1976. Both were elected under unusual circumstances.

Wally Shipley ran for president in 1973 in Eureka, Calif. The NJ delegates campaigned for Wally. We were able to convince many delegates to vote for him. At the convention the voting for president ended in a tie. On the second ballot I was able to convince the Nevada delegate who was sitting at our table to vote for Wally (he didn't vote on the first ballot).

At Bristol, PA, in 1976 Wally told me he would step down as president if Donnie wasn't elected. The NJ delegation had decided to vote against Donnie. We changed our vote to support Donnie. It was enough to swing the election.

Under our present voting rules it's almost impossible for a candidate, especially one from either coast, to become elected. The charters from the coast states rarely have their quota of delegates present at the convention.

At Statesville, Iowa was entitled to eleven delegates. They only had three present. AT Huntsville in 1982 Minnesota will probably be entitled to 15 or more delegates. They probably won't have half that many present.

One way of getting full representation for each charger is by having the proxy vote.

In 1972 at Middlesex the proxy vote was defeated in spite of the fact that it reeived 66% of the votes.

Decreasing the number of delegates would also help to equalize things.

SEIBOLD OVER WILLIAMS TO WIN CLEARWATER, FLORIDA

U.S. INVITATIONAL - RENO OVER WINSTON IN LADIES

In a head to head final match, Mark Seibold emerged champion of Chief Charley's Men's US Invitational while Opal Reno slid past Vicki Winston with a 42-35 score to take the Ladies Title. Walter Ray Williams, Jr., excited the audience with three 96% games along with Elmher Hohl and Mark Seibold who each had 96% games. On the ladies side, Opal Reno reached the 90% plateau once with a 94% game. In the final men's game Walter Ray and Mark tied at 50

shoes with 41 ringers each. Walter Ray missed one of the next 4 shoes while Mark put all four on to win the title.

Staged at Clearwater, Florida, March 27-29, 1981, the game plan for the tournament created spectator interest that kept bleacher seats filled at all times while four local TV Broadcasting Stations and Cable TV provided coverage. Advance media coverage generated an audience mixture of players and non-players.

The game plan: 50 shoe games - ringers only counting 1 point. Winner of each game awarded 3 point bonus. In case of a time game, each player pitched 4 additional shoes to determine the winner; repeating 4-shoe play if necessary to break the tie. On fist day ladies played one 8-player round robin with 2 bottom players dropping out. Ladies final 6-player ladder playoff on second day. Men played 8-man round robin on first day and second day with 2 bottom players dropping out at conclusion of play. Six man final ladder playoff occured on the third day.

We were pleased to have President Wally Shipley and lovely wife Sally in town for the event as well as Sec/Treas. Donnie Roberts and wife Helen who was one of the contestants. We are grateful to Wally for his assistance in handling the PA work at the courts.



You can use the following "guide-line letter" but do not duplicate the sample letter, use your own words in your request.

Dear Postmaster General:

Congratulations on your appointment to the responsible post you now occupy.

In these trying times, our country seems in need of something to ease its tensions, something to encourage peace of mind and good old-fashioned neighborliness.

We, in Horseshoe Pitching, feel we have at least, a partial answer. With your help, Americans of all ages can be made aware of the game. May I ask, how many other sports boast a Men's, Women's and Junior's National Champion and can still be played in one's own backyard? Few, indeed.

Evidently, our forefathers felt the art of Horseshoe Pitching had much to offer because it is a matter of record that our early pioneers did indeed, play the game. Not in the improved manner in which it is done today of couse, but play it they did. Many of the reasons the sport was popular then, still hold true today. It was enjoyed primarily because it was economical, easy to understand and play, while still offering an opportunity for friendly competition.

The tournament, however, pays for clerical help and judges, besides giving prize money. Individual pitchers pay scorekeepers 25¢ a game.

Ralph hails from Connecticut. He is a regular pitcher in the local Apache Trail league, and, with a smile and a gesture, said, "I have fun, but don't set the world on fire with my pitching."

"There is no competition for my job," he mentioned with reserved pride, but it can be expected that another capable person will, someday, accept the challenge to perpetuate this every popular VALLEY OF THE SUN tournament.


