NHPA PUBLICITY FOR MARCH

Bernard Herfurth, NHPA Publicity Director, while vacationing in sunny Florida will distribute NHPA membership blanks to other vacationers from the North that they might distribute them to sporting goods stores on their return to their northern homes. It is believed that many sport enthusiasts will join a Naitonal Association even if they are not participants in our sport. It will be suggested that the membership ask the sporting goods stores if they be permitted to insert membership blanks in horseshoe boxes that are for sale and also leave NHPA flyers in the stores. NHPA flyers will also be distributed while in Florida.

The 200 and 100 shoe qualifying has been eliminated in favor of the round robin games qualifying for the championship games. This will eliminate play during the heat of the day. Last year at Huntsville, it was decided to have all championships decided on the final day of the tournament. News releases will be sent to the Statesville newspapers prior to the start of the 1983 World Tournament.

NHPA Publicity is also working on plans to publish a "one-shot" tabloid. All state secretaries are asked to send approximate dates of all tournaments in their respective states, plus location of courts and names and addresses of the tournament directors.

1982 WORLD CHAMPION DALE LIPOVSKY CAPTURES FIRST MOORHEAD, MINNESOTA TOURNAMENT OF CHAMPIONS TITLE

Dale Lipovsky proved the champion that he is by capturing the first Moorhead, Minnesota Tournament of Champions in the 12-man event sponsored by the Ohio Horseshoe Company, Budweiser and the Moorhead American Legion Melvin E. Hearl Post No. 21 last fall.

The poised 27-year-old lefthander won Division I while his father, Leonard, won Division 2. Dale won the 50-shoe playoff game 32-20 by pitching 74 percent ringers compared to Len's 66 percent.

It was another of the many times the father-son combination have paired off on the courts. They pitched in the Minnesota State Tournament at Genola where Dale won his seventh title.

Lipovsky, who won his first world title at Huntsville, Alabama in August, will defend the title at Statesville, N.C.

Dale Lipovsky averaged 68.4 percent ringers in his six-game round robin competition at Moorhead. Len averaged 66.8. Fred Ash of Crosslake, Minn., took runnerup honors in Division 1 and was third overall with a 66.8 percent mark. Gene Lykken, the North Dakota champion from Kindred, was runnerup in Division 2 with an average of 64 percent.

Wally Rislov, the biggest winner in N.D. during the regular season and winner of the earlier

Moorhead Legion Open, dealt Dale Lipovsky his only setback.

Ohio Horseshoe Co., donated shoes for the Tournament of Champions with all pitchers using the pros and O's in the event. Dale Lipovsky won \$100 and received expense money for the tourney from sponsors and received free lodging at the Hawaiian Inn. Budweiser furnished prize money, a jacket and shirt to the champion who won his first state title at Moorhead.

The tourney involved pitchers from Minnesota, North Dakota and South Dakota. The courts were in excellent shape, and the weather was perfect. Will Gullickson and Lyle Romuld promoted the event and Romuld and Gust Magnuson prepared the courts.



WHY JOIN THE STATE & NATIONAL ASSOCIATIONS?

Donnie Roberts says "WHY NOT?"

All the rules that we play by were developed by the NHPA. Your state champions are officially recognized. If your state tournament was not sanctioned you would have no official stae champ. Your sanctioned tournament winners receive patches from the NHPA.

The Los Angeles Dodgers would not be world champions if they didn't belong to the National League. Jack Nicklaus could not compete in golf tournaments if he did not join the GPA. Bowlers can't be on the TV tour if they didn't join the PBA. If horseshoes didn't have the NHPA they wouldn't have an official event, no digest, no world tournament, no rules, no organization, no league program, no anything. We have gotten TV, Radio, and newspaper coverage all over the world. We have a Hall of Fame. If we did away with the NHPA we would have fifty states playing 50 different ways. Horseshoes would really suffer. What if we didn't control the types of shoes on the market?

\$6.00 is nothing for membership. One carton of cigarettes, a 12 pack of beer, ¼ tank of gas, one night at the bowling alley, a stop at McDonald's, or one trip across the West Virginia Turnpike are things which cost about \$6.00. Surely we provide that much benefit.

Our league program offers far more than the bowling leagues get from the PBA and for less

The NHPA is ready, willing and able to respond to the needs of the states. I know of no request that any state or pitchers has made of the NHPA that was not given consideration, so ask. Unsanctioned tournaments and separate state cards are not the answer to the future of horseshoes in your state. You only kid yourself if you think so. Pete Rose will never be in the baseball hall of fame if he plays at the local high school on Sunday afternoon. Even tennis realized that two separate groups was not workable. If you have officers in your state who advocate breaking away from the NHPA vote them out. They are not good for our sport. Horseshoes will benefit most from strong state associations and a strong NHPA.

Dear Sir:

At the risk of jeopardizing my long standing reputation as an advocate of equal rights, I feel impelled to comment on the article in the January issue of **Horseshoe Digest** written by Debby Michaud wherein she reasons that prize money should be equal between men and women.

The determination of equality in the distribution of prize money between the sexes in any sport should first give consideration to equal conditions while participating. In horseshoe competition, the difference of 10 feet in the pitching distance between men and women is most significant when analyzing the execution of the pitch. Because of the lesser distance, women enjoy the distinct advantage of a lesser margin for error while generating power from the step, the arm swing, the lift, the trajectory and the follow through. In addition, when sighting the target or allowing for any wind, distance is a major factor. Hence, a lesser degree of skill is demonstrated through inequality of distance and, following that, a share of prize money commensurate with the lesser degree of skill should be awarded. In the highly skilled art of horseshoe pitching, I agree with the acknowledgment and recognition of those skills at their highest level and feel that awards of equal prize money for lesser skills would detract from that excellence.

In Northern California a young lady of considerable horseshoe pitching skill has chosen to compete with the men at a distance of 40 feet and averages well up in the 40 percent range. When she finishes the competition of each tournament she has competed under equal conditions and she is rewarded on that basis, not on the mere premise that she is a woman, and because of that biological happenstance has reaped an unearned reward.

Consideration should be given to the fact that "equal pay for equal work" implies "equal conditions" and anything less could well be a step backwards for female pitchers and a disservice to the sport itself.


