From Your President — Glen A. Portt

Many cities have expressed an interest in holding the World Tournament but are hesitant about starting out on such a large scale. Because of this, your Council has made the decision to inaugurate thre additional annual tournaments. These three plus the W.T. will be known as the *four majors*.

The three will be the U.S. Open which may be held anywhere in the U.S., the U.S. Western Open (west of the Mississippi), and the U.S. Eastern Open (east of the Mississippi). This plan will give a city an opportunity to hold a prestige event, to bring in world class pitchers, and to gain valuable experience toward the day it decides to go for the big one... the World.

Cities interested in hosting one of the three additional majors must bid for it in the same manner as they would bid for the W.T. Bids will be opened at the '84 W.T. convention. The Council's goal is to build up these events to a \$15,000 minimum bid. However, for 1985, due to the short notice of this announcement, the minimum bid desired is \$7500 for the Western and Eastern Opens.

For 1984, the Council has voted to give the U.S. Open to Las Vegas for Dec. 2-6 if a written contract agreeable to both parties can be worked out. Las Vegas has indicated the prize fund will be a minimum of \$15,000.

Cities wishing to bid for the U.S. Western Open or the U.S. Eastern Open at the '84 W.T. convention will be bidding for the event for 1985. This gives a lead time of roughly 9-18 months in which to organize and raise funds. As anticipated entry fees are considered a part of the bid, the minimum desired bid of \$7500 appears to be within the reach of those interested.

The Council has a plan (not yet finalized) whereby a certain portion of the prize money from each tournament will be set aside and held by the NHPA. The NHPA will add a certain amount to this. This money will build up and part will be awarded to anyone who has 2 or 3 *consecutive* wins in the 4 majors. Another portion will be held for that person, who, somewhere down the road will make the GRAND SLAM of Horseshoes. This could be several thousand dollars.

YOUR PRESIDENT TRAVELS

Your President, in an effort to make the NHPA much more visible, has been traveling considerably in contacting TV networks and major corporations. In addition, at the invitation of various clubs, he has attended their functions. He has met some extremely fine people and has had some very interesting discussions.

John Huntzinger, who was hosting the Tri-State Horseshoe Conference (Colorado, Wyoming, Western Nebraska) at Ft. Collins asked me if I could possibly attend. I flew to Denver where John and Bob Champion met me. I attended the conference, was given a tour of some very fine outstanding horseshoe facilities, and was able to make contact with the Teledyne Water Pik corporation. I found the Tri-State conferees just about the most enthusiastic horseshoe group I have yet encountered. They are extremely well organized and appear to be a natural for holding the U.S. Western Open in 1985.

My second visit in April was to the PITCHIN' PALACE, an excellent indoor facility about 40 miles south of Milwaukee. Enterpreneurs Tom Roanhouse and Mike Wiess are spearheading this enterprise and appear headed for success. They have 240 doubles teams in that area (nobody pitches singles). None are members of the NHPA. I talked to the officers and I believe we have a chance of bringing them into our SANCTIONED League program in '85. I encourage every pitcher

to go by the PALACE when in that area. While there I was able to pitch a tournament with World Champion Dale Lipovsky, Clarence Bellman, Dave Hughes, Leroy Rowe, Harold Danrold and others.

I was also able to make contact with Johnson Wax Company, Miller Brewing, and Pabst. I have since sent proposals to Miller and Johnson. At the Pabst headquarers, I had considerable discussion wit Al Guerera, the advertising and Promotion Manager. Although not interested now, Pabst will keep the information on a back burner for 1986.

PROPOSED FOUL LINE RULE RE-WRITTEN

Refer to Page 20, Rule 6 on Foul Line definition

Due to considerable misunderstanding of this proposed change, it has been rewritten. It will now read as follows:

Page 21. Rule 8, Section A — Any shoe pitched while the pitcher's foot from which he/she steps touches the foul line shall be declared foul and removed from the counting area. All foul shoes shall be called by a referee.

Section B, (added) — The pitcher shall stand on the pitching platform with one or both feet behind the foul line. In delivering a shoe, the foot from which he/she steps must be behind the foul line when that step is taken.

(Note: This rule is self-policing. Each pitcher simply looks down to be sure the **foot** he/she steps from is behind the foul line before the step with the other foot is taken. Glen A. Portt

WORLD HORSESHOE PITCHING CHAMPIONSHIPS

The 1984 World Horseshoe Pitching Championships will be held at the beautiful Brahan Springs park in the heart of Huntsville, Alabama on July 25 through August 4 on their 24 courts. Over 500 contestants will participate.

The event presents the sport in its highest form. Played annually in different areas of the country. Men, women, boys and girls will compete, representing players from the United States and the Dominion of Canada. Players are divided into classes according to their ringer percentages.

During the last six days of the tournament a championship will be decided daily in all classes of men, women, boys, girls, Senior men and Intermediate men.

Championship classes have preliminary round-robin games of 50 shoes. The championship round-robin finals are decided by 40 point games with no shoe limit. Lower non-championship classes are 50-shoe round-robin contests.

The annual NHPA convention is held in conjunction with the tournament. Also the NHPA Hall of Fame induction ceremony and dinner; special awards; opening and closing ceremonies.

The tournament is hosted by the city of Huntsville Parks and Recreation Department. The tournament is conducted by the National Horseshoe Pitchers Association World Tournament committee. Thousands of dollars in cash prizes, scholarships and trophies are awarded.

Anyone travelling in the Huntsville area during the tournament is invited to stop by and enjoy the daily contests.

NATIONAL HANDICAP 'MAIL-IN' TOURNAMENT

WHEATIES SEARCH FOR CHAMPIONS LETTER TO BERMAN

Dear Dr. Berman:

I wasn't quite sure where to send this letter; I assumed you'd no longer be at your Florida/winter address, so used the one you wrote on the envelope. Hope this reaches you O.K.

I sincerely apologize for the delays and complications. I've been working closely with both our legal and contest departments, and am subject to their timetables. After researching the matter, they have informed me that since the contest is in fact void in Florida, we cannot accept ballots from residents of the state.

Yours, however, is a unique circumstance, given that those ballots submitted were from people merely visiting the state, and not residents. Therefore, it has been agreed that we can send you back the ballots in question, and the addresses can be changed. Please find the same enclosed, correct the addresses, and send them back in. Our contest department is aware of the situation, and will ensure that they are properly incorporated into the candidate's vote total.

Just to clarify further what I have learend from our legal department, I am reiterating the fact that the contest is definitely void in the states of Florida and Washington, and therefore no contes activity can be generated from those states. This means, apparently, that neither contestant or ballots can come from either area.

I am sorry if this has inconvenienced you; we wish, too, that those states did not have laws preventing us from promoting the conest there.

I was just about to close this letter when I received your letter dated April 26. To address your second concern about the packages in Arizona — I spoke with one of the brand managers. He suggested that perhaps the people in question did not realize that the ballot was on the box — but on the side panel. The "official" Search II packages, the first series on the shelves to announce the contest, have the ballot prominently displayed on the back. All subsequent package series have different package covers (non-Search), and the ballot is found on the side panel.

Hopefully this solves the dilemma. If you find out to the contrarn — that these packages definitely do not have ballots — please let me know. I will then have someone on the brand follow through, and check with that region's sales/distribution personnel.

Once again, I hope this clears up the confusion. Aside from these "problem areas," how is the campaign for Boni going? I think she is doing quite well in the balloting; your organization must really be supportive of the cause. Is there a "Minnesota correspondent" for NHPA who is responsible for coordinating her campaign? I would be interested in getting ahold of such a person to learn of the efforts the organization has made, votegathering "techniques," etc., and perhaps to offer publicity assistance.

If you have information along these lines, I would greatly appreciate hearing from you again. And I hope the rest of the contest runs smoothly for everyone.

Tari Powell of Rankin, III. is one of the country's record setting competitors in horseshoe pitching and according to her, she's just beginning. "I know I will win the World Tournament someday, as I have confidence in myself," says Tari. "If you have confidence in yourself, others will, too."

Tari was 15 when she began pitching along with her father. She recalls that she tried very hard to play well and when she beat her father a game her family decided she was ready for competitive tournament pitching. Tari says "I guess you could say I like competing. I knew then that I wanted to keep on pitching and better myself."

Tari practices every chance she has. Of course she takes time out for her husband and daughters.

In the World Tournament at Statesville this year, Tari placed 2nd. She earned her highest game of 86.5% against Debby Michaud. Both set world records in that match.

Tari's secret to successful horseshoe pitching is concentration, and always try to relax. Never put yourself down if you lose, there's always a next time.

Tari has won the III. State Championship 4 times, held the Midwest Tournament of Champions title for 2 yrs. and also won the III. State Fair Tournament.

She is currently the 2nd V.P. of the III. State Assoc.

Tari says her community is very supportive, but she owes a lot to her family. She had a supportive family when she first started and now she has a family of her own and they are just great. They encourage me to pitch and help me feel good when I lose.

Thank you for a job well done. The Digest seems to be getting bigger all the time.

The "Foul line even with the stake" ruling that our President Glen Portt is proposing is rather alarming. I feel so for the following reasons:

1. Before a new foul line is proposed shouldn't we police the present one before we rule it out. Let's give it another "go-around."

2. Why should 99.999% of the pitchers who observe the present foul line ruling be penalized by the .001% of those who maybe don't.

3. Many horseshoe pitchers including myself require at least four feet or more to properly deliver our horseshoes. Almost all pitching platforms are only six feet long. The new proposed ruling under present court conditions will leave only three feet of platform to perform in.

4. The new proposed foul line ruling will impose quite a financial crisis. Pitching platforms will have to have "tail" extensions on them to allow tall pitchers enough room to properly pitch their horseshoes without fouling. Many indoor and outdoor courts have crowded situations with backstops, fences and walls. We surely wouldn't want all this remodeling expense just to accommodate an unnecessary foul line ruling.

 Horseshoe pitchers will be forced to pitch their horseshoes three feet farther. Pitchers who have spent years perfecting their game will not appreciate having to make such a drastic change when it is not really necessary.

6. President Portt states that if the membership will adopt this rule, our problem on "fouling" should be eliminated. Until robots start pitching horseshoes we will have the "foul line sin problem" regardless of where the foul line is placed on the pitching platform.

7. I personally haven't seen the present foul line abused. I must travel in good company. I do see a need though of informing the membership of the enforcing of playing rules No. 7a and 7e. I will personally begin doing all that I possibly can to defeat the proposed foul line ruling.

Dear Mr. Editor:

The following comments represent my thoughts on the issues of the foul line controversy and the publication of only the results of N.H.P.A. sanctioned events.

If the foul line is to remain under the present rule the real problem is the enforcement of the foul and who may call the foul. Until we horseshoe pitchers agree that the rules of our sport must be enforced as they are in other sports, we will continue to have this on-going problem. Since it would be impossible to have a referee walking along with each pair of opponents, my suggestion would be to allow the judge, scorekeeper or the opposing player to call the foul line infraction the instant that it happens. If the opponent calls the foul the instant the player's foot comes down upon or over the foul line, then the offender has a chance to look down immediately to verify that he/she has in fact fouled. Of the three, the opponent definitely has the best position from which to make the call. The judge is usually out of position to make the call and the scorekeeper definitely is, unless of course the foul is of a flagrant nature. Does the opponent have the guts to make the call? Under the present rule the ideal enforcer would be some kind of sound device that would signal the foul, as has been suggested.

As I understand the intent of our President's proposed foul line change (March Digest), both feet would have to be behind the line (even with the stake) before making one forward stride over the line (no matter how long) while or during the delivery of the shoe. Many of our present players start with one or both feet forward of a line even with the stake and take a short step in order not to foul the line three (3) feet in front of the stake. Since the proposed change would be unfair to these pitchers, my solution would be to give the pitcher the option. In other words, have one line even with the stake and another three (3) feet forward. If you start with both feet behind the line even with the stake you may take one stride as far as you wish. On the other hand, if you start with one or both feet on or forward of the line even with the stake you may not contact or go over the line three (3) feet in front of the stake. This would not solve all of our present enforcement problems but it should help.

In my opinion the digest should be for the interst of "all" horseshoe pitchers. To say we are going to only report results of our N.H.P.A. members seems to make us cliquish and gives the impression to non-members that they must join us or else remain outsiders.

Many recent articles in the digest have dealti with publicity with a theme of "Let the world know about the great sport of horseshoes." Then our very own official publication says in effect, "World if you want to know about what is going on in our sport in your area you must be one of us and sanctioned by us first."

No matter how large we, the N.H.P.A. become, let's not fail to report issues of interest to all horseshoe pitchers (including tournament results) that are outside of our sanction. To do otherwise (in my opinion) would be detrimental to our sport, not to mention subscribers to the digest.


I for one enjoy reading the letters over the controversy of the foul line. First I feel we should thank our President for his proposal, this tells me his mind is in the interest of horseshoe pitchers. Some one has to start, before anything can be improved on. In reading these letters, our President got some horseshoe pitchers thinking. I feel we should quit feeling derogatory about the foul line, after all, this is just a proposal, not law. I feel some good can come out of this proposal. First — horseshoe pitchers are thinking and when people start thinking, good things are sure to come.

I for one would like to see our present foul line improved on. I feel most pitchers will agree with me, our present foul line rule has been serving us well for many years, yet there is one thing i don't like about this rule. This being able to leave the pitching platform before the shoe lands in the pit on the opposite end. We speak of judges, (if the shoe has left the pitchers hand, it is OK to continue to the opposite end.) This to me is the big controversy, has it left his or her hand? Is he or she running with the shoe to the other end with their follow through? This to me is what is wrong with the present foul line. Our judges have too many things to keep track of, (foul line stepping on, and shoe leaving pitchers hand.) Our judges have their hands full, why not make their work easivr? We have been getting by too long.

We have a foul line and I feel no one should be able to step on or over this line, until the shoe has landed in the opposite pit. This takes the load off the judges. The way I see it now, with the present foul line rule, most all of us are fouling at some time or other. Most all pitchers last shoe, is what I call a running shoe, for we are going to the opposite end anyway. I say no professional is in that big of a hurry, that he or she can not wait till the shoe lands in the opposite pit, before he or she crosses the foul line. This to me is a foul, just like in bowling. I feel this would be a very good proposal, with little change. This to me would make all pitchers equal.

Dear Editor and Fellow Horseshoe Pitchers:

It has taken me quite a while to get around to writing this letter, but I finally decided I had to write it to be at peace with myself.

First, it seems to me this flap about the ridiculous change in *foul lines* was settled at the 1983 meeting of the N.H.P.A. when it was so resoundingly defeated. Is it impossible for the supporters of such a thing to be able to take defeat and go on about the business of helping the Association? That change alone would drive at least 20 members from the N.C.H.P.A. It has been my experience that there is little, if any, trouble with the foul line as it is presently in use.

Second, I read with great fear the letter from Gary Minnick, President, Arizona Horseshoe Pitchers Association, regarding the granting of a charter in their association. I see nothing in the By-Laws that gives the N.H.P.A. authority to grant association charters. Are the separate associations not autonomous in their own affairs as long as national is not harmed? It would seem to me that National has all it can handle without entering into the individual association affairs. The associations may at times look to the N.H.P.A. Executive Board for advice and support, but not to be told to whom they should grant charters or not grant charters.

Third, this is my pet peeve, is the discrimination in the *whole* N.H.P.A., against the players, who are the majority, with averages under 50%. These people carry the load, pay the bills, and do the work, but when it comes to *big tournament* play, they are forgotten. In the big tournaments, the top three (3) groups are allowed to pitchin

12-man groups, or larger, but the rest of the players seldom are allowed to play in anything more than eight (8) man groups. Do these players pay less for their entry fee? Does it cost them less to travel to these tournaments? Do they contribute less to the sport of horseshoes? I think the answer to all of these questions is a resounding NO. It is about time we got somewhere near equal time on the courts at these events. I'm talking about such events as the World Tournament, the large Winter Tournaments in Arizona, and *all* State Championship Tournaments. It was proven in 1983 in California that large State Tournaments over 200 entrants can be run with all 12 man groups and run smoothly and to everyones satisfaction and enjoyment.

I, and many of my friends, truly love the sport of Horseshoes and devote many hours to the game, both playing and promoting, but many of us are unable, or unwilling, to travel long distances to pitch 5 or 7 games and then be told that is all there is.

It seems to me that it is about time we stopped worshipping the glory players and paid a little more attention to the people who make and keep this great association running and growing as it is.

This letter took considerable thought, but it is my firm belief that if the people that are trying to do something good for the Association, would devote their time and energy to the players and forget such trivial things as foul lines, and the entire Association would be better off. Remember, the Association is PEOPLE, not foul lines. Without the PEOPLE the rest of it would be less than useless. In my opinion, it is time we put our priority on the PEOPLE and let the little things take care of themselves.


