FROM YOUR PRESIDENT ... DAVE LOUCKS

Not only do we expect a record turn-out at the Eau Claire World Tournament, but we hope the ideal conditions will bring about some record performances. The NHPA has entered into an agreement with TeleVideo Productions of Eau Claire to produce a professional video of the 1987 W.T. highlights. This video will be available for sale in VHS or Beta formats for \$34.95.

The Convention in Eau Claire will no doubt be a long one. Members sent in 37 suggested changes to our Constitution and By-Laws. Some 30 were approved to come before the Delegates for vote. I ask that each State Charter review and discuss these proposals with your membership. There are a few that suggest some major changes to our game and policy. Don't be ruled by your personal emotion. View each proposal from the point of: "will this improve our game and enable the NHPA to better administrate policy and attract media attention". Send informed delegates to the convention and make sure your spokesperson is a *Digest* subscriber.

DAVE'S COURT REPORT

In the December *Digest*, I wrote about a plan to establish a special newsletter that I would write to Charter Officers, in particular, the president. I asked each Charter to send me their comments and answer four questions. Apparently, many Charters don't get the Digest or my request was too big a task for some. Out of 60 Charters, I received replies from 24. Unfortunately, it took a special follow-up memo to get some of those 24 replies. Even then, 10 Charters who were sent this special mailing by me failed to respond. While I am not happy with the overall response, those that did write were generally enthusiastic, and so, I will proceed with the idea.

The 1986 membership reports have recently been completed by Donnie. We had our largest membership increase since 1982. Membership was up more than 800 to 10,277. The most notable gainers were Iowa, New Mexoco, Mississippi, Ohio, Northern Utah and Virginia. My congratulations to these Charters. Unfortunately, the Charters of Western Maryland, Massachusetts and Nevada report big declines.

It has been suggested that the NHPA adopt a slogan. This idea comes to us from member Harold Morris in Taylor, Michigan. Your NHPA Officers are frankly not sure so I have decided to bring it to the members in the form of a contest. I am inviting you to submit your slogan idea that would be identified to our sport. The best of these slogans, as decided by the NHPA Council will then be presented to the Delegates in Eau Claire. Only if the delegates

show their support of the idea by voting a clear-cut winner, will we adopt an official slogan. Contest rules are as follows:

- Entries must be postmarked by May 15, 1987. In the event of identical entries, the one with earliest postmark will apply.

- 3. Council will decide which ones will come to delegates for vote.
- To be declared a winner, a slogan must obtain the approval vote of two-thirds of the delegates represented in Convention.

TELEVIDEO PRODUCTIONS

The National Horseshoe Pitching Association and the Eau Claire, Wisconsin, Horseshoe Pitching Association have made arrangements with a professional television production company, TeleVideo Productions of Eau Claire, Wisconsin, to provide a professional video of the 1987 World Horseshoe Championships taking place in Eau Claire, July 27 through August 8, 1987.

Mark Atkinson, president of TeleVideo Productions, says, "The format will be as professionally done as you might see on ESPN or TNN. It will include complete narration, music and video of the top matches, along with hints and tips from the winners. It will be entertaining as well as educational."

The video will be available for home video players in VHS or Beta formats and will highlight the World Competition in about 40 to 50 minutes of finished product.

The production will be a joint venture between the local and national horseshoe associations and TeleVideo Productions. The retail price will be \$34.95, and it will become available tby September 15 through the National Horseshoe Pitching Association.

REGIONAL DIRECTOR'S REPORT

This report is several months late but my hospitalization of 33 days has caused a backlog in my NHPA work. I am on the mend and back in the swing. A comprehensive report from Jerry Walton, President of the Mississippi Association was very gratifying. Jerry is not the regional director for region #31 but he works very closely with Bill Calhoun, the RD.

Mississippi is a new charter and 1986 was a banner year. The boast 111 members for 1986! In November their first time ever State Tournament was held in Ocean Springs, MI. "Cotton" Bosarge was crowned the State Champion by virtue of 8 wins and 1 loss. Class "B" was won by "Moe" Beauguez; class "C" by Richard Miller; class "D" by Mike Uher; and class "E" by Lloyd Jeffcoat. The ladies State Championship was won by Jo Tisbury; class "B" by Sharon Garner; and class "C" by Fern Weekly. Elton Balius was voted "Sportsman of the year". Much could and should be said about the tremendous effort that was put into the tournament but space does not permit. Just let it be said that we congratulate the members of the

Mississippi Association for their great first year. Jerry informs me that bigger and better tournaments are in the future of the Miss. Association.

A report dated December 10, 1986 from Assistant RD, Bud Schardine of Springville, Utah informs us that he has established the only public and free indoor courts in the State of Utah! Two courts located in the basement of the Springville High School, are used by NHPA members and school children alike. The future of our sport is tied to programs such as this where our young people are exposed to the game. Bud deserves our accolades for his efforts to make this program a reality.

Jim Shilling, regional director for region #12, Indiana, reports a record 226 pitchers entered their State tournament for 1986! Promotion is progressing nicely in Indiana with a new 8 court facility being built south of Spencerville at the Willis Miller Campground. Six new courts were constructed in Ft. Wayne and will be used in the Adams County traveling league. Mettert's Indoor courts have a new roof, paint and new scoreboards. This facility is home to some 90 Classic City horseshoe pitchers. A new club, Ohio Valley Horseshoe Club, has been formed at Madison. They report 30 pitchers using the six court complex. A sanctioned tournament has been scheduled for 1987. Granny Palmer, Jim Lane and others put on a pitching seminar for over 500 youngsters at a school in Vincinnes. Bonnie Seibold is introducing the game to many juniors in the Huntington Schools. The State of Indiana continues to move ahead in the promotion of our game.

Jack Springer reports from North Carolina that the Dogwood Festival has been moved up one week to April 11, 1987 and the Statesville autumn has been moved back a week to Sept. 26, 1987. Jack will be heading up horseshoe clinics again in 1987 for adults and juniors in the Carolina areas. They inaugurated a Church league last summer and it will be expanded in 1987. For the record all tournaments held in Statesville are NHPA sanctioned.

LEGENDS OF HORSESHOES

No, we don't have them all on tape ... but we do have a few.

The men?... Elmer Hohl, Carl Steinfeldt, Frank Stinson, and Paul Focht (with Dale Lipovsky thrown in for good measure). The women?... Vicki Winston, Ruth Hangen, Phyllis Negaard, Debbie Michaud, Teri Powell, and Lorraine Thomas.

This video tape was made at the 1984 World Tournament by Dr. Sol Berman in his capacity as Promotion Chairman and it is the best I have seen about our sport. Any horse-shoe player who owns a VCR (or who can borrow or rent one) can watch this tape over and over and receive valuable tips from the world's greatest. The individual styles can be leisurely studied, analyzed, and emulated, if so desired.

I have viewed this tape several times, running it back and forth, looking at parts of it in slow motion... hoping that I could find that one magic something that would increase my percentage 10 points. Did I? No. I have come to the conclusion that after pitchers reach a certain age, they are not going to improve... they will do well to just hold their own. However, not true for the majority. They can improve and I believe this tape will help them.

In watching this tape, I tried to pick out the points that most of the legends have in common. *The first swing...* 4 of the 5 men and 4 of the 6 women brought their shoes to eye level, generally sighting through them. *Back swing...* no definite pattern here... anywhere between the hip and the shoulder. *The forward swing...* 7 of 11 swung their shoes past their knee at knee height with actual release of the shoe at that height or just slightly above. *Straight arm...* 6 of 11 kept their arm straight (not stiff). *Follow through...* 8 of 11 had a high follow through.

During my horseshoe career, I have always been told and have tried to adhere to the rule to "step straight toward the stake". Is this good advice? I found that most of the legends *step straight* (parallel to the pitching platform) or almost straight... while two of the very best, Hohl and Michaud step toward the right hand corner of the slab.

So... to improve your pitching, should you sight thru your shoe? Have your backswing end

between your hip and shoulder? Be about knee high on your forward swing? Pitch with a straight arm? Have a high follow through? Step parallel to the slab? What to do?

Order this tape! Study it. Pick the legend you'd most like to copy. This tape could be the best investment you'll ever make. Write Sol Berman, 1 Wycliff Road, Palm Beach Gardens, FL 33418 and enclose \$25. You won't regret it.

Of course there is another way... the sine qua non route! Sine qua non (if I am recalling my Latin correctly... which I could never do when I was taking it) means "not without which"... and without which prepared horseshoe pitchers usually are not. This system works real well along about 2 A.M. when it begins to get chilly.

NHPA PROMOTION COMMITTEE REPORT

The NHPA Ring — An NHPA Ring became available about ten years ago. Ideas for the ring were gotten from my 300 bowling ring. Interchangeable bezels makes it possible to have four different models. The regular NHPA ring. The second one has the words State Champion on it; there's a ribbon on the side of the ring on which the name of the state can be placed or the year. The third bezel, Hall of Fame; it can be used for the State Hall of Fame by placing the name of the state on the ribbon. If the ring is for the NHPA Hall of Fame, NHPA can be placed on the bezel. The fourth bezel, World Champion; the ribbon can be used to denote the class — girls, boys, intermediate, seniors, women, etc. The year can be placed inside the ring.

Pennsylvania has been presenting their NHPA inductees' rings. New Jersey has purchased rings for their State Champions.

Control of the ring dies and bezels has been turned over to Ed Domey, P.O. Box 298, Wilkinsville, MA 01590.

1986 Bowler of the Year — Walter Ray Williams, Jr. was selected as the 1986 Professional Bowlers Association Player of the Year. He was top money winner, winning \$145,000. He won three PBA titles and appeared on TV nine times.

On Feb. 14, 1987, he beat top seeded Marshall Holman 277-205 in the title game of the \$150,000 Miller Lite Classic at Kendall, Florida, winning \$27,000.

The tournament is the first leg in the \$1 million Miller Lite Slam. If he wins the upcoming Miller Lite championship in Milwaukee and the Miller Lite Open in Cleveland he will earn a \$1 million bonus from the Miller Brewing Co. If he wins one of these two events, he will earn a \$50,000 bonus.

Williams & Aulby rolled 300 games during the qualifying rounds.

It is with deep regret and sorrow that we report the death of Clayton C. (Boo) Henson of Arlington, Virginia.

He was a charter member of the Virginia Horseshoe Pitchers Association and the first living member to be put in the Virginia Horseshoe Pitchers Association Hall of Fame. He was Virginia State Champ. 15 times and D.C. Metro Champ. 34 times. He was a champion pitcher and a champion person. We will miss him greatly.

It is with sadness the passing of three members of the Missouri Horseshoe Pitcher's Association in 1986. All three belonged to the Missouri Hall of Fame.

John Elkins of Neosho, Missouri had served as an officer in the Missouri Horseshoe Pitcher's Association and former title holder of Missouri six times. He was a life-time member of the NHPA and a promoter and director of tournaments in and around Neosho.

Robert Bales, Kansas City, Missouri won the state title in 1940 and played against some of the World Title Holders in those years. He was also a good golfer and bowler.

Ray Cavin of St. Joseph, Missouri was a promoter and director of many tournaments in and around St. Joseph. He served twenty-seven years as tournament director and was past president of the St. Joseph Pony Express Horseshoe Club. The courts in St. Joseph were named the Ray Cavin Courts, due to his management of the courts, by the officials in St. Joseph. Steven carried a scholastic grade average of A+ during the 1986 school year, maintaining the highest standards in his education, plus the following achievements as a pitcher and member of the Independence Junior Horseshoe League.

Nationally, Steven carried the 3rd highest ringer percentage, 3rd highest point game, and 4th highest point average, and in the Boys Division, carried the 3rd highest ringer percentage and 2nd highest ringer game, earning a 2nd position National Top Ten plaque.

Steven is commended and recognized for his outstanding achievements in the game of horseshoes, while still maintaining the highest standards in his scholastic education while in the classroom.

The Officers and Members of the NHPA recognize Steven as an outstanding youth of the National Horseshoe Pitchers Association.

FENIMORE AND McCARTY INDUCTED INTO ARIZONA HALL OF FAME

On February 15, 1987, during a break in pitching at the Valley Of Sun Tournament, M.H. (Bud) Fenimore and Ralph McCarty were inducted into the Arizona Hall of Fame.

Bud Fenimore was the moving force for horseshoes in Tucson for many years until his death in November. He was a founder of the Tucson Horseshoe Club and was instrumental in getting twelve new courts in Reid Park. The courts were dedicated just prior to his death. He was known as "Mr. Horseshoe" in Tucson. He served four years as secretary of the Arizona Horseshoe Pitchers Association and directed many tournaments in Mesa and Tucson. He was instrumental in enlarging the Valley Of Sun Tournament and was known to many of the nation's top pitchers.

Ralph McCarty was noted for his many years of tournament directing, league directing, and service as an officer in the Arizona Horseshoe Pitchers Association. Ralph is presently Treasurer of the Association, a post he has held for over ten years. He was Secretary/Treasurer for five years. He has been Secretary/Treasurer of the Apache Trail League since 1977. He has been involved with the Valley Of Sun Tournament for over eleven years, serving as Director many times.

Dave Loucks, President of NHPA, presented Ralph with his plaque, and Bud's widow, Florence, received his award.

PROPOSED CONSTITUTION AND BY-LAWS CHANGES

Proposed Constitution and By-Law changes that the majority of the committee has agreed have sufficient merit to be brought before the Delegates at the 1987 Convention.

Page 5

1. ARTICLE III, SECTION 5, Par 2, Change to read

Should the office of the presidency become vacant for any of the above reasons, the First Vice-President shall become the President for the remainder of the term. Normally, the Second, Third, Fourth and Fifth Vice-Presidents would move up in sequence. In the event any or all decline, the new President is empowered to fill the vacant VP office by appointment as defined above.

Reason.... The Fifth VP is currently assigned, by another By-Law, the responsibility of the Regional Director Program. As we grow and other VP's are assigned specific job functions, it would be foolish to lose that expertise by forcing Vice-Presidents to move into another office.

2. ARTICLE III, SECTION 7 Change entire paragraph to read;

The President may appoint any committee and/or chairperson he/she deems advisable for the good of the NHPA. These committeepeople normally from the NHPA membership shall be under the direction of the President or the appointed chairperson. Their work will normally be accomplished through correspondence. On those occasions of priority or circumstance, the phone may be used or a special meeting, approved by the President, may be called. Issues requiring a vote shall be decided by a simple majority of committeepeople present if a meeting is called or by majority of all committee if voting by mail or phone.

It shall by the duty of all committee members to serve willingly and in the best interests of the NHPA. Any committeeperson may be removed by the President with the majority approval of the Executive Council. Any committee that has been inactive for more than one year or whose specific project has been completed, can be dissolved by the President.

Reason.... Some of the wording of the current By-Laws is ambiguous, out-dated and redundant. It needs to be changed to better reflect current requirements for organizational growth.

3. ARTICLE IV, SECTION 2 Change the last sentence to read

The newly elected officers shall take office on January 1 following the election.

Reason.... This change is needed to make a proper change of officers. Since so many NHPA programs work on a calendar basis, this only makes good sense. For example, Donnie gets paid \$1.00 per member for 1986. Suppose I go out of office on August 8. How would we figure the \$1.00 per member for 1986? If Gene went out of office, how would we figure the RD Allowance for 1986? The new person would have to depend on Gene. What if the new President decided to replace Terrence or Ed or others on August 8. It would be poor timing. If this January thing is good enough for the President of the US it ought to be good for us. We need the time to change properly.

4. ARTICLE IV, SECTION 7, Par 3 Change to read

All interstate sanctions shall be issued through the Secretary-Treasurer and/or Fifth Vice-President, who shall notify the State Associations or state representatives in each state

included in such territory assigned to an interstate tournament. All sanctions for intrastate tournaments shall be issued by the Fifth Vice-President and/or Regional Director who shall require that National Rules be followed and each participant be a member of N.H.P.A. A copy of the sanction shall be forwarded to the National Secretary-Treasurer for recording. Championship certificates and/or insignias shall be issued through the Fifth Vice-President and/or Regional Director upon certification that National Rules were followed, legal shoes were used, and all participants were members of the N.H.P.A.

Reason.... Needed to bring us in line with our Fifth Vice-President issuing sanction certificates through the RD's.

6. ARTICLE IV, SECTION 12 Change to read

The fiscal year of the N.H.P.A. has been established as April 1 through March 31. It is the responsibility of the Secretary-Treasurer, Managing Editor of the *News Digest* and all persons appointed or elected to handle sport related items, to submit their books to the N.H.P.A. appointed auditor for review and audit not later than April 15 each year. Those completed audits are to be published in the *News Digest* each year.

Reason.... To aid auditor in receiving timely information as well as giving him sufficient time to make a proper review and to issue a correct financial statement.

No sectional, national or world tournament game shall be played in the rain. The tournament committee shall decide whether it is raining sufficiently hard to stop play and shall communicate this to the affected participants directly or through the official referees. When the game is stopped on account of rain, upon termination of the rain and satisfactory repair of the courts, it shall be resumed after the last pitch in which both contestants pitched both shoes. The tournament committee shall also determine these two provisions.

Reason.... This rule is impossible to follow. For example, if I throw a shoe on first pitch that is maybe on or maybe off and a big rain starts immediately with the tournament director calling a rain delay. Even if we leave my one shoe in the clay during the rain, when we go back and it is in 4 inches of water or maybe bumped by the cover, we don't know for sure if it was a ringer or not. If I had thrown a double and took it with me, I could never place it

back like it was. This rule cannot be followed. We need a rule just like baseball which says that we start over after the last full completed inning. In our case that would be the last time both pitchers threw both shoes.

If more than two tie, first place shall be decided by a ladder-type playoff based upon player's total points. In all other ties, trophies shall be awarded based upon total points, but monies shall be divided equally.

Section 6 - Change to read

In any tournament, ties between contestants for first place shall be settled by play-off. Other ties shall be settled by total points.

Section 7 through Section 13 - No Change

Section 14 - Change to read.... The Point System must be used in any and all pitching activities.

Section 15 through Section 19 - No Change

Reason.... The presently approved cancellation — ringer percentage method would be eliminated leaving a count-all point-average method. I feel the count-all method would in-

crease participation in our sport, make it more adaptable to media participation, and will be necessary if indoor pitching facilities are ever going to successfully compete nationally against bowling and other indoor sports.



Each Vice-President and the Publicity Director shall receive \$200 annually for the performance of his/her duties, plus \$200 expense money for attending the World Tournament. The Publicity Director, if a Vice-President shall receive \$200 additional. The Vice-President charged with the Regional Directors Program shall receive an additional \$400 annually. The N.H.P.A. President shall receive an annual allowance of \$1200.

In case a Vice-President cannot attend the W.T. for any reason, then he/she receives nothing for a year's work. Under the above proposal, a Vice-President will receive an allowance of at least \$200. 26. RULE 4 — SECTION b Change to read

The clay or synthetic substance area must be a minimum of 43 inches long in the direction in which the players throw their shoes and 31 inches wide. The maximum area is 72 inches long and 36 inches wide. This area must be located in the middle of the pitcher's box with the stake in its center. This area must be filled to a depth of four to six inches and kept in a moist, putty-like condition.

Reason.... We should not list dirt or sand as an acceptable pitching substance and should list synthetic clay.

Rule 14 — Scoring Rules

This is one official method of scoring - the count-all point-average method.

CANCELLATION SCORING: DELETE a. through s. — DELETE

COUNT ALL SCORING

- A game is divided into innings and each inning constitutes the pitching of two shoe by each contestant.
- b. A regulation game shall consist of 50 shoes pitched by each player (25 innings).
- c. Each player shall receive credit for all points scored according to the position of the shoes at the end of each inning, regardless of what his opponent throws. Thus it is possible for each player to score up to six points in any one inning. A perfect game shall be 150 points.

- d. Players shall alternate first pitch, one player having first pitch in the even numbered innings and the other player in the odd numbered innings. The double alternate first pitch may be used if desired.
- e. One shoe within six inches of the stake scores 1 point
- f. Two shoes within six inches of the stake score 2 points
- g. One ringer scores 3 points
- h. Two ringers score 6 points
- i. One ringer and one shoe within six inches of the stake score 4 points
- j. A leaning shoe scores 1 point
- k. Each player shall call his/her name and points scored at the end of each inning.
- Ties shall be broken by pitching sets of two extra innings until one player outscores the other.

RULE 14 - DOUBLES GAME

Two players are partners and pitch from opposite ends of the court against a similar combination of opponents. Partner's points are added together, but each individual's score also shall be recorded. Each pitcher shall pitch 50 shoes.

RULE 15 — THREE HANDED GAMES

In three-handed games, each player shall pitch 50 shoes. All other rules apply.

RULE 16 — RECORDING OF RESULTS

- a. The recording of results shall be as follows: W Games Won; L Games Lost; P -Points; OP - Opponents Points; PA - Player's Point Average.
- b. All past and future World Tournament Play-Offs in any Championship Division are to be included in total World Tournament Statistics.

Reason.... These revisions are presented as guidelines so that the concept of adapting a new scoring method can be considered. I feel the count-all method would increase participation in our sport, make it more adaptable to media participation, and will be necessary if indoor pitching facilities are ever going to successfully compete nationally against bowling and other indoor sports. 



NHPA DRESS CODE

The NHPA dress code states that horseshoe pitching is an individual sport... that a person's dress should lend to all participants' enjoyment of the game and shall not be objectionable to anyone taking part or anyone watching. I have all reaspect for the NHPA: I understand and appreciate what the dress code is trying to do.

I have been a NHPA member and participated in World Tournaments since 1960, in sleeveless shirts. I have tried to pitch in sleeves but I throw a high shoe and it's impossible for me. The dress code states that pitchers can pitch in tennis shorts with or without socks. That is for their comfort, which is the way it should be. Why can't I pitch in sleeveless shirts for my comfort? I can't understand the difference! I can change the type of shirt I wear and I will, but I cannot pitch in sleeves. I have been told I could not participate in the 1987 World Tournaments.

What is the NHPA trying to do to me? Would any of you horseshoe pitchers want to quit a sport that you have participated in since 1935? It would mean the end of my horseshoe pitching competition. I have pitched too long to change now!

My reason for taking this so personal is that out of the 700 pitchers in the 1986 World Tournament (at least 10 or 12 were sleeveless), I was the only pitcher to get a note from the dress code committee that I was improperly dressed. I was handed the note just before I was to go on the court for my second night's competition. I had my horseshoes in my hand.

I feel the NHPA delegates should have an opportunity to vote on the dress code. I have been a delegate for several years and it was never discussed in the National Convention.

In my 27 years of pitching in World Tournaments, if I have ever offended any pitcher or anyone watching on or off the courts with my dress or actions, I apologize, otherwise would you please support me at the National Convention, in what I think is right? After pitching in sleeveless shirts for 27 years, I'm being told "You pitch in sleeves or you *don't pitch.*"

PIONEER CLUB—SYRACUSE, NY — 1986 SEASON RESUME

The 1986 horseshoe season marked another highly successful year for the Pioneer Horseshoe Club located at the New York State Fair Grounds in Syracuse. Again, under the tremendous leadership of President Big John Ruston, and Vice President Al LaRock, the Pioneer "Red men and women" have grown to a membership of over one hundred! We also held events such as our first ever Open Tournament, and part of the Pulaski Tournament, which greatly influenced the entire state. John, himself, will be inducted into the New York State Hall of Fame this season, after over 25 years of top pictning and horseshoe promotion!

The gallant men and women wearing our red hats and shirts have spread their pitching prowess, leadership and co-operation throughout the state. Most areas are now aware of and respect the "rampaging redmen and women" from the Pioneer Club of Syracuse! Most recognize the fact that our club is for real — RED POWER — and is here to stay, 12 inside-courts strong at the New York State Fair Grounds!!

The single-most event that made this a reality, was our First Open Tournament held at the Fairgrounds last May. Although we have some veterans in our club, it was the first time the membership had tackled such a large project. Under the leadership of Ruston, Hinman, LaRock, Osinski and Sposato, and many other unsung heroes, we delivered the best open tourney of the season, and one of the best of all time! After carefully putting the right people in the right positions, all work groups co-ordinated their efforts to bring it off, beyond our wildest dreams! Since most of us started pitching in the backyard, like most of you readers, this accomplishment was like once in a lifetime! Having the tournament inside, on well equipped courts with accurate scoring devices was, of course, a big factor in our success last May. Even in May the weather can be quite brutal in Syracuse!!

With around 80 participants pitching in the tournament, the legendary, Carl Steinfeldt won Class A, after a close duel with State Champ Mike DeMartino. Carl, probably one of the top five pitchers of all time, put his powder-puff 1¹/₄ turn to work inside our building and literally smoked the opposition off of the Fairgrounds! Those who had never seen him, shuttered in disbelief as the horseshoe dynamo poured on ringer after ringer with the ease and coolness that has marked 50 years of pitching against the best players of all time. The record books link his name with the Allens, Days, Renos, and Hohls of yesterday and the DeMartinos and DeadEye Williamses of today. It makes you wonder if you play the same game he does!

Averaging around 82% for yet another tournament, Steinie was lavish in his praise for our tournament, and he has seen more than his share, that's for sure! Carl, also, conducted a professional clinic which held everyone's spellbound attention. It was the best clinic for horseshoes that I've ever seen, and was a credit to one of the games of true professionals. Kind of like hearing Ted Williams discuss hitting, or Lary Bird talk about shooting a basketball—really Big League!

State Champ Mike DeMartino wrote us a letter after the tournament, addressed to Vice President Al LaRock, the tournament director, congratulating us on a great tournament, and for a job well done! What a show of support!! Boy, we really felt we were on the horseshoe map, finally!! Thanks to all you workers and participants, we did it! We hope we can repeat the performance with another Open Tournament this May!

Growth of our over-all membership went to over 90 members, 72 pitching in the summer and 59 in the fall. The breakdown included 8 ladies, 6 women, 2 junior girls, 3 juniors overall. We anticipate even more players participating in 1987, so we are expanding from ten to twelve indoor courts!

Progress during the year included vast improvements inside and out of the physical appearance of our arena. We painted inside and out, and enclosed the ends of the building with corrugated metal. We encircled the pitching area, itself, with new mesh-wire fencework which has greatly improved safety.

In the fall, Saturday workers constructed new backstops behind each court to help prevent shoes, bouncing off the stakes, from going over the chain-link fence. Two new courts were underway, and newly constructed walls for bulletin boards and schedules were being built. The men also started and completed framework for a ladies bathroom and now await

putting in the plumbing during the spring.

Again, in 1986, we had very successful Summer and Fall Leagues. They covered twentyfour weeks of solid pitching with only a two week break just before the State Fair. Summer League lasts 16 weeks with a Spring and Summer session. Fall League starts in early September and goes to October 30th.

OUTSTANDING ACHIEVEMENT AWARD TO AL LAROCK

If ever a person endured a more difficult year in horseshoes than Al LaRock, I've never heard of them. Al suffered three heart attacks, nervousness and trouble with sugar diabetes. His ringer production and over-all play suffered as his health suffered. He slipped all the way from 45-50% to less than 20%, in the span of only one season. Through this entire tailspin "Stoney" hung in there and tried to weather the storm. He never complained or gave a lame alibi. He finished the season as best he could, hoping for a better year, next time.

Throughout the year, he continued his other duties as best he could as Vice President, despite his poor play. He did a tremendous job as Tournament Director of our First Open Tournament in May of 1986. He and Secretary Jim Robertson did all of the paper and leg work in helping to organize our very successful banquet held in November. Al's stout-hearted attitude is the type of attitude which is the very spirit of our club and one which has helped make our Club the fine one that it is today!!


