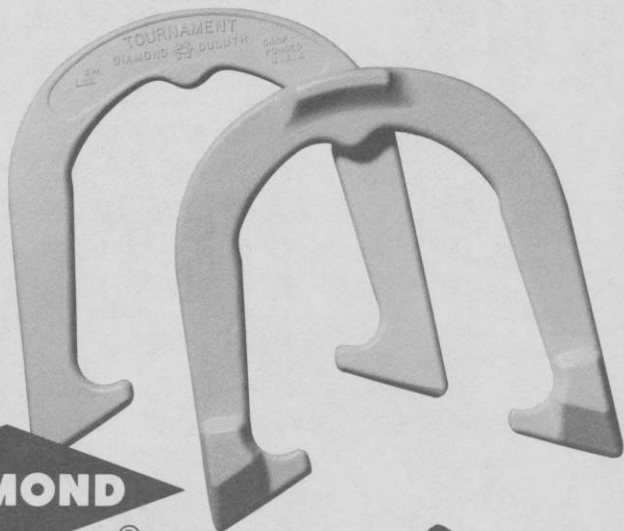

## FROM YOUR PRESIDENT . . . DAVE LOUCKS

Somewhere in our sport there always seems to be controversy. Cancellation of count-all, 30' pitchers playing with 40' pitchers, handicap or scratch, games are too long and pitchers too slow, not enough spectator interest, no uniformity in establishing or keeping pitching percentages, the list goes on and on. Where will it end, what can we do?

While most of us only talk about the problems, one man set out to do something about them. The task was not to work on just one problem area but to devise a program that would improve all facets of the game so it could be played in a uniform manner world wide. sound too good to be true or an impossible task? Well, I want to tell you that such a program does exist. It is a reality and if given a chance, could do more for horseshoe than any other thing we have seen.

Recently, Donnie Roberts and I had the opportunity to visit with George Schummer, the gentleman who had this visionary idea. We read and discussed the 8 page brochure, viewed an informative video and pitched on the most advanced portable court ever devised. We quickly and easily adjusted to a method of uniform play that had us pitching from "meter markers," some that were behind the stakes that were set only 33 feet apart. We pitched a format of 30 shoes and kept score on the most innovative scoreboard I have ever seen. Set in the middle of the court, this scoreboard eliminates the need for a scorekeeper and when you are through, gives points, ringers, total shoes pitched and a method to easily determine the percentage you pitched. This information is then quickly transferred to a master board that keeps the cumulative totals for 8 pitchers during an entire 8 person round-robin.

The advancements of the program don't stop with the marvelous portable court and scoreboards. It includes a Record of Performance Card on which your tournament information is recorded. The last 3 tournaments are averaged which gives everyone an accurate handicap plus a Star Rating between 1 and 5. Your star rating which equates to your pitching percentage determines your class with 5 stars being an All Pro at 75%. This ROP Card is carried in your wallet as you travel so you can always enter the proper class in any tournament anywhere. The system also provides the avenues to mix pitchers of different ages and pitching distances so all can pitch to their full capabilities.

This unique system is called PAR Horseshoe. PAR means Pro. Am Rated. It is an exciting system that could do wonders for the way we approach the game. Like anything new, however, one must keep an open mind to the benefits of change for we cannot grow as a sport if we do not grow within ourselves. I have extended an invitation to George Schummer and his associate, Glen "Red" Henton, to set up and display the entire concept of PAR Horseshoe at the Pleasanton World Tournament. Let's hope their busy schedule will permit this.

### DAVE'S COURT REPORT

I am very happy to inform the membership that the position of 5th Vice President has been filled by Mary Van Sant. Mary spent much time assisting Gene with the Regional Director chairmanship duties prior to Gene's untimely death. Being familiar with the prime areas of responsibility will benefit the NHPA and greatly assist Mary in this transition.

An April 1st insurance update found 53 Charters had paid their insurance assessment in full while Eastern Nebraska had made a good partial payment and is expected to be current soon. Only Delaware, South Carolina and Northern Utah have failed to respond, leaving their members ineligible for NHPA sanction play.

Regional tournaments are no longer an item we only talk about. The first will be held in Ponca City laer this month while the Iowa State Fairgrounds will be the site of the second Regional in late June. Each event will pay out over \$5,000 in cash prizes as pitchers from around the country sharpen their game in preparation for the 1988 World Tournament.

Speaking of the World Tournament, your registration has to be postmarked prior to June 1st. The last 3 tournaments will determine your entering average and these must be attested to by a state officer. Don't delay too long. This will be a great event pitched under cover with some \$70,000 in prize money up for grabs.

As Regional Director of Pennsylvania she has contacted some of the schools in the area and asked them to promote Horseshoes, leaving them some of our literature on the Junior programs the NHPA has to offer. The President of one of the Pennsylvania clubs, Jim Zdrale, has sustained an injury to his right arm and had to switch to his left hand. Jim corresponded with the gentlemen that requested information in the digest about such a switch. Jim should be commended for all the correspondence and help he gave this fellow pitcher. Marie and her husband are in the process of covering the bleachers at their courts and have plans to cover the courts next year.

## THE HISTORY TELLER

Some books aren't bought simply because the title just doesn't have that certain eye catching appeal. A book with a title like "The Official History of . . ." will turn most people away. (Who wants to be bombarded with a lot of statistics, no drama, no excitement?)

However, it has been found to be absolutely true that *sometimes* people do make mistakes. I know you never have . . . but if you haven't bought *The Official NHPA History of the World Tournament, 1909-1980*, by Gary T. Kline, then it's your first and probably one of the worst mistakes you'll ever make.

Why? Because Gary is a superb story teller and he takes us through our W.T. history, he weaves drama and excitement into it. I have read the book several times and each time I seem to discover something I didn't know . . . and wonder why I missed it the first time.

Here are a few gems I found the other night. Squanto was the nickname of our Vietnam fighting marine, \_\_\_\_\_, who pitched horseshoes while not on patrol . . . and that the first NHPA's 'Honary President for Life', (Maybe the only one?) was \_\_\_\_\_. The first N.Y. State Championship was organized by \_\_\_\_\_, . . . but the first state to hold a State Championship was \_\_\_\_\_. The first NHPA magazine was named \_\_\_\_\_ . . . that one year, \_\_\_\_\_ received \$10 for winning the World Championship! That there were three (yup, three) W.T.'s in a period of two years where the winner was determined by \_\_\_\_\_, not by W-L record.

In June of one year, \_\_\_\_\_ started pitching for the first time. He won the W.T. the next. A man named \_\_\_\_\_ sponsored one of the W.T.'s, failed to pay the \$1600 prize fund, police were called to stop a riot, and believe it or not, this man was later elected to the NHPA Hall of Fame.

The World Tournament was held at Soldiers Field in Chicago in \_\_\_\_\_ and 100's attended . . . even 20 year old Ralph Dykes. The first man from the EAST to win a W.T. was \_\_\_\_\_. \_\_\_\_\_ tossed 62 straight ringers against Jim Solomon, Elmer Hohl pitched \_\_\_\_\_ consecutive games over 80% in W.T. play, and the first flip pitcher to make the Championship field was \_\_\_\_\_. Starting in 1959, \_\_\_\_\_, one of our all time greats closed out his career by averaging over 80% for 14 consecutive W.T.'s.

I could go on and on but if I haven't sparked your appetite by now, it's too late. The Official NHPA History of the World Tournament, 1909-1980, is a *collector's item* because relatively few were printed . . . and when they're gone . . . there ain't gonna be no mo! Tournament managers would do winning pitchers a big favor by giving these books . . . properly inscribed with tournament data, as *prizes for all classes*.

The books (if there are any left) are available at *bargain* prices from your NHPA distributors. I highly recommend you buy yours now . . . because you'll enjoy it forever. Hopefully another volume covering the 1981-1990 W.T.'s will be published . . . and will be put together by Gary T. Kline . . . *the History Teller*.

(It wouldn't hurt a thing to include the women in a separate section of the book. Just in case you couldn't fill in all the blanks, you'll find the answers somewhere in this issue.)

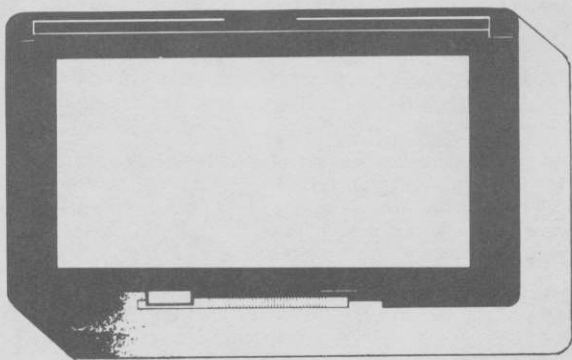

## PROPOSED CONSTITUTION & BY-LAWS CHANGES

Proposed Constitution and By-Law changes that the majority of the committee has agreed have sufficient merit to be brought before the Delegates at the 1988 Convention.

### 1. ARTICLE IV, SECTION 14, paragraph 2

Add: An annual renewal fee of \$100 shall be paid to the NHPA by each manufacturer for each model shoe produced by said company. This fee shall be paid on or before January 1 to cover the succeeding year.

### 2. ARTICLE VI, SECTION 3 . . . Change to read

If a Charter acquires ten (10) or more members up to fifty (50) members it shall be entitled to one delegate at the National Convention. Thereafter, a Charter shall be entitled to one additional delegate for each additional fifty (50) members up to four-hundred (400) members. Then one delegate for each one-hundred (100) members thereafter with no maximum.

Reason . . . To help streamline the convention for the growth of our organization.

### 3. ARTICLE VII, SECTION 2 . . . Delete the following

. . . unless he is defeated in the interim by an official recognized challenger in a title match authorized by the Executive Council with the title at stake.

Reason . . . The winner of the World Tournament has won his/her crown and title competing against the best in the world over a gruelling stretch of 23-35 games. A title match would probably be for 3-7 games or thereabouts. No way should a World Champion lose his/her title under those conditions. He/she should retain the title until defeated in the World Tournament.

### 4. ARTICLE VII, SECTION 5 . . . Change last sentence to read:

In all other ties (second place and below), trophies and prize money shall be awarded based upon percentages.

### 5. ARTICLE VII, SECTION 13 . . . Change to read

The Count-all System is to be . . .

Reason: Count-all system is the more recognized name over Point System.

### 6. ARTICLE VII, SECTION 13

Eliminate all following the words "pitching activities."

Reason: The Count-all System is a very simple and exciting format for running tournaments and should be an option at our most important tournaments.

## BY-LAWS—(Continued)

### 7. ARTICLE VII, SECTION 14, . . . Add a second paragraph to read

"All adults registering for the World Tournament must have completed a minimum of three sanctioned tournaments in the time span starting with the last World Tournament and ending with the mailing of their registration form."

Reason: The World Tournament is the epic event of the year held primarily for the benefit of the membership that have been supportive of the NHPA and their state sanctioned play. We should not allow pitchers to all of a sudden come out of the woodwork and compete without some previous show or support to the benefit of sanctioned tournaments. Most charters require some minimum of sanctioned play to be eligible for their State Championship so, why not the World Tournament.

### 8. ARTICLE VII, SECTION 16 . . . Change to read:

A city or organization desiring to sponsor and hold a World Tournament shall place its bids in the hands of the NHPA Secretary by the 15th of April. The NHPA President shall then designate one or more members of his Executive Council to open said bids after he has determined that those members have no conflict of interest in the matter. The details of such bids shall include the name/names of those who opened the bids. No bid will be considered. . . .

Reason: Neither the Secretary nor any other Council member should be put in the unenviable position of opening the bids when they work for an organization submitting a bid, or if they have a definite interest in any particular bid. In the business world, such a thing as a contractor opening his own and his competitors bids is unheard of and would never be allowed. It would be a definite conflict of interest. No business in the world operates that way. Neither should the NHPA.

### 9. ARTICLE VII, SECTION 17 . . . Omit the following words . . . except for the World Tournament. . . .

Reason: In my opinion, the Executive Council *does* conduct the World Tournament, so why is this wording here?

### 10. ARTICLE VII, Add a SECTION 19 . . . To read as follows

The qualifying rounds for each division shall be at least 300 shoes pitched by each contestant in games which are to be a maximum of 50 shoes each.

Reason: There should be some rules for the World Tournament so the players can have some idea of what to expect. We have been using a format similar to this for the last seven years.

### 11. ARTICLE VIII, SECTION 1 . . . Change entire section to read . . .

The Constitution and By-Laws may be amended at any Convention of Delegates, in even numbered years, by a two-thirds vote of those present.

Reason: Under the present method of allowing changes in any year, we are getting suggestions to change sometimes before the ink is dry on the most recent printing of revisions. It is ridiculous to foster so many proposed changes to such a small book every year. It will also shorten every other Convention.

**BY-LAWS—(Continued)****12. ARTICLE IX, SECTION 2 . . .** Omit the following words from the paragraph

Omit the word . . . World . . . from the first sentence.

Omit the words . . . from future competition in World Tournaments . . . from the next to the last sentence.

Reason: This By-Law should govern all NHPA Sanctioned Tournaments, not just the World Tournament. It would allow all play standings to be determined in a uniform manner when a forfeit must be considered. Right now, there are probably as many methods as Charters.

**13. ARTICLE IX, SECTION 6,#3 . . .** Change to

The Managing editor of the organization's monthly magazine shall receive an expense allowance of \$1200.00 annually to compensate for personal expenses incurred in the performance of his duties as long as the magazine is in existence.

Reason: In past years, we have given raises to the Executive Council, the Publicity Director, and all Regional Directors. We seemed to have forgotten our publisher and editor. Let's correct this.

**14. ARTICLE X, OFFICIAL RULES FOR HORSESHOE PITCHING . . .**

Rule 1 through and including Rule 16.

Remove all playing rules entirely from the Constitution and By-Laws and print them separately in pamphlet form for wider distribution and ease of up-date.

Reason: Playing rules, by the Constitution and By-Laws, are interpreted by the Executive Council. Rarely are changes to the rules proposed but when something needs update or a better explanation, we cannot do it because wording in the constitution can only be changed by the Delegates. This is extremely cumbersome and precludes efficient and timely additions or clarification.

**15. ARTICLE IV, SECTION 16 . . .**

Remove this section and all sub-paragraphs entirely from the Constitution and print as part of NHPA playing rules if above proposal to remove rules, passes.

Reason: This whole section reads as rules of play.

**16. ARTICLE VII, SECTION 6**

Remove this section from Constitution and print as part of NHPA playing rules.

Change submitted by Dave Loucks

**17. ARTICLE VII, SECTION 9, paragraph 2 . . .** "Playing rules for Juniors, etc."

Remove and print as part of NHPA playing rules.

Reason: Both the above sections are obvious playing rules and should be part of a playing rule pamphlet, not the Constitution and By-Laws.

**18. ARTICLE X, RULE 1 . . .** Add a part c. to read as follows

For World Tournament court layouts, the courts shall not have more than a one (1) inch change in ground level from one end of a court to the other end of a court.

Reason: The World Tournament should be played on the best conditions possible.

**BY-LAWS—(Continued)****19. ARTICLE X, RULE 2 b. . . .** Change to read

Pitching stakes for women and juniors shall be 30 feet, with a foul line three feet in front of each stake. When women, juniors or any designated 30 foot pitchers play on a court constructed for men, foul lines shall be marked 10 feet in front of the men's foul lines, parallel to, and the width of the men's platform. An imaginary stake should be marked on the ground. All 30 foot pitchers may pitch a distance anywhere from 30 to 40 feet, but must pitch from a platform on either side of the court. No 30 foot pitcher will be allowed to stand in the middle of the court.

Reason: The present rule discriminates against any junior wanting to move back as he approaches adulthood. It also discriminates against women who are pitching 40 feet in leagues or elders who jsut want to step up a foot or two.

**20. ARTICLE X, RULE 2 . . . .** Add a part d.

d. In situations where the pitcher is standing at floor level pitching onto a raised pitching area the tournament officials shall calculate the increased pitching distance created by raised peg areas and adjust the foul line accordingly.

**21. ARTICLE X, RULE 4 . . . .** Add a part d.

d. The material around the peg must be level with the box that surrounds it before the contestants start their warm-up for a contest.

**22. ARTICLE X, RULE 4 . . . .** Add a part e.

e. The material around the peg may not be shoveled during a contest unless approved by a judge. Contestants cannot mash or move the material around the peg during a contest except to repair damage done by picking up a buried shoe or damage done by the measure of a shoe. Contestants are responsible for leveling and watering as needed the court scheduled for their next game. Contestants may have someone do this job for them.

**23. ARTICLE X, RULE 4 . . . .** Add a part f.

f. Every effort must be made to keep the substance around the peg moist and in good shape to avoid bouncing ringers and sliding ringers.

**24. ARTICLE X, RULE % . . . .** Make the first paragraph a. and add paragraph b.

b. When a peg breaks during an inning, the game shall be discontinued at the end of the previous inning and the peg shall be repaired. The contestants shall be allowed four shoes each to warm-up and the game shall continue. Tournament officials may opt to hold the completion of that game until another time if scheduling dictates. Tournament officials may opt to move that game to another court while the repairs are made. A broken peg is defined as any peg not standing in the same position as when the inning started due to whatever damage.

**BY-LAWS—(Continued)****25. ARTICLE X, RULE 7 . . .** Make this addition to Section e.

All players in 30 foot classes must remain three feet behind their opponent on the opposite side of the court when their opponent is pitching. No player is to walk to the rear of the court.

Reason: This should help to speed up the play in the 30 foot classes, if this rule were passed and observed.

**26. ARTICLE X, RULE 7, section e.** Change to read . . .

A player, while not pitching, must remain on the opposite side of the stake to the player who is pitching, and at least twelve (12) inches behind the pitcher, but not more than fifteen (15) feet from the pitcher.

Reason: Some players can comply with the current rule and be in front of the pitching player. This can be distracting. Most players don't like to be confined to the opposite pitching platform and like to step back out of the way.

**27. ARTICLE X, RULE 8 b.**

Change 30 seconds to 20 seconds.

Reason: We shouldn't have rules for 2% of our members. 98% of the pitchers are within 15 seconds so why would we keep a rule for the 2% who are delaying tournaments. The NHPA doesn't need a 30 second rule which permits a small number of deliberate stallers to disrupt pitchers and tournaments. Some of the well known stallers actually have friends time them so they can get to within one or two seconds of the time limit. This is designed to bother their opponent and should not be permitted.

**28. ARTICLE X, RULE \* . . .** Add a part c.

c. A contestant must pitch his/her second shoe from the same side of the approach as his/her first shoe. A contestant may pitch his/her shoe from the approach side of his/her choice during any inning of the game as long as they are both pitched from the same side.

Penalty: The second shoe shall be removed from the court.

**29. ARTICLE X, RULE 8 . . .** Add a part d.

d. A contestant must pitch both shoes in each inning of a horseshoe contest. Penalty: Removal from the tournament and forfeiture of all prizes.

**30. ARTICLE X, RULE 8 . . .** Add a part e.

e. A contestant may switch horseshoes between innings anytime during the contest. A switch cannot be made after the first shoe is pitched, unless the first shoe pitched is broken. Penalty: Forfeiture of that game.

**31. ARTICLE X, RULE 8 . . .** Add a part f.

f. A contestant may use two horseshoes at any one time during a contest. Any use of a third or more horseshoes to carry or for any other purpose shall be prohibited. Spare shoes are to be kept in your horseshoe box or somewhere off the court.

**32. ARTICLE X, RULE 8 . . .** Add a part g.

g. A contestant pitched horseshoe which strikes an object such as a bird, dog, cat, a rolling shoe from another court, a fellow contestant, etc. shall be pitched over. A pitched horseshoe striking a tree limb, an electrical wire, or the ceiling of an Indoor Facility, etc. shall not be pitched over. Items that cannot be avoided call for a repitch, those items that can be seen and avoided don't call for a repitch.

**BY-LAWS—(Continued)****33. ARTICLE X, RULE 8 . . . Add a part h.**

h. Any horseshoe that has crossed the foul line shall be ruled a pitched shoe and cannot be repitched unless as covered by g. above.

**34. ARTICLE X, RULE 8 . . . Add a part i.**

i. A pitcher tossing out of turn shall have both shoes removed from the court. The error must be detected before the second player pitches. After the second player has tossed one shoe no penalty can be called.

**34. ARTICLE X, RULE 8 . . . Add a part j.**

j. If it is discovered during an inning that a contestant has pitched his opponents horseshoe that entire inning shall be pitched over using the proper horseshoes. Contestants need not walk back up to the original peg to continue the game. If the contestants fail to discover the error until after all four shoes have been pitched, each contestant shall receive credit for his own shoes as they lay, regardless of who they think may have pitched them.

**36. ARTICLE X, RULE 12 c . . . Change to read**

A ringer is declared when a shoe encircles the stake far enough to allow the touching of both heel caulks simultaneously with a straight edge even if the straight edge touches the stake.

Reason: This will make it much easier for everybody to determine ringers. The straight edge is simply put against one heel caulk, then run down the stake. If it touches the other heel caulk, the shoe is a ringer. This would save time in judging a ringer and make it easier for a player to measure a ringer.

**37. ARTICLE X, RULE 14 r.**

Under the Score Call Method: change the two ringers each—no score to Four Dead.

Reason: No one uses the terminology as printed in our rule book. This takes less words and the scorekeepers all know what we're talking about. A long time ago someone decided they didn't like the term "dead" to be associated with our sport. It's a term identified with our sport, when there are four ringers on the stake. We can't deny it. I see no reason to be ashamed of it.

"I don't mind. That's just about the only way most tournaments can be run. generally, there aren't enough women pitchers to make separate classes. How about you?"

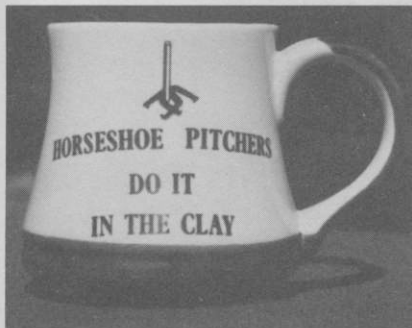

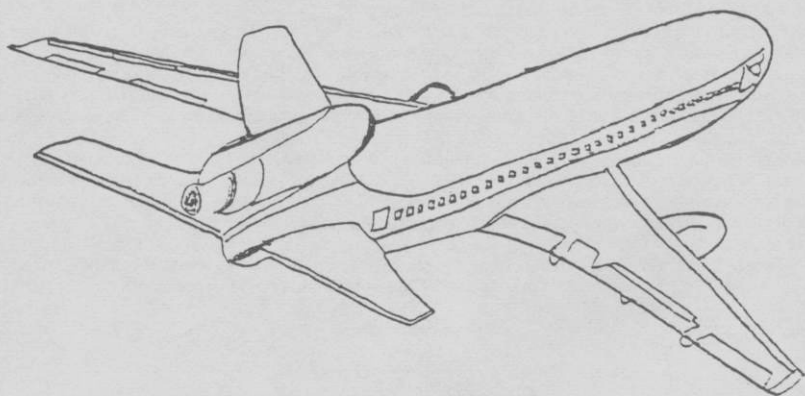

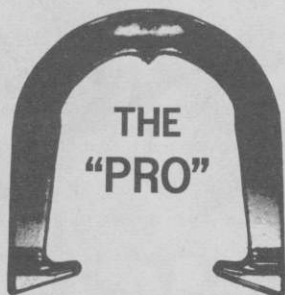
