

SECRETARY'S MESSAGE

Once again tournament time is upon us and we're beginning to get things lined up for the big show at Murray, Utah.

July 20th through the 27th are the dates. Qualifying will begin July 20th and continue through that day. As usual, if weather permits and there are enough officials on hand for proper scoring, qualifying will be permitted the evening of the 19th. Two hundred shoes will be pitched consecutively—total points will count. There will be a scorekeeper (from a state other than that of the qualifier) at each end of the court.

The high 35 men plus the defending champion will play a round robin of 35 games—7 games per day—starting at 5 P.M., July 21st. There will be no play Sunday, July 24th. On July 27th, the top four men in the 36 man round robin will play a final round robin to decide the championship.

A consolation tournament or "B" Class tournament will be played by the next high 24 qualifiers. This will probably be played the mornings of July 22nd, 23rd, and 25th. It will be a round robin tournament.

The Junior Tournament will be played the mornings of July 22nd and 23rd.

The Women's Tournament will be played the mornings of July 26 and 27.


We were extremely sorry to hear of Jake's illness and trust that he is well on his way to recovery by now.

SOMETHING TO THINK ABOUT By Al Dahlene, reprinted at the request of Walt Bagley



Walter Bagley wants to see more tournaments held in Mass. and Rhode Island. Let's wake up and have more tournaments!


MAINE

out various needed changes in Rules, By-Laws and Constitution, and offer definite ideas in The Horseshoe Pitcher magazine and other pertinent places, should not be ignored. Where else can one express himself by writing? If there is an N.H.P.A. Committee or Secretary where correspondence of this nature should be made, then this ought to be permanently indicated in our Official Organ The Horseshoe Pitcher, on some page such as the page taken in each issue by the N.H.P.A. We know from the experiences of more than one, that any effort for Rules, etc., benefit to The Game by different individuals, usually gets zero, and writing to different officers or committees on these matters gets no answer at all much of the time. This lack of consideration hurts The Game and hurts the N.H.P.A. Is the N.H.P.A. snubbish? Why doesn't it express itself in The Horseshoe Pitcher?

Such neglects as the courtesy of a reply to a letter is one of the reasons that my own State of Maine has withdrawn its association affiliation with the N.H.P.A. for the past year or two. We love our State and we want to be loyal to the N.H.P.A.

A Forum in The Horseshoe Pitcher might be a constructive and productive means to place anyone's ideas before everyone. Answers could be made by some N.H.P.A. Officer or Committee or Veep, so the earnest efforts of anyone would not be disregarded, but would get satisfactory recognition and would have some consideration. There should be tangible means of contacting the N.H.P.A. If this Forum thing would add a page or two to the magazine, there should be also a result of more interest among a wider spread of potential subscribers. And "land knows" our dear editors can welcome an added list of subscribers.

Everyone has or should have beside his own or self interests, these 5 Aims for Good: 1 His Club; 2 His State Assn.; 3 The National Assn; 4 The Horseshoe Magazine and 5 The Game. No one of these should harm or be a detriment to the other. Not one should be omitted. Each ought to build up and support the other: Club, State, National, Magazine and Game, in that order. There you are.

In May yours truly had a four-hour visit and consultation on horseshoe matters in his front room on this concern and other matters relating to The Game, without picking up a horseshoe. So don't think that you or You are the only one, who has a spirit for the good of Our Sport. It was my, and our, good friend, Herbert G. Bowman, who made a twoor three-hour drive from Hebron, Maine, to Kitterypoint, in order to spend a hopeful 4-hour counsel over the good of The Game.

Some day Maine will see the wisdom of belonging in the fold of the N.H.P.A. But in the meantime let's have the N.H.P.A. be so useful, good, necessary and downright wholesomely helpful to the lower associations, that Maine and every other state just cannot afford to be out of it. The N.H.P.A. can't afford to have Maine or any other state on the outside. We don't want Maine or any state to be a Horseshoe Orphan. So let's have the N.H.P.A. be a Good Daddy.
