# PRESIDENT'S MESSAGE

Spring is finally around the corner. Many of you have already started your horseshoe season, however, a few of us in the northern states are only dreaming of getting on the courts. I wish everyone the best as you get your leagues started and step onto the courts to pitch that first ringer for the 2011 season.

The Council would like to remind everyone of one of our Mission/ Vision goals of increasing membership. We would like everyone to assist in signing up some new members in your leagues. Membership continues to decline and it is our hope that everyone can assist by recruiting some new members. The following are membership numbers for the last four years; 2010 is 11,243; for 2009 is 11,396 (drop of 1.34%); for 2008 is 11,891 (drop of 4.16%); for 2007 is 12,063 (drop of 1.42%). Horseshoes is not the only sport seeing a decline in membership. Those of you who know me, know that I am also an avid bowler and enjoy this sport during the winter months. Bowling membership has also been declining. The Council challenges each Charter to assist in turning this trend around.

Congratulations to Amy Francis and Joe Faron II who will be inducted into the National Horseshoe Pitching Association Hall of Fame. Amy will be inducted into the category of "Player" and Joe will be inducted into the category of "Promoter/Organizer". The Hall of Fame induction will be held at the 2011 World Horseshoe Tournament at Monroe LA. Congratulations to

these two very deserving individuals.

At the 2010 Delegate Meeting, I discussed the World Tournament Financials. We felt this was important to make the delegates aware of what the W.T. has been costing the NHPA to operate. At the winter meeting, the Council discussed and came up with some changes to try and get these costs under control which Dick Hansen will be addressing in this issue of Newsline. The Council felt these changes were necessary in an effort to balance the World Tournament Account.

In another area, the Council has been researching ways to trim costs is the Newsline. The Newsline magazine costs our organization a significant amount of money. Over the past years, it has been proposed to make it mandatory for all members to have Newsline, however, it was voted down by the delegates. At this time we are not recommending any changes, however, we are seeking sponsorship to offset the publishing expense. I do encourage all of you who do buy Newsline to share the magazine with others in an attempt to get them interested in subscribing also. If any of you know of a business who would like to sponsor an ad, please contact our editor, Paula Summerlin. Last I want to remind

all the Charters at their State meeting to bring this up as an item on their agenda to discuss. We all need to do our part if we want to continue supporting this magazine. The cost of doing business has risen and the Council does not want to increase subscription fees.

The 2011 World Horseshoe Tournament will be held July 18th -30th at the Monroe Civic Center. To participate, you will need to have four sanctioned tournaments by the entry deadline (May 19th). The same pitching format will be used as last year. There are two attached facilities which Monroe plans on using. Both facilities are air conditioned for your pleasure. It is our intention to expand the electronic scoring to 24 courts for your pleasure. I look forward to seeing a great turnout as I know everyone with have a good time in the Bayou.

In conclusion, I want everyone to know that the Council is working hard to control costs and increase membership. This has been a real challenge as the cost of doing business has risen significantly. I want to assure everyone the Council is working hard and I know if we all work together, our accomplishments will be even greater.

Have fun in your leagues and I hope you have a good year of pitching!

# NEWS, VIEWS & DONATIONS

With the approach of the 2011-pitching season, the NHPF was called upon to assist two clubs with their preparation for sanctioned play. Many of us who frequent the NHPA forum enjoyed viewing the progress of seven new portable courts as construction photos were posted by Kevin Smith of Michigan. Kevin had applied for an NHPF grant for the benefit of the new Greater Detroit H.C. and the Foundation Directors approved \$1,500 for the club.

Also receiving a \$1,500 grant was the Lisbon Left Hand Club in Lisbon, Maine. This horseshoe club with 10 courts has been running non-sanctioned league and tournament play for some time. Over the past couple of years, some pitchers have joined the NHPA and the club has scheduled its first sanctioned tournament for this June. In order to get the courts sanctioned by the NHPA Regional Director, extended walkways have to be installed. For this purpose, the grant was issued.

Many years ago when I first started pitching as a junior, I had the privilege of being the houseguest of Arch & Mary Stokes during the World Tournaments of 1951, 52 & 53. It was a wonderful experience as I was treated like family. Arch, as I'm sure many of you know, was one of the seven original charter members of the Horseshoe Pitching Hall of Fame. The most prestigious NHPA award, The Arch Stokes Memorial Award, is given annually in his honor. In 1988, I was honored to receive this award during the Pleasanton, CA, World Tournament. I was doubly honored to have the award presented to me by Maureen Stokes-Cook the daughter of Arch & Mary. I had first met Maureen during my visits some 35 years before. Over the years since, we periodically exchanged mail. I was saddened to hear in March that Maureen had died during this past winter. I'm not sure, but believe she may have been the last surviving child of Arch & Mary Stokes.

During the 2011 W.T. in Monroe, the NHPF will have some nice and unique prizes available through raffle or a silent auction. Among them will be a handmade oak clock with Westminster movement and a lithograph reproduction of a 1965 Keene W.T. painting done by renowned painter, Norman Gautreau. Both of these prizes are valued at about \$400. Be sure to stop by the NHPF booth in Monroe to take a chance or bid on one of these or other offered articles.


# PUBLICITY/PROMOTION

# HALL OF FAME

In the last issue of Newsline I gave you the list of nominees that were on the ballot for the 2011 voting. I wrote my article a couple of days before the nomination deadline and said there might be a nomination come in after I sent the article. Well, that happened and a nomination came in for Gary Roberts of Ohio. He is in the Promoter/Organizer category and his name was on the ballot for the voting this year. I am pleased to inform you that after the votes were counted the committee had elected two people for the Class of 2011. There is one from each category, and they will be inducted into the Hall of Fame at the banquet in Monroe, LA in July. I hope many of you will attend the banquet and help welcome these two deserving people into the NHPA Hall of Fame. A brief history of our two new inductees follows.

#### **Amy Brown-Francis**

Amy came from a family involved in horseshoe pitching and had the good fortune to marry a horseshoe pitcher, which has enabled her to continue her pitching career. I think most of you have heard of her husband, Alan Francis. She gave Alan some tough competition when he moved to Ohio. Since 1992, Amy has participated in the Women's Championship Division a total of 17 times. She has not won the World Championship, but finished second in 2000, 2001 and 2003. She finished third in 1995, 1998 and 1999. She finished fourth in 1996 and 2002, and fifth in 2006. For the period of 1998 through 2003 Amy never finished less than fourth. She has averaged over 81% for the Championship finals three times and in the high 70's at least five times. She has also pitched some impressive games. In 1996 Amy pitched two consecutive 90% games. In 2002 she defeated Joan Elmore by a score of 42-23 and threw 105 ringers out of 118 shoes for 89%. In 1996 Amy lost to Sylvianne Moisan while pitching 100 ringers out of 116 shoes for an 86.2% game. In 2003 Amy defeated Sue Snyder by a score of 42-35 while throwing 103 ringers out of 120 shoes for an 85.4% game. I also know that she skunked Vicki Winston in the 1995 Championship Finals throwing over 87%. That's what happens when a pitcher forgets how to throw ringers, but Amy didn't forget how. She has been a tough competitor for many years and is now helping to teach the next generation of the Francis family how to throw ringers. Little Alex Francis pitched in his first sanctioned tournament last year. With two parents as talented as his, the competition had better watch out for Alex in the years to come. Congratulations to Amy Brown-Francis on being elected to the Hall of Fame. She is a wonderful ambassador for our sport and we wish her continued success on the

horseshoe courts.

#### Joseph J. Faron II

This man, who is better known as Joe Faron, has done many outstanding things for the sport of horseshoe pitching and for the Missouri charter. He was instrumental in the formation of the New Melle Horseshoe Club and by promoting more sanctioned events on the eastern side of Missouri, helped to grow the Missouri charter into the largest charter in the country at one time. It is now second largest. Some people may not know that Joe and two friends designed and sold the first Six Pac Horseshoes, before selling the company to Harvey Wobbe. Once Joe began promoting the sport of horseshoe pitching, he has never stopped. He became active on the national level and was chosen to be a director of the National Horseshoe Pitchers Foundation. He personally transported Earl and Vicki Winston and all of their Hall of Fame memorabilia to the first Hall of Fame building in Joelton, TN. Later, when the untimely death of Jack Freeman ended the establishment of the Hall of Fame in Joelton, Joe was instrumental in finding a new site in St. Charles County in Missouri. He attended countless meetings and helped to bring about an agreement that was almost unbelievable. Joe worked continuously to see that the new Hall of Fame would be something of which the NHPA could be proud. When the time came to move things from Joelton to Missouri, Joe was again involved in making several trips to bring things back to Missouri to be placed or used in the new Hall of Fame Museum and Court Complex. The New Melle Horseshoe Club, which he helped establish, became the Quail Ridge Horseshoe Club and became caretakers of the new facility. Joe continues to work constantly at the facility, often greeting visitors and giving tours. He also often uses his woodworking skills to add to or enhance the facility. Because of his accomplishments on the charter level, Joe was inducted into the Missouri Charter Hall of Fame in 1999. In 2006 the NHPA presented him with the Arch Stokes Award. It is only fitting that he has now earned a place in the National Hall of Fame for all of his time and efforts he has spent on its behalf. Joe isn't done yet. He is still working on getting highway signs approved to direct visitors to the Hall of Fame. This has been a difficult task, but some of the signs are now in place. You will also be able to find him working in the NHPF booth during the world tournament in Monroe, LA. Joe will continue to work for the sport until he is no longer able to work. Congratulations to Joe Faron on being elected to the Hall of Fame. It is an honor that is well deserved.

## 2011 WORLD TOURNAMENT PRIZE FUND

The NHPA Council has approved the prize fund for both class play and the championship divisions. I would like to point out some changes and where needed, explain why they were made. The World Tournament has for years almost always lost money and the Council felt it was time to change that. To make that happen some cuts had to be made. Not something we wanted to do, but felt we had to do.

One thing that did not change is the payout in class play. That will remain \$500 for 1st place with the top 6 in every class of 16 getting prize money. Another thing that did not change is the prize money for the champion in each division. That will be the same as last year with one exception. The Elder's have been increased for the champion up to \$2,000. Not as much as we wanted, but we just couldn't come up with the funds to support it.

This year the Men, Women and the Elders will have 16 in each division championship. This is also an increase for the Elders from the 14 in that division last year. The Sr. Men and the Sr. Women will remain the same as last year, with only a small reduction in the total prize fund for those groups.

All the junior classes are the same as last year except the Jr. Boy's. There will 8 that move up to this championship class this year and not 10. This change was made so that all the junior championship classes could pitch all their games in one shift. With 10 in the boy's it required two shifts for them and made scheduling difficult because of it. Also new this year is that all the juniors will not be seeded into the class play until right before the tournament starts. This is being done because juniors can improve greatly from May to July and should make for a more balanced class based on average.

The total prize fund for 2011 for all the Championship Classes amounts to \$47,855. I hope many of you will make the trip to Louisiana this summer and take part in this great event.

# NHPA RULES ANDBYLAWS

#### Proposed NHPA Bylaws Changes for 2011

By the deadline date of December 31, 2010, only two proposed Bylaws changes were received. In addition, two slight changes to Standing Rule #11 have been proposed, as well as a proposal that Standing Rule #16 be added to this section. For your consideration, all of these proposed changes/additions can be found below, along with reasons for these proposals. Please discuss this information with other members of your Charter and if you have any questions or concerns, pass them along to your Charter President who will be appointing your Charter delegates to the 2011 NHPA Convention in Monroe, Louisiana where voting will take place during the World Tournament. All of these proposed changes have been reviewed by our NHPA Council and we are recommending that they be approved by the Convention delegates. Here are this year's proposed Bylaws changes:

ARTICLE III: Membership (see page 2 of the Bylaws booklet)

SECTION 5. (current wording) Dues are due and payable January 1, or upon joining, and last until December 31 of the current year.

SECTION 5. (proposed wording change) Membership cards will become available for purchase from the Charter Secretaries on October 1st and will remain valid through December 31st of the following year.

Reasons for this proposed change - For some years now, it has been NHPA policy to start selling next year's membership cards before the current card expires on December 31st. This policy is mainly for the *convenience* of current members who may want to purchase next year's card early. Some pitchers living in Charters to the North may be leaving for Florida in early December, for example. In more recent years, this policy has become "expanded" a bit, allowing brand new members to purchase next year's card in October, and also to use it for remaining sanctioned events of the current year, giving them up to 3 months of free membership. Currently, these policies cannot be found anywhere in writing. This proposed change is more in line with our current policy and will allow our members to read and know about it in a more official way.

ARTICLE V: Officers (see page 4 of the Bylaws booklet) SECTION 2. Duties of Officers

a. The President shall: (add #9, as follows:)

9. Develop and implement the annual NHPA operating budget guidelines, pending approval of the NHPA Council.

Reason for this proposed addition - The NHPA Council feels that there should be something in our Bylaws stating who is in charge of the NHPA budget.

STANDING RULES (see pages 10-12 of the Bylaws booklet)

11. (see page 11) current wording: Regional Directors and Assistant Regional Directors are appointed, removed, replaced and will serve in accordance with the published guidelines developed by the NHPA 1st VP who oversees the RD program. All must be subscribers to the *Horseshoe Pitching Newsline* magazine.

11. (proposed wording in *italic print*, as follows) Regional Directors (deletion #1) are appointed, removed, replaced and will serve in accordance with the published guidelines developed by the (deletion #2) NHPA Vice President who oversees the Regional Director's program. All Regional Directors and Assistant Regional Directors must be subscribers to the Horseshoe Pitching Newsline magazine.

#### Reasons for deletions:

#1 (Assistant Regional Directors) - Assistant RD's (ARD's) are now appointed by the Regional Directors (RD's), upon approval of the VP in charge of this program. ARD's are also referred to as "Zone Directors" in some Charters.

#2 (1st) - As job/duty assignments of our NHPA Officers may change from time to time, it may not always be our 1st Vice President who is in charge of the RD program. Deleting "1st" solves this problem.

#### Proposed addition to our Standing Rules:

16. The NHPA shall provide longevity patches to those who reach 10, 20, 30, 40, and 50 years of membership. These accumulated years do not have to be consecutive or all from the same Charter. It is up to each Charter to track these years and to report them to the NHPA Secretary/Treasurer. Those who reach 50 years of membership shall be granted a lifetime membership to the NHPA and will not be required to pay NHPA dues. Charter membership dues may still be required, depending on the decision of that Charter/State Association. Benefits for lifetime members will include, but are not limited to, a lifetime NHPA membership card, and upon request, a free subscription to Horseshoe Pitching Newsline magazine.

# NHPA RULES ANDBYLAWS construced

Reasons for this proposed addition: The awarding of NHPA longevity patches has been an unwritten policy of the NHPA for many years; one which has been communicated mostly by word of mouth. There are very likely a few Charters out there that still do not know about these awards, and some pitchers who are missing out on this benefit. Adding this information to our Standing Rules should help with this important communication.

#### Proposed RGS Book Changes for 2012

It is important for all members to realize that Proposed Rules Changes will be voted on at next year's NHPA Convention at Knoxville, TN and not at this year's Convention. Based on discussions and some e-mails I've received, there seems to be some confusion about this. I have already received a fair number of Proposed Rules Changes from our membership, and expect to receive more by the deadline of December 31, 2011; the last day of this year. If you would like to submit a proposed rules change for any section of the RGS Book, there is a suggested procedure and format to use, which was provided in the last issue of Newsline. Please send your rules change proposals to Dan Sanders, NHPA Rules Chairman, via e-mail or US mail by December 31, 2011 (See inside cover of Newsline Magazine for current contact information).

From The E-mail Bag - Earlier in the year I received this e-mail question from one of our members. This situation, or one similar to it, may have happened while you were on the courts. Here are some comments on this question. In most cases, common sense should prevail in these situations. Full names have been omitted here, but perhaps you could insert a name, from your pitching experiences.

Question: I want to know if by clanging my horseshoes 3 times before I pitch, I am breaking any rules, or could this be considered any form of gamesmanship or taunting? I do not mean it that way. This has just become part of my normal delivery. Jim.

Answer: Hi Jim... In response to your question about the clanging of horseshoes as a part of your normal delivery, please consider Rule 12, Section A, page 20 of the current RGS Book which reads... "An NHPA member, while in competition, shall make no disturbing noises or movements that would distract the opponent or contestants on adjacent courts". I think that the clanging of horseshoes probably falls into this category. I have also received e-mail responses from two other members on this question, which may shed some additional light on this subject. Here are their comments:

#### Comment 1...

Just an opinion to slip in here. There may be nothing specific written about this but Dan can probably explain that it might not be the most courteous thing to do. But, to add to that, that noise can be VERY disturbing to someone who is sensitive to noise - it can cause an instant headache or ringing in the ears. So it is just much more sportsmanlike to avoid making sudden, metallic noises. I used to play a woman (a very well known pitcher) who used to clang her shoes together when she picked them up. I learned to wait to pick up my shoes until after she did that, but a few times she did it right next to my ears as I was picking up my shoes. At times, I had to wait until the ringing in my ears stopped to pitch. She just did it to get the clay off the shoes and never realized that it could bother someone. I never spoke to her about it and wish I had. So this letter strikes close to home for me and it may be something that most pitchers are unaware of. One lady in the championship division this year wore ear plugs - same issue, I am sure.

#### Comment 2...

I can attest to (the above) comments. When I'm pitching indoors, the clanking of shoes sometimes gets my hearing aids ringing, and I have to adjust them in my ears to make it stop..... very annoying at times.

#### In Summary...

The clanging together of your horseshoes is against our current Rules if it is (or seems to be) disturbing or annoying to others on the courts. I'm sure that you have probably had some comments or complaints about this? In any case, it would be best if you would eliminate this part of your delivery. Thanks again for your e-mail question.

Of course tucked into the middle of that impressive list of sports is Horseshoes. For the past 25 years, new friends and old have been getting together and pitching shoes at the Games. The Horseshoe event runs from October 10 to October 13, 2011 and offers both singles and doubles. The event is also sanctioned by the National Horseshoe Pitchers Association. NHPA membership is required. (NHPA sanction #'s 09-11-024 singles; 09-11-025 doubles. "One of the unique things about the Games as a whole," says Merrill Barney, Director of Sports, "is that our divisions for the sports are based on age and wherever possible, skill level as well. This makes the event more inclusive and allows for a legitimate chance at a medal." In 2010, over 10,000 total athletes converged on St. George, filling up hotels, restaurants and main thoroughfares throughout the city as they enjoyed the competition and camaraderie of what has become an annual tradition for so many. All 50 of the United States of America were represented and athletes from 27 different countries took the playing field as well. The Games awarded 7,895 gold, silver and bronze medals to worthy participants. 

They are always willing to try a hand at pitching some Whatever shoes. the age group may be, they are most impressed with the entire facility learning and something new about horseshoes. We were pleasantly surprised and honored when a Hall of Famer Inductee visited the facility last November. Jerry Schneider, of California, was inducted into the NHPA Hall of Fame in the year 2000. Jerry was born March 21, 1925 and

was introduced to the sport by his father and by the young age of 13 had pitched an exhibition game against Jimmy Risk. He qualified for his first World Tournament in 1959. He pitched in the Men's Championship Class ten times and had a top-ten finish twice, 1963 and 1968, pitching 80.1%. Jerry won five California State Mens Titles and eight times won the California Elder Mens Championship. It was a thrill for Jerry to see his name and picture in the Hall of Fame room and a thrill for us to meet him in person.

Like every other NHPA sanctioned horseshoe club, we recently checked our courts to make sure the stakes and pits meet the necessary specifications that are required by the NHPA. We have some 16 indoor courts which require some time to do this. With the help of QRHC members Rich Altis, Andy Folds, Ernie Brakensiek, Mike Dentsbier and Larry Langewisch they were able to complete this project in two days. While working on the pits, a visitor from Iowa, Ron Stanerson and his wife Mary Jane, arrived at the courts. Rich had met Ron at the 2010 WT when they were working on the portable pits. Ron said he could sure use some horseshoe lessons and Rich told him to stop by at the NHPA Hall of Fame facility sometime and he would try to work with him. Rich worked with the couple that same afternoon giving them some extra tips about pitching shoes. # FACTS AND FOLKLORE

By Bob Dunn, NHPA Historian

This issue we revisit an article about Hall of Fame pitcher Guy Zimmerman. While other stars of the game may have achieved more coverage in the media and in our own horseshoe pitching magazine, Guy Zimmerman was right in the thick of the mix when it came to pitching skills. During the period of 1933 through1959, there were 19 World Tournaments held with Ted Allen and Fernando Isais winning 18 of the titles, Allen winning ten and Isais winning eight. The only other pitcher to win a championship in that time span was Guy Zimmerman, who won the World's Championship in 1954. Zimmerman was inducted to the National Hall of Fame in 1967, in only the second year of the Hall's existence. This article was written by Hall of Famer, Roy W. Smith, for the April 1949 issue of the Horseshoe Pitcher, 18 years before Zimmerman's induction and even prior to his World Championship.

# **GUY ZIMMERMAN**Golden Gate's Great Guy

By Roy W. Smith, Author of "Science at the Stake"

This scene has been enacted at thousands of horseshoe clubs all over the United States: A large crowd is present at a group of horseshoe courts. A few pitchers are tossing shoes on some pegs. One court has been carefully spaded up; the clay watered down and packed smoothly around the stakes. No one is playing on it for it is being reserved. The players and spectators wear expectant looks on their faces and an excited murmur runs through the crown. A poster on a wall of the club house announces that Guy Zimmerman, World Famous Trick and Fancy Horseshoe Pitcher is to stage an exhibition here on this date. Then follows a list of novel and entertaining stunts, many of which are extremely dangerous to Mrs. Zimmerman who will assist her husband with the act.

Suddenly, there is a burst of cheers and handclapping as someone shouts: "Here they are! Hi Guy, you old cuss! Have you come to take some lessons from us?" Other similar affectionate greetings are sung out and a lot of handshaking takes place. Mr. and Mrs. Zimmerman then begin to unload hoops, blankets, bottles, a stool and other assorted paraphernalia from their car. They make a very attractive couple, attired in their red shirts and dark slacks. Guy is about 5 feet 10 inches in height, of a slender build, with a tanned face and a friendly lopsided grin. Grace, (Guy's boss) is a rather small, comely woman with a nice smile and a merry twinkle in her eyes.

While Guy warms up to loosen up his arm and get the lay of the court, one of the leaders in the club introduces them to the crowd and enumerates a number of Guy's pitching records, many of which are the best in the world. After warming up with a few practice shots, Guy unusually begins by playing a match with one of the local players. Guy pitches blind over a blanket that is taken down to allow his opponent full view of the pegs. Zim wins well over 75 percent of these games. Then he proceeds to amaze his audience with such stunts as striking and extinguishing matches, throwing ringers around bottles, cigarettes, the legs of a stool on which Grace is sitting and ringing the stake while she rests her chin on it. Then he hurls a 21/2 pound shoe to knock a paper bag off her head. The shoe clears her head by only a few inches and the bag is gone with a whoosh as the shoe clicks home around the stake. Then he turns loose with a blizzard of ringers in pitching over her reclining body, through hoops, and makes the old mare's slippers do virtually everything but talk.

These are but a few of the stunts that Guy the Great has in his bag of tricks, for he is one of the greatest pitching machines living today. I have often wondered if he wasn't born with a horseshoe in each hand and I have seen people, who are unfamiliar with the game, gasp and refuse to believe their eyes as they watch in action. I know that I almost fell over with amazement when I first saw him in my hometown of La Grande, Oregon back in 1932. Several of us who had just taken up the game traveled 50 miles over steep, crooked mountain roads to see Zimmerman, C. Jackson and their wives do their stuff that night. Jackson was the clown

in the act and Zim furnished the fireworks. I'll never forget that exhibition there under the lights of the police and fire department courts.

The next time I saw Zim was in June 1939 when he and his wife and two youngsters again paid visit to Eastern Oregon. I met them in La Grande and helped them with their exhibition there; also in Elgin where I was working in a sawmill and in Wallowa which was then my hometown some 30 miles on up the branch line. "The Old Master" looked bad then and had lost a lot of weight because he was suffering from a stomach ailment. But this did not seem to affect his ability to toss ringers. I still have the newspaper clippings stating that I pitched 76.6% ringers and the most I could get was 37 points. In a game at Elgin, I tossed 65% and only scored with three pitiful points! Guy threw 45 ringers out of 50 shoes in that game and I was lucky to even get on the board.

A full account of Guy's brilliant pitching career would make a good sized book so I won't attempt to list but a few of his outstanding records. He is so well known throughout the horseshoe world that his name is a byword among millions of fans who are thoroughly familiar with his exploits. In 1940, at the World's meet at Des Moines, Iowa, Guy made the greatest bid on record for the championship of the world. He and Ted Allen hung up a record smashing performance that still stands as the greatest game ever played in a National Tournament. A full account of this is described in my instruction book "Science at the Stake." In this same meet Guy averaged 86.1% for the entire tournament of 31 games, which was another worlds record that stood until it was broken by Casey Jones last year (1948) at Milwaukee. But not to be outdone, Guy hung up another record last year too. He pitched the only perfect game in National Tournament history by tossing 44 consecutive ringers to keep his opponent, Henry Pergal from scoring a point.

Formerly champion of Iowa, Guys hails from Sac City and has been pitching in the Nationals since his early teens. For the past 12 years he has been one of the top three contenders for the World's title, but it has eluded him by just a point or two on several different occasions. For the past several years he has lived here in California and has held the state title since 1942. The past two years he has defended this title against the onslaughts of Fernando Isais, the World's Champion and Eddie Packham, champion of Southern California.

After an operation a few years ago for his stomach ailment, Guy is now the picture of health. He has just turned 40 and is right in his prime. He is fully capable of winning the world's crown, which has eluded him so long, and he may do it at the next National Meet. Like so many others, Guy's marriage failed to work out but he is now happily married and living in the little town of Alamo which is not far from San Francisco. Guy is a plumber by trade and the letters M.P. after his name mean "Master Plumber" and "Master Pitcher." He leads the large Golden Gate Horseshoe Club of San Francisco and this fine group of Golden Gate boys are justly proud of their "Great Guy."

In the Spring of 1947, I visited my good friend Harvey Clear at Santa Cruz which is some 75 miles from San Francisco. Harvey was then President of the Northern California HPA and is now Secretary-Treasurer of the N.H.P.A. Guy drove down from Alamo and spent the night with us and the next day, which was Sunday, we visited the Golden Gate Club. I never saw such a bunch of fellows and such a live wire club. Although I was a sick man and half dead due to bad teeth, thoroughly enjoyed every minute of my visit. That afternoon a bunch of us crossed the huge Oakland Bay Bridge to Berkley and attended a picnic to watch Guy do his stuff. Last fall, Guy and Grace attended the Southern California Open Championship Tournament, held at Pomona. They played exhibitions on their way down and back. Guy won second place in this meet losing only to Fernando Isais, the World's Champion.

Guy is a colorful and flashy showman and I rate him as being the finest show and stunt pitcher in the world. He is a familiar figure on the firing line in the National Tournaments and consistently pitches one of the highest ringer percentages in the world. For the past year the Zimmerman's have been sponsored by the Acme Brewing Company of San Francisco and their famous pitching act is the highlight at most of the leading Fairs and Sports Shows here in California.

In all the years that I have known Guy Zimmerman, I have never seen him lose his temper; nor have I ever heard him boast or alibi about winning or losing a game. Win or lose, he always displays a splendid brand of sportsmanship. He is a rather quiet fellow with a kind expression in his eyes but he is full of the devil and good clean fun when you really get to know him. Yes, he is a great 'Guy' on and off the courts.


