## PRESIDENT'S MESSAGE

On behalf of the NHPA Council, I hope everyone had a Merry Christmas and are enjoying the New Year! As we begin the new year, the NHPA Council would like to once again remind the Charter Officers about one of our goals, which is membership growth. Dick reported to the Council another decrease in membership the past year. Membership numbers dropped from 11,243 in 2010 to approximately 10,399 in 2011, however, those numbers may go up slightly. I want to encourage "everyone" to do their part and sign up a friend or two. You could not find a better sport to participate in for the cost!

The NHPA Council will be holding our annual winter meeting January 13-14, 2012 in Knoxville, TN, which is the host site for the 2012 World Horseshoe Tournament. In conjunction with this meeting, Jerry LaBrosse and Tina Hawkins will also conduct their site visit with the Knoxville CVB and Convention Center personnel. Some of the main topics on the agenda to discuss include: 2012 NHPA Goals, 2012 Financial Budget, World Tournament issues, Membership, Software update for HS Master/Scoring, and new Publicity and Promotion ideas.

The NHPA Council has approved expenditures for upgrading the Hall of Fame Viewing Booth. The new equipment will be installed early next year by our Natstats Director Rob Hagman. The recommendation for this upgrade was brought to the Council by the NHPA Hall of Fame Committee. I want to thank everyone for their efforts to make this happen.

Bidding status for the 2014 World Tournament consists of interested parties from Charleston, WV, Fargo, ND, Jackson, MS, Pleasanton, CA, Mobile Bay, AL, and the State of Missouri. To date, we have received no signed contracts; however, the parties have until March 15, 2012 to submit their bid packages to the NHPA. York, PA will not be bidding this year because of scheduling conflicts; however, they have reported it is their intention to bid again for hosting it in 2015.

Each year the NHPA recognizes members for their contributions to the NHPA, their Charter, and/or local club. The Council is asking all the Charters to provide a list of individuals who you believe would be a candidate to receive an NHPA Achievement Award. These awards will be presented at the 2012

World Tournament in Knoxville, TN. To obtain a form, visit our website at www.horseshoepitching.com

The NHPA is also looking for your assistance in providing candidates who you believe would qualify for the NHPA Hall of Fame Award. Candidates for this prestigious award must have been an NHPA member for at least ten years and may qualify based on their distinguished outstanding performances in World Tournament Championship play or as a person who has made significant and beneficial contributions to the NHPA. Nominations for this award should be submitted to our NHPA Hall of Fame Director Vicki Winston. This form is also available on our website.

The 22<sup>nd</sup> World Congress of *The Association for International Sport for All* (TAFISA) was held at Antalya, Turkey November 10-14, 2011. As part of growing our sport of horseshoes internationally, the NHPA asked Gary Roberts (President: USA Jukskei Association) to attend this conference. Gary was pleased to announce the countries of Japan, Mexico, and the Netherlands expressed an interest in pitching horseshoes. He also reported that Namibia will be attending our World Tournament in Utah in 2013. This is exciting news and we look forward to seeing these folks in St. George, UT!

I would like to remind everyone that elections are open for the positions of 2<sup>nd</sup> VP, 4<sup>th</sup> VP, and Secretary-Treasurer. In accordance with the By-Laws, candidates for an NHPA office must announce their candidacy in writing no later than February 1, 2012. Announcements are to be received by the President and the Horseshoe Pitching Newsline Editor. I encourage anyone interested to announce their candidacy prior to the deadline.

Just a reminder for people looking at attending the 2012 World Tournament in Knoxville, TN to begin making your plans and getting your reservations made. Additional information regarding the World Tournament is already on our website.

## NHPF NEWS VIEWS & DONATIONS by Dave Loucks

We again start a new year with high hopes that it will be better and more prosperous than the previous. For the NHPF, member contributions during 2011 did not rebound from the low \$25,666 achieved in 2010. In fact, total 2011 income from contributions and brick orders has fallen to an all-time annual low of \$15,780 as I write this during the first week of December.

It's no secret that only about ten percent or less of members in the average club volunteer to hold office or do some work for the club, but what about the other ninety percent? You would think that at least some of those who choose not to volunteer could at least send in a small donation to help support the association. We all realize that the economy is poor, but there are a bit more than 11,000 NHPA members who should be interested in helping their association grow and prosper.

In the past twelve months only 146 contributions and/or brick orders were received from a total of 107 members. clubs or charters. Of the 70 bricks that were engraved during 2011, 15 were purchased in late 2010 and just 55 in all of 2011. Of the 107 who donated or purchased a brick, 26 were first time contributors. That left 81 previous donors who sent in 120 checks between them.

Please study the annual list of "How Your State Ranks" which is included in this issue. 55% of all 2011 income contributed by members came from just five states, California, Missouri, Minnesota, North Carolina and Oregon. It is a sad fact that only ten donations were received from a combined total of 27 states. Not much need to mention the states as only two are among the top 20 on the list. The other 25 are all among the bottom 30 states. While it takes a lot of mutual support, both work and financial, to hold a World Tournament, it was disappointing that not a single donation check came from members or organizations in the states hosting the 2011, 2012 or 2013 World event.

Many of us live and pitch in communities hard hit by the poor economy. Cities are cutting back budgets for recreational park expenses. This often has an adverse effect on the plans of horseshoe clubs who want to update their pitching courts. Such has been the case with four clubs who received NHPF grants in 2010. All found that the expected community financial support had evaporated and with it, their court improvement plans were put on hold. Clubs in Clarence and Warsaw, MO. Klamath Falls, OR and Winter Haven, FL all returned the grants the NHPF had given them in 2010.

Let's all strive to give more support to our club, charter and association in 2012. A few individuals can't do it all. Promote the NHPF in your club and charter newsletters. This is your Foundation but without financial support, giving back becomes more difficult. ## PUBLICITY PROMOTION by Tina Hawkins

In some regions of the country, there are ample opportunities to pitch horseshoes at indoor facilities, even through the coldest, wettest, most inclement weather. However, for many Charters, horseshoe pitching comes to a stand-still during the winter months.

If you are in one of those latter areas, there are other ways you can keep your club alive during the "off" season.

Organize a "group trip" to the Hall of Fame pitching facility or some other indoor pitching arena within reasonable driving distance. Rent a van and split the cost. With half a dozen or more attendees, the cost per person will be minimal, you can share the driving, and you will have the opportunity to pitch in an indoor winter tournament, as well as enjoy the fellowship of your club mates!

If you prefer to stay close to home, winter is a good time to conduct a score keeping seminar. Now, in addition to teaching on paper, you will be able to download HSScorekeeper and instruct your fellow pitchers in the art of ELECTRONIC score keeping. A 3-hour workshop centered around the lunch-hour will give time for the paper method, a break for pot-luck lunch, then a round of computer training.

You may also want to gather for a viewing of the many horseshoe pitching instructional videos that are available through Game Related Sales. What better way to stay connected with the club than popping some popcorn and discussing the tips and pointers found on these great DVD's! You can view "The Basics of Horseshoe 'Pitching" by former NHPA President, Dave Loucks, or you might choose "How to Pitch Horseshoes" by six-time World Champion, Walter Ray Williams, Jr.

Be sure to invite "non-pitchers" to your classes and video nights. The camaraderie may be just what it takes to get them to come out for pitching when your season starts back up!

If you are fortunate enough to have access to indoor courts, hold a horseshoe pitching clinic. Be sure to advertise - by word of mouth, newspaper, radio, flyers,

and even church bulletins! You will want to have plenty of "experts" on hand to help with demonstrations and to answer questions. It would be good to begin with a brief demonstration of basic horseshoe pitching, scoring and etiquette, then let the participants take the courts while your club members watch and give guidance and pointers. Have lots of spare shoes on hand as well as information on where to buy and how to join the NHPA.

This would also be a great time to contact your local Parks and Recreation Department to discuss installing a set of courts, if you don't already have some. Remember, the NHPF awards grants to aid in the construction of new facilities on public land. The application for this grant can be found by visiting the NHPA website, www.horseshoepitching.com and clicking the NHPF link from the menu on the left.

It is not too early to begin the ground work for your "Horseshoe Pitching is FUN!" event in May. Scope out your area and find a nice level, high-traffic area that will allow you to set up one portable horseshoe court.

A shopping center parking lot, or outside the ball park when spring ball season starts up are both excellent locales. You never know if they will let you unless you ASK!

Don't forget about spring carnivals and even craft shows - how many husbands have been bored stiff following their wives around a boring craft show?? Wouldn't it be great if you could go outside (or in an un-used exhibit hall) and throw a few shoes with the other "tag-a-long" hubbies?

No matter where you hang your horseshoes, there is SOMETHING you can do yearround to keep your club and our sport alive! All you have to do is - JUST DO IT!

Please, drop me a line to let me know what you ARE doing to help promote and grow the NHPA and the sport of horseshoe pitching. Sharing YOUR success stories could help OTHERS achieve the same results.



## SANCTIONED CLUB/LEAGUE REPORT by David Sidles

As the newest member of the NHPA staff, I would like to start with a brief introduction and some background information. My name is Dave Sidles. I was elected at the 2011 World Tournament delegate convention to succeed Lorraine Sternberg as NHPA 3<sup>rd</sup> V.P. As such, I will be assuming the duties of National Sanctioned League/Club Director.

My first introduction to any type of organized horseshoes was with a sanctioned league in Iowa. One of my softball teammates, who was already pitching, asked if I could sub on their team one night. I told him I had never pitched "real" horseshoes before. His response was, "doesn't matter, you'll have fun." He was right. By the end of that first night I had purchased two pair of Ohio Pro shoes from a retiring pastor on that team and played in that sanctioned league for the next 17 years. I was the league director for several of those years and became familiar with the membership and stats reporting and also the associated Top Ten program.

The Central Iowa Traveling Horseshoe League, first organized in 1979, is still sanctioned and continues to be well represented at the Iowa State Fair team championships. I am very proud to have participated in this league and hope to see it continue for many more years.

I also served as IHHPA Sec/Treasurer and statistician for four years and was involved in administering the first medical exemption in the Iowa charter.

In the summer of 2006, several circumstances came together all at once that prompted a move to Omaha, Nebraska. On the way over from Iowa, I got on the NHPA website and found the link to the Nebraska website to see if I could find anyone or anywhere to play horseshoes there. As it turned out, Steve Barry, the ENHPA Secretary/ Treasurer lives in Omaha, so I called him from the car. I introduced myself and asked if there was a way to get involved in horseshoes in the Omaha/Council Bluffs area. He said "Can you play tonight?" That started my involvement with the Greater Omaha Horseshoe League. With many outdoor court locations and a small indoor facility, we play year-round here. There are also several other leagues in this area during the summer. All of them, however, are non-sanctioned, so I guess I already have my work cut out for me here.

My first semi-official duty was assisting Lorraine at the National Sanctioned League/Club Tournament in Wentzville last October. What a wonderful weekend! It was a pleasure working with Lorraine and her husband Terry, as well as all the members of the Quail Ridge Club. If you play in a sanctioned league, I would highly encourage you to think about entering a team in this annual event. The Hall of Fame facility is one of the finest places you will ever pitch horseshoes in and a visit there should be on every horseshoe pitchers "bucket list".

If you are a league/club director, don't expect too many drastic changes to the way you've been doing things right away. I've been using computers since the days of the first Perfect Secretary bowling program and dot matrix printers. I prefer e-mail as a primary way to communicate and submit reports, but I realize not everyone does this. What's important is that the right stuff gets done and sent in at the right time. I also will do my best to make sure that's getting done on my end. Most important is making sure your league/club players are getting the awards and recognition they deserve.

Also, if you have juniors pitching in your sanctioned league or you help with a Sanctioned Junior League, please be aware of the NHPA Junior Scholar awards program. This program is fully explained in the Red Book and also on the NHPA website. Make sure your kids get the recognition they deserve for the efforts they put in on the courts and in school.

Don't hesitate to contact me with your concerns, questions, or suggestions. I'm looking forward to the challenge ahead.

## REGIONAL DIRECTORS REPORT by Debby Michaud

There are more new Regional Directors to report. After serving one year as RD in Iowa, Bert Logsdon resigned his position and a new RD was voted in; Mr. Vern Kollasch, we welcome you as the Regional Director in Iowa. Vern has already contacted me with some good questions showing he is definitely connected! Another new RD is taking the reins in Texas. Jim Anderson has served there for many years and will continue as an Assistant to the new RD, Mr. Coyce Allen. Mr. Allen has also asked many questions and that is very reassuring to me! Thank you to Jim Anderson and to Bert Logsdon for their service — the transition already seems seamless and that is, in part, due to Jim and Bert.

#### New Club to Report.

This has been written about before, but this new club is now a reality. Peter Zepponi first contacted North California Assistant RD Casey Sluys by phone in 2008 telling him that he was going to resurrect the horseshoe courts at Golden Gate Park in San Francisco (these courts were originally constructed in 1922). They put a link on the Northern California website so people that were interested could follow Peter and his progress in rehabbing these courts – it is: <a href="http://www.sfhorseshoepitching.com/">http://www.sfhorseshoepitching.com/</a> After 22 years of neglect, there was much to do with the property, but Peter persevered – he ran unsanctioned tournaments there for a few years and had some help from a group called the Guardsmen. He held their first sanctioned tournament there, which was an invitational and consisted of World Champion Brian Simmons, State Champions Kimmy Stockli and Rick Bermingham, Elder pitcher Dave Loucks and Junior Travis Sluys. It was a five-person round-robin just to showcase what a sanctioned tournament was about. This occurred in October 2009 and proved to be a very successful effort, as they are now an official NCHPA club.

On October 22, 2011 Peter, in conjunction with the Half Moon Bay Club, hosted a successful sanctioned tournament on the SF Club courts. They will be listed on the schedule for 2012 and are now a new club with 16 sand courts. Even though they still need some work done on their pitching pads, and even though they only have about ten members right now, they are a sanctioned club. Welcome Peter, thank you and good luck!

Thanks to Casey Sluys, RD of N.CA, for this report

The patch orders are going out at a good rate – more than half of them are done and I can see my upstairs hallway again! My only concern is that charters who have tournaments in January might not request their patches on time to have them for their first tournament. Don't "fergit" to order patches on time! So far I am sending out fewer patches than last year but there were many unused patches returned from 2011, partly due to the very unusual weather that occurred in many

parts of the country. I hope that we will need MORE patches in 2012 because of increased entry levels – if any of you need extra patches for add-on tournaments or higher entry numbers, just e-mail me; I can usually get them out the next day.

We do appreciate the notes and calls that we receive from pitchers all over the country. Many of them are critical of conditions in their area or of the way a tournament was run. Although the NHPA board does not have full control over all of this, we do have control if NHPA rules are not being followed. I hope that all of you have a current RGS (NHPA Rules, Guidelines, and Specifications) booklet. If you do not, please contact one of your state officers. If they do not have enough RGS booklets for each club and for each officer, then they must contact the NHPA Secretary/ Treasurer, Dick Hansen for more. AND we do want those notes and calls to continue – we DO try, from afar, to help expedite improvements. We WANT the pitchers to be happy with their tournament and league experience.

One of the little controversies was; do Regional Directors have a vote in their state Executive Board meetings? Since many RD's are wearing more than one "shoe", those RD's are automatically a voting member of their board. However, in most charters, RD's are appointed and not elected. Because of that, according to NHPA Constitution Article VII, they will NOT be allowed to vote in their Executive Board meetings simply because they are an RD. Since the Regional Director has his or her hand in SO much of what goes on in a charter, I do believe that they should have a vote - so maybe Regional Directors should be elected OR an allowance should be made for the Regional Directors to have a vote in their charter's Executive Board. Just my opinion but there it is! Something to discuss in your next meeting. Write to me if you disagree or agree and give me good reasons for your opinion - you can make a difference!

Also, there is a slight addition to the Regional Director Guidelines as found on the NHPA website. We just added the need to re-sanction courts every four years as one of the requirements. It was understood, but not written so we corrected that oversight. On that note, THANK YOU to all of the RD's who have worked hard this year to re-sanction courts. Those of you who are new and may have to "catch up", we understand. Those of you who are still finishing up, we understand that, too. Again, the MOST important things are that the pitchers are happy, have a good competitive experience, are safe at each set of courts that they visit and that the courts are consistent and within specifications.

By the time you read this, it will be 2012. Hopefully you had a wonderful Christmas or Holiday season and are looking forward to a wonderful New Year. See you in the New Year!

Daisy Chapelle Oregon

Daisy Chapelle, the wife, mother and mother-in-law of NHPA Hall of Famers Cletus Chapelle, Barry Chapelle and Vicki and Earl Winston passed away on November 10, 2011. She was 95. Daisy's involvement with the NHPA goes back to the 1950's when the World Tournament was held in Murray, Utah. During that span, she served as tournament helper and statistician for Elmer Beller and Archie Gregson, who were the NHPA secretaries in that time period. She even pitched a couple of years so that there were enough contestants to have a women's class.

In the 1970's through the 90's, she worked with Barry compiling Oregon tournament results and typing them up for the NHPA News Digest and the Oregon Ringer Review. A Life Remembered ... Willard Mabry, Sr.

It is with great sadness that the MDHPA reports the passing of Mr. Willard Monroe Mabry, Sr. on November 2, 2011 at home with his beloved wife and family. He was born July 16, 1933 in Amelia, Virginia. He was the son of the late Blanche Nagao and Ernest Mabry. He is survived by his loving wife of 57 years, June Mabry; two sons Willard Mabry Jr. (Rocky) and wife Linda, Frank Mabry and Debbie Jenkins; grandchildren, Justin, Brandon, Daniel, Kari and Kimberly.

His family moved to Maryland when he was four years old. He spent summers on his grandparents' farm in Amelia. While there, he learned a lot about farming. He was amazed at how hams were cured hanging in the barn and how tobacco was raised and cured.

He joined the US Marine Corp in 1952. He was sea-going aboard the Newport News, departing from Norfolk, Virginia January 6, 1953 for the Mediterranean: French Morocco, Algeria, Italy, France, Greece, Istanbul and Turkey. August 27, 1953, he was underway for the Caribbean: Virgin Islands, Puerto Rico and Cuba, followed by another tour in the Mediterranean in 1954. He was honorably discharged May 11, 1955. He was a longtime and dedicated member of American Legion Post 191.

For fun, Will learned to pitch horseshoes at age eight, using a regular horse's shoe and a stick of stove wood stuck in the ground. He's been pitching ever since. He joined the Frederick Horseshoe Club in 1988. He was kind, enthusiastic and encouraging, always with a joke to share. He enjoyed pitching and the friendships he made so much that he inspired son Rocky, and grandchildren Kari, Kimberly and Danny to join him. A true sportsman (and Sportsmanship was just one of many awards he received), he was always willing to help out whenever needed. June joined in on many occasions, assisting in the concession stand during tournaments. Horseshoe pitching was truly a Mabry family affair! Will was a great leader and in the 90's, served as the Frederick Club and Maryland State HPA President for six years. In 2010, Will's dedication, success in and many contributions to the sport were recognized when he was inducted into the MDHPA Hall of Fame. He continued to be very active until being diagnosed with mesothelioma and hospitalized several times. He served as the Frederick Club Co-President in 2011 and hoped to resume pitching. He also pitched in the Senior Olympics, earning eight gold and four silver medals.

Will was an avid duckpin bowler. He served as President of the Tuesday Night Men's Independent Bowling League at Mt. Airy Lanes since 1983. Twice, he achieved the highest award given to a duckpin bowler.

A member of Calvary United Methodist Church in Mt. Airy, he worked on the building committee, was a greeter and usher and assisted with other social activities.

Many pitchers throughout Maryland and surrounding states were blessed to have known Will and will miss his smiling face and jovial laugh on the courts. Our hearts go out to the Mabry family. We share your grief and are comforted in our assurance that he is now at peace and smiling down on us. Will Mabry, Sr., we will never forget you!

The good news was the heat wave in Missouri had broken and it was a great day to receive all visitors.

As the gentlemen from the Friendship Village in Sunset Hills stepped off their bus they were greeted by QRHC members to come in and enjoy the National Horseshoe Pitchers Hall of Fame facility. One of the first questions I always ask is "How many have every played the game of horseshoes?" Most of them shook their heads that they had played a few games during their lifetime. Another gentleman told me that he had belonged to a horseshoe club at one time. "Really," I said, "What club would that be?" He answered, "The Greater St. Louis

Horseshoe Club." "And what would your name be?" I asked. "Dick Cotter," he quietly replied.

Dick Cotter - a voice and face from the past that I did

not recognize! Dick was born (November 17, 1919) and raised in Washington D.C. When he was about 12 years of age, Dick would often go to a park located behind the White House to play. He would see a group of older boys there pitching horseshoes. They would not let him join in because he didn't know how to play well enough. He went home and asked his Dad to put up some

stakes. He spent many hours of practice; determined that he would get good enough to beat the older boys. And when he mastered the game, he went back to the park and challenged the boys each at ten cents a game. They met his challenge, and lost! Dick went home with a pocket full of dimes and never went back. Determination! Doing it his way to prove a point!

After graduating from a prep school in Washington D.C. in 1937, Dick enrolled at the University of Maryland. In the middle of his junior year Dick received his greeting card from President Roosevelt being drafted into WWII. In October 1941, Private Cotter, age 24, entered the U.S. Army serving with the 26th Infantry Division, 101st Field Artillery Battalion, Headquarters Battery. After receiving basic training in Macon, Georgia, Dick would soon find himself in the thick of world war action in France and in Belgium. On December 16, 1944 - January 31, 1945 he was engaged in the Battle of the Bulge under the direction of General Patton. He survived this bloody massacre being injured which earned him the Battlefield Commission, the Purple Heart and numerous medals for his heroic service to his country. He remembers a period of 48 days without taking a shower. Today he suffers with permanent hearing loss due to the sounds of heavy bombing and suffers the effects from frost bitten feet during the cold icy conditions of the war zone. "I don't know how I ever got out of there alive," Dick recalls. Determination! Doing what was necessary to survive.

Second Lt. Cotter was released from service in January 1946 at the age of 29. He returned to college as an architectural student. He met his wife, Violet, and they were soon married. After 20 months of college, Dick found it necessary to find employment due to the coming of their first child. Determination! Accepting his family responsibilities.

Dick was employed by the Federal Government with the Coast and Geodetic Survey in Washington, DC, as cartographer in 1948. He then transferred to the Defense Mapping Agency at St. Louis in 1957 where he retired from in 1978. By this time Dick and Violet were the parents of two daughters and two sons, one of whom served in the Vietnam War for four years. After the children were grown and married, the couple was free to pursue their dream of travel. They traveled through 48 States and in Canada. Determination! After fulfilling his family duties, now some time for a little R&R.

In 1982 they wintered in Mesa, AZ where he became involved again with horseshoes. Returning back home he saw some impressive horseshoe pitchers playing at Carondelet Park in St. Louis and quickly joined the Greater St. Louis Horseshoe Club and the NHPA where he held membership for 19 years. The STL Club was

the oldest sanctioned club in Missouri in 1980 when it was organized. After pitching outdoors for eight years, the club received permission to build some indoor courts at the Gardenville Community Center for a rental fee of \$100 per month. They would install three courts in each of the two gyms on the lower floor. The club would prosper to over 250 members. They would host many tournament events at this facility. Horseshoes became a full-time activity for Dick serving as Vice President, Secretary and President through the years. He was also elected as Missouri State 314 Regional Director for Eastern Missouri serving three years. Determination! Fulfilling leadership duties for his horseshoe club and state charter!

Dick became an excellent horseshoe pitcher during this time as he became Missouri's State Elder Champion in 1994 defeating another great horseshoe pitcher, Lou Rector. He qualified to pitch in the Six Pac Invitational Tournament held annually in New Melle. Determination! The young soldier's fighting spirit returned as Dick won his State Championship Title and many other victories on the courts.

In January 1993 Dick founded the Veterans of the Battle of the Bulge, "St. Louis Gateway Chapter." He was elected Sergeant-at-arms. He would attend many of these reunions visiting old army buddies sharing war stories that only they knew the full meaning of.

After the STL Club folded, we lost tract of Dick Cotter. His wife and a son would pass away. Dick fell injuring his hip and would move into The Friendship Village where he now resides at the age of 91.

Dick Cotter – a voice and face from the past but well remembered. It was a tearful reunion for each of us at the NHPA Hall of Fame facility. A reminder of what this man has stood for throughout a lifetime - sheer determination and faith got him through all his trials and triumphs.

A lifetime of lessons learned. You will find Dick's brick in the Missouri section at the Memorial Brick Walkway. This is what the NHPA Hall of Fame is all about. Not only for present day pitchers, but all those of the past - how grateful we are to have this wonderful facility and that they can come to visit as often as they please. #### A Town Got Its Name By the Outcome of a Game of Horseshoes

This story is told through a newspaper article from the sesquicentennial edition of the Gasconade County Republican (July 2, 1997). The newspaper was provided through the efforts of Joe Faron, 2011 NHPA Hall of Fame inductee. Joe is one of the more active members and tireless workers of the Quail Ridge Horseshoe Club, which operates and maintains our NHPA Hall of Fame Museum and Arena Complex. Joe Faron is primarily responsible for the Hall of Fame coming to its present location and he has been working at the site ever since. Joe, a long time member of the successful New Melle Horseshoe Club, (in fact he was the founding member of the club) saw to it that the club moved to the new facility and become the Quail Ridge Horseshoe Club. Joe was presented the Stokes Memorial Award in 2006. He is also one of the original founders of the Six-Pac Horseshoe Company and has served many years as the co-director of the prestigious Six-Pac invitational Horseshoe Tournament, which has been held each spring in the Hall of Fame Complex.

#### Horseshoe Match Decided Naming Of Owensville

Ed Luster Actually Won the Game, but Gave His Friend Owen A Place in History By Tom Warden

Many cities have been named in strange fashion...but in all these United States; Owensville is probably the only city, which owes its name to the outcome of a game of horseshoes.

It was possibly a summer day in 1947 – no one knows for certain the exact date – when Francis "Frank" C.W. Owen and Edward Luster met for a game of horseshoes.

Luster owned and operated a blacksmith shop where what was then Springfield Road and the Iron Road.

Owen was in his early 20's when he arrived in the small settlement and operated a general store on a site later known as the J.E. Bryan home before it burned a number of years ago.

The town was just a wide place in a dusty road in those days and a relatively few buildings were scattered about the flat prairie land. The Iron Road snaked its way into the vicinity from the south; Springfield Road came in from the northeast.

Owen and Luster – among the first businessmen in the settlement – probably were close friends and met behind Owen's store frequently to play horseshoes. Luster, who possibly had a financial interest in the store, was married and 15 years older than Owen, at the time a bachelor.

But on this day in 1847, the outcome of the game was to occupy a page in local history. Whether the two set out, as legend suggests, to name the settlement so Owen could apply for a post office at his store, or if the game was played in jest, is not known.

Luster, a blacksmith who was as good at pitching horseshoes as he was at making them, won the match and consoled his younger friend who was disappointed at losing. Luster said "Owensville sounds better than Lusterville, anyway", and thus the settlement was named.

Luster – who became sole owner of the store when Owen joined the California Gold Rush – had been appointed postmaster in 1856 and held that position until 1961 when the War Between the States split Missouri into two camps. He raised a family and some of his descendants remain in the area to this day.

While Luster remained in the area after that historic horseshoe game in 1847, Owen had itchy feet. The same wanderlust, which brought him and his family from Tennessee westward to Missouri, was still in his blood. Two years later in 1949, he was lured to the newly-discovered gold fields in California and subsequently returned to Missouri – in possession of some gold nuggets, settling near Judge on the Gasconade River. Another post office and village – Owen's Mill, also thought to be in Osage County – was named for him.

Though denied – apparently by his own doing – a place in history as a town's namesake, Luster remained close to the village he helped name. His contributions were finally recognized by Owensville city officials who, at the urging of the *Gasconade County Republican*, dedicated a public park in his honor on July 23, 1987.

#### Owen or Luster?

#### Who was the first postmaster here?

Just as much of Owensville's history is reconstructed from oral narratives handed down from mouth-to-ear, several conflicting accounts speculate on when a post office was authorized and who became the first postmaster. Was it Francis Owen or Edward Luster?

One version – from later newspaper files – of the early post office here purports that in August of 1847 Owen applied for and was granted the first post office in the settlement and was the first postmaster. If this is correct, his appointment apparently was entirely unofficial.

For another version – from microfilm roll number 71 of the U.S. Archives in Washington D.C. containing a listing of all postmasters in the county from 1830 to 1971 – officially suggests that Luster became the first postmaster on July 18, 1856 and served until September 17, 1861.

Who was the first postmaster – Owen or Luster? That it is minor historic controversy, which the official record – in an example of poetic justice – apparently settles in Luster's favor."

Owensville can be found on the Missouri map, south and east of Jefferson City, on Highway 19.

Some people don't understand it ... but once one is at the tournament even an outsider can see what it is all about for us." This proved to be true as the teary-eyed owner of 'The Kitchen', a

## NHPA RULES AND BYLAWS by Dan Sanders

By the time you receive this Newsline Magazine, the deadline for submitting Proposed Rules Changes (December 31<sup>st</sup>) will have passed, but our NHPA Rules Committee and Executive Council may still be reviewing and deciding on which proposals will be presented for delegate voting this coming August, at the annual NHPA Convention in Knoxville, Tennessee. These selected Rules Change Proposals will be published here, for your review and consideration, in one or both of the next two issues of this magazine. After reading them carefully, please discuss your thoughts on these proposed changes with your fellow pitchers, and also be sure to share these opinions with your State Officers and Charter Delegates, before the Convention.

As you can imagine, we receive a good number of questions from members about our Playing Rules and also about specifications for building new courts, etc. I received this question (see below) from one of our members about the placement of stakes, and although there are other acceptable methods for doing this, anchoring the stake in concrete has become more popular in recent years. I have included here some recommendations about how to do this that you might find helpful, so please file this information away for a future reference, and also pass it along to others.

Question: I am setting up a horseshoe pit---my question---When anchoring the stake, do you measure 14" from the hard surface that the sand is on or 14" from the top of the san?. I purchased stakes from the St. Pierre Chain in Worcester, Mass. The stake is 23" long. I am putting the stake in cement, which will be 2" under the hard surface. I don't think this will allow me enough stake to put in the cement to make a secure hold. I am thinking a longer stake, 36" long would be the answer. At any rate, I need to know where to measure the 14" from. Any suggestions from you would be very helpful. Thanks - Peter

Answer: Hi Peter... Thanks for your question about stakes and stake placement. This specifications information can be found on the NHPA Website at <a href="https://www.horseshoepitching.com">www.horseshoepitching.com</a> under RGS Book (see menu along the left side of the front-page). Go to the *Specifications* section for the exact wording, but basically this measurement is made from the base of the stake, at the level of the adjacent pitching platforms. The easiest way to determine this "spot" is to place a

straight board across the adjacent pitching platforms, just in front of the stake, and perpendicular to the pitching platforms. Where the *bottom edge* of the board would touch the stake is the "spot" to measure from. The correct length of the stake will be 15" (recommended) above this point. Also, the stakes should be positioned at a distance of 40 feet apart, from this "spot", to the same point on the opposite stake. Full-distance foul lines should be marked at 37' from the *opposite* stake. But if the stakes are *exactly 40' apart*, these foul lines would also be 3 feet in front of each stake. Looking at the diagram of the court layout (on the back of the RGS Book) may also be helpful in your better understanding of this information.

As for the stake, it should be made of cold-rolled steel with a diameter of 1 inch, and that has been cut to a length of about 3 feet. If you are placing the stake in a bucket of concrete, the bucket should be a 3 to 5 gallon size. To cushion the stake from the direct impact of a pitched shoe (this will help to decrease lost ringers), it can be inserted into a 1" inside diameter rubber hose\* and then pushed straight down into the wet concrete, clear to the bottom of the bucket. But before placing the stake in the concrete, drill a hole through the stake (a few inches above the end) and push an 8-penny nail through it (and the hose) to prevent the stake from working its' way up the inside of the rubber sleeve, through use and time. Also, this rubber "sleeve" should not extend more than 1/4" above the concrete in the bucket and can be cut away (if necessary, after the cement dries) by using a utility knife. The 3" forward lean (also 12 degrees) of the stake (at a distance of 15" above the level surface of the pit material) can be attained by adjusting/tilting the bucket when burying/placing it beneath the center of the pit. Using the end of a length of 2x4, tamp the soil

around the bucket, to hold it in position. To keep the pit material from "mixing" with the soil below, place pieces of thin plywood or roofing shingles on top of the soil before adding the pit material. The height of the stake (above the level playing surface) must be between 14 and 15 inches. If it is *more* than 15" (which is likely if you start with a 36" stake), use a hacksaw to cut off the excess stake length above this 15" height. I hope that this information is helpful to you.

\* This is the type of high-pressure hose that is used by companies that do sandblasting of brick surfaces (usually old homes or buildings). It may be difficult to locate this 1" inside diameter hose, but you can make some phone calls or maybe do a "Google" search via your computer. This hose can also sometimes be found at salvage yards, so call around.

If you can't find it, another option is to split (lengthwise) a couple pieces of thick, *rubber* garden hose to use as a substitute. Also, when using the 1" high-pressure hose, lubricate the inside of the hose (and outside of the stake) with oil or dishwashing soap to more easily slide the stake inside the hose.

In closing, I hope that all of you have had a very Merry Christmas and New Year celebration with family and friends! Perhaps many of you have already set some horseshoe pitching goals for this New Year and are already working toward these goals by participating in tournaments and/or winter leagues. I wish all of you the *very best* in the coming year and hope to see many of you at a local tournament, or at the World Tournament in Knoxville, Tennessee.


