



He had a nice vacation and enjoyed visiting with the players and wives. The Mesa officers received lots of cooperation and help from many players in order to conduct and pitch everyone who showed. Classes were held at various locations. It was a job well done by all.

Donnie Roberts and I had two outstanding meetings. Much was discussed and accomplished. Three Regional Directors and one Hall of Fame Committeeman were also present, Clarence Giles, Arnie Mortenson, P. D. Riley, and Art Halter. By-laws committee members present were George Nick, Jerry Schneider, and a new member Don Tutich of Alhambra, California, who replaces Bill Cessna. The proposed by-laws changes were discussed and voted on.

Southern California Association and the Los Angeles County Fair Board will be sponsoring a \$4,000.00 six player indoor invitational tournament. It will be held September 29-30 and October 1,1978, at the Los Angeles County Fair, in Pomona, California. The Fair Board has guaranteed \$2,500.00 and Southern California the remainder. Southern California Committee has selected and invited six top players with a deadline for accepting and sending their \$100.00 entry fee. When the players have been finalized we will announce their names. The prizes will be 1st — \$1,000.00, 2nd — \$800.00, 3rd — \$700.00, 4th — \$600.00, 5th — \$500.00, 6th — \$400.00. Local members including myself will provide lodging during their stay and be responsible for transportation to and from airport and tournament site. Portable courts will be built and installed in one of the Fair's large buildings. Further details on the tournament will be published later. All the credit and thanks for the contacts, meetings and leg work go to Amos Hodson, Eston Brown along with Jerry Schneider.

Wouldn't it be nice if more of these type tournaments could start up across the country? If so, maybe we could get a quote "Pro Circuit" started. It might be easier than you think with a little effort. How about it?

I appointed Curt Day of Indiana to the NHPA Hall of Fame Committee replacing Paul Puglise who passed away.

The 1978 World Tournament schedule, prize list and proposed by-law changes are listed elsewhere in this issue.

The NHPA offices up for re-election at the 1978 convention are: 2nd and 4th Vice President and Secretary-Treasurer. Donnie Roberts and John Rademacher will be seeking another term. Dorothy Pinch has decided not to run for re-election. I have asked Bonnie Siebold of Indiana and she has accepted to be the NHPA female Vice President if the delegates elect her. I will be sponsoring and supporting the above three. However, this does not mean the door is closed for other candidates. I only hope if there are others your names will be published soon so all states and delegates can discuss their choices before the convention.

Dear Editor.

In the February issue of the News Digest, Sol Berman's report put my inability to attend the "Challenge of the Sexes" and "Superstars" competition in an unfavorable light, implying that I was uncoperative. This is not the case.

At the World Tournament in Greenville, Ohio, I told Sol that I would love to compete in both events if it was at all possible. Twice I told him I was enrolled in nursing school for the coming two years and that it might be difficult to get the necessary time off for these events, but that I would try in every way I knew to be able to go.

I was very excited about the possibility and had already started training for these events.

In August, after I had returned home, Dave Herscher of Joe Goldstein's Office called me and said that I was accepted as a contestant on the "Challenge of the Sexes" program which would take one week in November and that I was possibly accepted for the "Superstars" competition which would take place in Freeport in the Bahamas from Jan. 28-30, 1978, a Saturday, Sunday, and Monday. I did not understand how "Challenge" (or "Battle—as he continuously referred to it) would take a whole week and asked him if he was certain about that. He was, so I regretfully said it would be impossible for me. As for "Superstars"; I knew a Monday off would be impossible so I asked if I could compete in 7 events on Saturday and Sunday alone. In the "Superstars" competition, each competitor chooses 7 out of the 10 events in which to compete and I was willing to compete in the first 7 events, whether or not I liked them, just to be able to do it. He promised to find out if that was possible and call me back a few days later. About 4-6 weeks later he called back and said it couldn't be done. During that interval, I received a letter from Sol Berman asking me why I had turned down the offer of the competition. Since I had not, in fact, turned it down and since I was still waiting for the return call from Dave Herscher, I wrote to Sol Berman and explained the above facts.

I heard nothing more until November. In the early part of November, Paul Fava of Trans World International, Inc. telephoned me and said he had read about horseshoes and about me and wanted to know if I could compete on "Challenge of the Sexes" against Carl Steinfeldt. I was very excited at this second opportunity. He said it would be scheduled sometime between November 11-20, but that he didn't know exactly what day it would be held. He understood my problem with school and asked which days would be possible as it would only take one day to film the horseshoe segment. I replied that Thursday through Sunday were the only days I could do it. Their schedule was flexible at that point but they were to decide the exact time for the horseshoe pitching segment at a meeting to be held a few days later. At that meeting they decided to have the horseshoe pitching segment on a Wednesday. Again, the disappointment hit me. I told Mr. Fava that I would see if I could somehow pull strings to get out of rurs's training on that Wednesday but he said that would take longer than they could afford to wait. He asked if I could recommend anyone who was photogenic and competitive who could play in my stead. I mentioned Kelly O'Brien as a former Junior Girls' Champion and a promising newcomer and gave him Donnie Roberts' address and telephone number in order that he might somehow reach her in time for her to take advantage of this opportunity.

During our conversations, I asked Paul Fava how they were going to portray horseshoes. He said Arnie Mortenson of California, a name I recognized, was handling the details of the horseshoe court and the game itself. Hearing Arnie Mortenson's name assured me that horseshoes would be portrayed in a good light. I also asked if Trans World International had heard about our sport from Joe Goldstein Public Relations, Inc. and to his knowledge, they had not. Again, Arnie Mortenson seemed to have done the promoting. We talked also about how we might plan better for this in other years. We mentioned that if we of the N.H.P.A. organized a portfolio of sorts including our top players and/or our most colorful players, we might be able to do a better selling job on ourselves. He said we could plan this a little sooner next year if T.W.I. received some information from us in September or October.

I hope this letter sheds some light on the occurrences of the past few months. The decisions to pass up these opportunities, with their obvious advantages both for me and for horseshoes were the most difficult decisions I have ever made and I am still very disappointed. However, I hope we have begun, through Carl and

Kelly, to make ourselves more visible to the public.

A HISTORICAL RESUME OF THE PACIFIC NORTHWEST OPEN

The Pacific Northwest Open held annually at Yakima, Wash. the 2nd week-end after Labor Day in September has been held every year at Yakima for 32 years. It was formerly called the "Northwest Open" but because many places throughout the central states began to use the name "Northwest" it was changed to "Pacific Northwest Open". It was held at the Fairgrounds in Yakima the first years and then moved to the Elks Memorial park in the latter years, but always in Yakima, Wash.

The first tournament was held in 1946. Lewis Getchell of Tacoma won the Title the first 3 years 46, 47, and 48. He received cash for the 1946 and 1947 victories. In 1948 he received a nice trophy as he won the championship after a close game with John Monasmith.

Cletus Chapelle of Portland, Oregon has established a tremendous record, having competed in the top clas every one of the 32 years the tournament has been held. He never won a championship, but has came very close. He was in a playoff with Henry Knauft for the title in 1969 but lost.

John Monasmith has won the championship a total of 16 times and Henry Knauft has won 9 titles.

Officers are elected each year at the annual meeting held during the tournament schedule. In the latter years a big banquet has been held. Officers elected for 1978 are Barry Chapele, Portland, Ore. president; Ken Carvo, Yakima, Wn. vice-president and Beth Carvo, Yakima, Wn. sec.-treasurer.

The first Pacific Northwest Ladies tournament was held in 1967 with 6 women competing. Alice Rehard of Spokane won the first championship. Mildred Kuhne of Tacoma is the only lady to win the championship more than once. She has won the title 4 consecutive times, 1968 thru 1971.

The first Pacific Northwest Junior Boys championship was held in 1967 with Jim D. Malvern of Seattle winning the first Title. Mike Weber, Hoquiam competed in 1969 and wound up with 82.40% but it was unofficial as he did not play enough games. Had he pitched the required number of games, he might have established some lasting Pacific Northwest records as he did in his Washington State tournaments. Sam Woodman, Colbert and Ray Durfee, Quincy had 2 consecutive championships each for the most titles.

WINTER PITCHING COMES TO WYOMING

Pitching horseshoes in Wyoming during the winter season, until the past two years, was an event as rare as Walter Ray missing a ringer. Winter horseshoe pitching here, for the second successive year, was the headliner event for the Wyoming State Winter Fair held in Lander, Wyoming, January 21-28.

A large heated county owned building is used for a variety of contests, livestock and farm machinery displays, exhibitions and community functions. Contemplated expansion of

the building will provide sufficient space for the conduct of rodeo events.

Eight courts with sawdust-sand pit material provided spacious facilities for thirty-six pitchers during the two day tournament. State and former State champions and those seeking revenge against the titlists gimaced, grunted, and groaned throughout the single round-robin contests. Noticeble was the extensive use of surgical tape to protect tender fingers from abrasive effects of rough shoes. As final games in each class matches developed weariness in the form of flat-foot sluggish strides and bloodshot eyes became evident. After all, four to five months of inaction is good reason for the encroachment of cobwebs.

Ken Raymond, the 1976 State Champion and LaVern German 1977 State Chamion emerged in a tie with German winning the game with Raymond during regular play. However, Raymond walked off with the trophy in Class A by virtue of a superior ringer percentage. German commanded second place and Farron Eiseman of Riverton and former World Junior Champion took third place in the Class.

Roy Lacy of Lander, 1977 State Class "C" Champion took first place in Class B with a loss of one game. Ron Harvey easily captured Class "C" and Dave Brown of Lander, an inexperienced tournament pitcher breezed thru Class "D" without a loss.

BOB DOMEY ARRIVES...WINS JANUARY THAW AT HERITAGE

For the last three years or thereabouts, a fellow figures if he gets by Domey he's got it made all the way to the top of the winter tournament trail at Heritage Recreation Center in Sutton, Massachusetts. "Hi, guys. My name's Domey. Bob that is." Joe Schultz and Art Tyson thought they had it made. They'd just buried Ed Domey in 4th place. All one of them had to do was get by that young upstart from way down south in northern Rhode Island, Bob Domey. Tyson says, "I want him." So he buries Schultz 35-10, pitching 80.6%. Bob says to Artie, "That's not nice, allowing poor Schultzie only 10 points." So Bob throws 86.4% at him and only lets Baldy get nine points! Seriously, with a little more seasoning of high-level competition, Bob Domey may well surpass his brother's exploits. He's learned to throw ringers and let the other fellow worry about getting more. Welcome to the top, Bob.

New Hampshire's Mike Donovan made his return to the horseshoe wars a distinguished one with a convincing 60.9% win in Class 2, losing only to "3rd Place Gadoury" (three tourneys, three thirds) in a meaningless last game. His 60.9% was way over his infrequent sojourns these past four years. Fran "Tiger" Norman dispelled some of those "What's wrong with Norman" questions by winning a three-way playoff battle with Gil Lee and Lee Ashford in one of the most exciting finishes in recent years, averaging 54.2% for the day.

"When the competition gets stiffer, stiff the competition." After finishing 4th in Class 5, Karl Jernburg filled a cancellation in Class 4 and won it! Bill Davis saved his best game for a playoff with Joe Guy, pitching 52.6% to win Class 5. "Sleepy" Ralph Lacerte finally woke up

and won Class 6.

Buddy Ploof's previous high tournament was 26%. His New Year's resolution is holding true. He averaged 32.6%, finished regulation play with a 40.5% game, and then won Class 7 with a fine 36.5% playoff game over Al Doucette. Not to be outdone, Rich O'Brien carried a previous high of 22% into Class 8. He proceeded to pitch three new high games, culminating in a 45.2% game ')''Don't forget the 'point two'', he said) and averaged 33.1% overall. There was one slight catch, however. Newcomer Dick Brown averaged 35.2%, beat O'Brien when Rich was pitching the lowest of his three high games, and won the class.

It hasn't happened yet. You can beat Debby once in a tournament, but not twice-handicap or no handicap. Debby laid a 78% game on Anne Domey in the playoff showdown. To Anne's

credit, she tossed back a 30%, but it was not quite enough.

WORLD TOURNAMENT QUALIFYING

By Donnie Roberts

To enter the 1978 World Horseshoe Tournament a player need only come to Des Moines on July 27, 28, 29, 30 pay your entry fee, be a member of your state association and the NHPA, and throw your qualifying round. Men throw 200 shoes and Seniors, Intermediates, Women, Girls, and Boys all throw 100 shoes. The Qualifying fees are \$15.00 for men and \$10.00 for Seniors, Intermediates, and Women. Additional entry fees are charged depending on what class you get in. Juniors pay no entry fee but must have a card.

There will be no practicing on the fairground courts during the four qualifying days. When you are ready to qualify, select an empty court by yourself. Put your two qualifying cards on the fence at each end. You will have 15 minutes to warm-up. At that time you must start or vacate the court. If someone is already on the court you want just clip your cards under his and wait your turn. Two people on one court will not be permitted at any time during qualification.

When you are ready to start notify an NHPA official who will get scorekeepers for you. Based on our NHPA survey we feel that having scorekeepers from another state serves no worthwhile purpose. Therefore we will not follow that policy at Des Moines. You must tell both scorekeepers

which pitch you plan to start on. We do not follow any policy of starting on a six.

The NHPA will have judges on the courts during qualification. If a shoe needs measured just call on them. However, every pitcher could carry a straight edge and six inch rule and measure his own shoe to avoid a delay which might hurt your score. We also want each pitcher to call the score to the scorekeeper. When you get to the peg and have a six just say '6' so the scorekeeper won't be involved in guesswork. People keeping score during qualification shall **not** mark up the score until the pitcher has called the number. Scorekeepers should not talk or move around or do anything to distract the pitcher.

If you are qualifying and some major interference comes up that is distracting you, stop and notify the office immediately. We will make a proper arrangement. Don't wait until you have thrown the entire round and ask to qualify over. Also, the Juniors and Women only throw 30

feet. If it bothers you to qualify next to a 30 foot pitcher, don't do it.

No pitcher will be allowed on the courts at anytime during qualification or during tournament play unless he is wearing a shirt with his name and state or country on it. We reserve the right to refuse people with shirts that are scribbled with felt tip markers or other sloppy efforts. Let's look like athletes. Make your plans now for some very attractive wearing apparel to pitch in. Put some class in our sport. There will be **no** exceptions to the lettered shirt rule this year.

When a Senior or Intermediate signs up he can choose to throw just 100 shoes or he can decide to throw 200 shoes if he wants to shoot for one of the big classes. However if he throws 200 shoes and then decides to play in the Intermediates or Seniors his first 100 shoes will represent his qualifying score. Seniors and Intermediates will **not** be permitted to qualify twice as in the past. Seniors and Intermediates must come to the office and declare which group they will play in by Sunday night or they will be placed by their age in Seniors or Intermediates automatically. Any qualifyer who doesn't get in a class high enough to satisfy him and plans to withdraw must report this information to the office.

W. T. QUALIFYING — (Continued)

There will be automobile racing at the fairgrounds on Saturday, July 29 starting at 8:00 p.m., so if a lot of noise will bother you, please avoid that period of time. The races cannot be stopped.

It should be pointed out that any irregularities during qualifying will be handled firmly. The NHPA Officials have been asked to monitor the qualifying very carefully this year. We want everyone to have an equal chance.

Defending Class A Champions do not have to qualify, but must sign up during the four days of

qualifying. Champions in all classes below A must qualify.

These qualifying guidelines may seem somewhat rigid but they are only intended to make things better for the pitchers and the sport. Your cooperation will be greatly appreciated.


OLD SETTLER'S DAYS ANNUAL TOURNAMENT—SUMNER, ILL.

NHPA AND STATE SANCTIONED LEAGUES AND CLUBS

Prepared by Donnie Roberts

The NHPA in cooperation with the State Associations in the United States and Canada is proud to announce a very attractive program for the league and club horseshoe pitchers.

This program will recognize the Horseshoe Clubs and their members as members of the NHPA and their

State Associations.

This program will initiate a combined State and National Membership Card. The cost of the card will be

\$2.00 per player per year. The \$2.00 fee will be used as follows:

- 1. \$1.00 to the State Association of residence. Hopefully each state association will use part of this fee to provide some programs, awards, or whatever they desire for all their local clubs. They should also use some of the fee to improve and develop their state association and the services it provides to the clubs in their
- 2. \$1.00 to the NHPA. This part of the fee will be used to pay for the awards program which will be presented to the league pitchers and to the local clubs. Ten cents of each dollar to the NHPA will go to the NHPA Secretary Treasurer as a partial compensation for the tremendous amount of extra work involved with this program. Ten Cents rebate to local club.

So the breakdown of the \$2.00 fee is:

A. \$1.00 to your state

1. part to help local clubs.

2. part to help your state. B. \$1.00 to the NHPA.

1. 10 cents rebate to local club.

2. 10 cents to NHPA Secretary-Treasurer.

3. 80 cents to partially fund the awards program and necessary materials required.

We feel that \$2.00 is a very reasonable fee. The benefits will far exceed the small charge.

We also feel that a league or club must have 100% participation by its members to be eligible for the benefits of this program.

What benefits will a league, club, or league pitcher receive as a member of the program?

 The local club will receive an 8 x 10 framed certificate indicating they are an NHPA and State Chartered and Sanctioned Club or League. This can be displayed at the courts or in the clubhouse.

2. The club or league will receive a one year subscription to the Horseshoe Pitchers News Digest. This will

be for the first year only. After that the club or league will be expected to subscribe.

3. Only Sanctioned leagues and tournaments will be advertised or published in the news digest. So if your league is sanctioned, your results and events will be published. Unsanctioned events will not appear. 4. Your winners and participants will be officially recognized by the state and national associations for

their achievements. Currently they are not. 5. This program applies to all forms of league play. Singles, doubles, scratch, handipac, count-all,

cancellation, or team-leagues, whatever system you use. Man, women, and juniors are all eligible. 6. Junior boys and girls will need to purchase the card at a cost of 50 cents, one half to your state and one half to your NHPA. They will be eligible for all aspects of this program.

7. The state and national associations will be very available with technical assistance to all local clubs and leagues.

8. The NHPA will provide an awards program to each league or event.

A. League Champ Awards.

B. Most Improved Pitcher Awards.

C. Consecutive Ringer Awards. 2-4-6-8-etc.

D. Percentage over average. 10%-20%-30%-etc.

E. Points over average. 10-20-30-etc.

F. Perfect Game.

G. A so much percent game. 10%-20%-30%-etc.

H. A so many point game. 30-40-50-etc. I. Player of the year. Local, State, Nation.

J. High Average. Scratch or Handicap

K. League Class Champion.

.. Sportsmanship Awards.

M. League Membership Awards.

This program was unanimously voted in by the delegates of all state associations represented at the 1977 National Convention. This program has been mandated by the state delegates because they realize how important the program can be.

The \$2.00 league membership does not entitle the holder to play in state and national sponsored sanctioned tournaments. However, a player need only pay an additional \$4.00 plus state dues to get the full tournament card. Juniors would only need to pay the additional 50 cents plus state dues for the full \$1.00

tournament card.

LEAGUES & CLUBS — (Continued)

What effect will this have on tournaments? Many of you are reluctant to have sanctioned events because your pitchers don't have State and National cards and the cost scares the players away. Now you could have league sanctioned tournaments where most everyone would have a league membership card. Those who didn't would have to join your league or club and buy the \$2.00 card. We could really just completely eliminate non-sanctioned events with this procedure. However, to participate in your state tournament, the World Tournament or other large state or national sponsored event the \$5.00 card would be required. But players would only need to pay the additional \$4.00 plus state dues, if they already had the league card. This would probably help your state tournament, because people who have the league card would be more likely to pay the extra fee.

CHANGE FOR PROGRESS

By Sol Berman

Ed Yankowski, regional director, made the observation that spectators sitting on the lower seats of the stands have difficulty in following the action, because of the angle and also due to the fence. Spectators in the lower rows and those behind the fence disturb the pitchers if they move.

He suggested that all these difficulties could be overcome if the pitching area was lowered or the stands elevated so that the lower rows were at the level of the top of the fence. Both of these

plans are good but impractical because of the cost.

The following changes should be considered when new courts are being built. If the stakes are spaced thirty feet apart, and the men's foul line placed 7 ft. behind each stake, we could accomplish many favorable conditions.

1. Lighting of the courts would be improved.

- 2. The fence surrounding the pitching area could be made much lower (2 ft, would be sufficient).
 - 3. Spectators sitting in the lower 3-4 rows would have a better view of the action.
- 4. People walking close to the fence would not disturb the pitcher. They would be 15 ft. behind each stake.
 - 5. Boys, girls, and women would no longer consider themselves as 2nd class citizens.
- 6. New pitchers could be encouraged to play, by starting them at 30 ft. They wouldn't loose interest as readily.

The only disadvantage is that a wider piece of land would be necessary (54 ft.). Most areas at present are at least 50 ft. wide.



- 6. Shall the N.H.P.A. First, Second, Third, and Fourth Vice Presidents be allowed \$150.00 for attending the World Tournament. (CHANGE FROM \$100.00)
- 7. Shall the N.H.P.A. President receive an annual salary of \$250.00. (CHANGE FROM \$100.00)
- 8. Shall the Managing Editor of the Organizations monthly Magazine receive an expense allowance of \$700.00 annually. (CHANGE FROM \$600.00)

Items 5-6-7 and 8 to be effective at the 1978 World Tournament if passed by the delegates.

REPORT ON 1977 RAFFLE

The primary objective of the NHPA raffle was to get some real money into the Championship Classes for the World Tournament. Asking each of the 4500 members to either buy or sell 10 tickets was asking very little for the game of horseshoes. If the membership had gotten behind this, \$45,000 could have been raised with little difficulty. Selling 10 tickets is not hard. Phil Zozzaro, NJSHPA president sold over a 100 by himself; others sold over 50. We could have had real prize money in every division.

It is easily seen that the Class A Champion could have received \$10,000 with 2nd place \$5,000; Class B Champion \$2,500 with 2nd, \$1,500; Class C, \$1,000 with 2nd \$500; and Class D, \$500

and \$250.

The women could have \$2,500 first place with \$1,500 for 2nd; the Intermediate Seniors and Seniors each \$1,500 for first with \$1,000 for second. This would have been \$30,250 of the \$45,000. We could give a new car for first place in the drawing with several smaller prizes. **However**, we do not have to limit our thinking to \$45,000. Suppose every member sold 20 tickets each?

With this kind of money, the number of entrants in every division would probably double, this making still more prize money for those not finishing one or two in their division.

Frankly, I'm not proud of the fact that we have a would tournament where even the World Champion barely breaks even. We can do better! Altho' the raffle can by no means be termed an overwhelming success, it did show what 10% or less of the membership could do. It also showed what could be accomplished if the other 90% would get with it.

Until somebody comes up with a better way to get some respectable money for our World Tournament, I still feel it is the way to go. At least it is a self-help project in which every pitcher can participate. Perhaps mailing every member 10 tickets direct is the answer.
