

Don Titcomb, 1960 World Champion, has decided to withdraw as a candidate for the NHPA Presidency for the following reasons:

- So involved with 40 veterans hospital wishing to organize a recreation day which will include a horseshoe tournament.
- Community Services which are holding a tournament plus exhibitions at the Agnew State
 Hospital which involves about 10,000 spectators. Don will give an exhibition.
- 3. Involved with the 1st annual Watsonville, Ca. \$2500.00 tournament in June.
- 4. During the summer conducting the second annual Santa Clara County Fair pitch and win event for the fairgoers. This is an amateur and professional segment. Event will run from 11 a.m. to 11 p.m. this year and will probably realize 500,000 people viewing our sport.

On behalf of the NHPA membership we extend our best wishes to you and the Northern California membership and much success in your efforts in promoting our great sport.

I am disappointed that out of our entire membership we only have four members running for the

elective offices. Glen Portt of Georgia for President. Earl Winston, incumbent 3rd Vice-Pres. running for 1st Vice-Pres. and only two running for 3rd Vice-Pres. both of whom are from New Jersey, Vince Yannetti and Dr. Sol Berman. If one is elected there will be two on the Executive Council from New Jersey. If Winston is again elected we will not have a Council representative west of Missouri.

The Executive Council has approved two new NHPA charters, New Mexico and a second charter for Nebraska. We wish all new charters much success and hope to see an increase in membership for both states.

Received the following clarification of the proposed Proxy vote By-Law change from Barry Chapelle.

To the NHPA Membership:

Volume 26

There seems to be some confusion as to the proposal concerning proxy vote which will be voted on at the 1983 NHPA convention. I will attempt to clear it up.

First of all, the idea is to let the membership at large have a bigger say-so in NHPA affairs. The membership would discuss the issues at the state level and vote on them. Each state would get as many votes on each issue as it is allowed under the NHPA By-Laws and Constitution.

Since this is a radical change and would seriously alter the structure of the convention we want to start off this new voting procedure (we have called it proxy vote) on just two issues. These issues are: 1) election of NHPA officers, and 2) the site of the World Tournament. For the time being, all other NHPA business would be handled as now is, although it is our goal to eventually have all voting done at the state level by proxy. The proposals state that all candidates for NHPA offices and all bids for World Tournament be submitted to the NHPA Secretary by a certain date. The Secretary would compile the info, and send it to the state associations for discussion and voting.

The state associations would then return their votes to the NHPA Secrtary who would oversee the counting of the votes and announce the results at the NHPA Convention.





NHPA PUBLICITY REPORT

NHPA Publicity requests that the 1983 W.T. prize winners in all classes give the results of their accomplishments to their local newspapers. They are also asked to give the names of winners of the six championship classes together with some highlights of the 1983 World Tournament.

Also that all state and local tournament winners send an article to their local news media who in most cases are willing to give coverage to local events.

These figures do not reflect the income and expen-

ditures of the game related sales people and the

NHPA Publicity has been given permission to publish a one shot tabloid newspaper to be distributed nationwide featuring a directory as to approximate dates of all state tournaments and league schedules. It would list the location of all major courts together with the names of Regional Directors and state secretaries. State and national activities would also be listed.

The publicity committee is also working on plans to distribute membership blanks to all sport-

ing goods stores, putting blanks in all horseshoe boxes that are on sale.

Another request is made to the membership to send in any old used horseshoes that they might be sent to the West African natives who are unable to purchase shoes because of the economy that exists, and of the high cost of transportation to their area. To date the response has not been too great and it is hoped that this second appeal will bring about a better response.

It is also suggested that local courts be made available high school and junior high students to interest them in our sport. One of the best ways to do so is to organize a sanctioned league pro-

gram.

Also perhaps a form letter could be send to various trailer camp sites in hopes of creating interest there.

Tournament directors are asked to keep a court open, if possible, at their tournaments to let spectators participate in a 10-shoe count-all contest during a regular tournament. Such player would give his name and address for possible participation in organized pitching.

SPECIAL NOTICE: As NHPA Director of Publicity and Public Relations I am requesting that all contestants in the 1983 World Tournament refrain from smoking on the courts. I hope that the contestants will honor our sport by complying with this request.

RUTH HANGEN'S RESPONSE TO BOB MALLEY'S LETTER

April 12, 1983

Dear Mr. Malley:

I am sure your letter in the Digest criticizing the article written by Debby Michaud did for sure

jeopardize your reputation as an equal rights advocate.

Your major mistake was in assuming 30' distance for Class A Women is easier than the 40' men pitch at. Let me challenge any Championship Class man to pitch against any talented Class A woman at 30'. He would be lost. Don't you realize it is what you are used to doing automatically that is easier?

Before I ever entered any N.H.P.A. or sanctioned tournament, I pitched in my yard at 40' against my husband, male neighbors and friends. In the Buffalo paper I read about Lorraine Thomas and the NY State Tourney being conducted at Lockport, NY. At that time I was averaging 60% ringers at 40'. My husband encouraged me to enter the State Tournament, which I did.

To my astonishment, I discovered the women pitched at 30'. I was wrongly told I had to pitch at 30'. I found this change very difficult and I stood back as far as I could and still be on the cement pad. So, from experience I know 30' is not easier than 40' if one is used to pitching the longer distance.

In golf, women, because of physical build, have a shorter tee distance. Also in bowling, women are not obliged to use the same weight ball as men. I throw a 10 lb. bowling ball and most men throw a ball weighing between 14-16 lbs.

Mr. Malley, if you honestly believe 30' is easier, let me challenge you to a game at this year's

World Tournament. We will both pitch at 30'.

We women are campaigning so sincerely and progressing finely in our efforts for equal prize money in the Championship Class, when a disturbing article such as yours really tries to halt our efforts.

"COMMEMORATIVE STAMP MONTH"

This is the third year that the NHPA and its membership is requesting the Postmaster-General to favor our sport by granting a commemorative stamp.

The membership is asked to request their Congressman, State and City officials to write to the Postmaster-General to consider a commemorative stamp depicting our sport. All horseshoe pitchers and their friends are asked to send a letter this month.

Following is a letter written by Jerry Schneider of California to the Postmaster-General. Excerpts from this letter could be used in writing your request.

Postmaster General Postal Service Headquarters Washington, D.C. 20260

Dear Sir,

Never before have I written to you, but it is indeed an honor to write to you now. Undoubtedly

you have received many letters before - some good and some bad.

You are probably wondering why I am writing to you at this time. I will try to answer by saying this. In the past the Post Office Department has issued many commemorative stamps, commemorating many famous men of history, occupations, places and many sporting events. Some of them being baseball, basketball, football, horse racing, tennis, bowling, golf and numerous events in the Olympic Games, but never in the sport of Horseshoe Pitching.

Being a stamp collector for over 50 years and an active horseshoe pitcher for over 45 years, I would like the Post Office Department to consider very seriously of a Commemorative Stamp for

our sport "Horseshoe Pitching."

The first organized play recorded in the United States was in 1899, a local club was formed in Meadville, Penn. Today the National Horseshoe Pitchers Association has branches in nearly all the 50 states in the Union. Every year the N.H.P.A. conducts a World Horseshoe Tournament. Also every state having a charter holds State Tournaments in their respective state yearly.

All ages and both sexes compete in the various classes in these tournaments. It is a family sport enjoyed by all and can be played both indoors and outdoors. This sport definitely qualifies

in our Presidents message of more physical fitness is needed for all.

Even in the past, former President Harry S. Truman had horseshoe courts built at the White

House for his and those who desired usage during his years in office.

Also former Admiral Chester K. Nimitz carried a membership card of the Mosswood Horseshoe Club in Oakland, Calif. In his own words, Horseshoe pitching is a great way to keep physically fit, especially for those in the Senior Citizens age group and that it is an ideal exercise recreation.

Many of the schools in California have added horseshoe pitching to their athletic programs. They play in their gym classes and also have team play with scheduled tournament play, both in

singles and doubles teams. This is for girls as well as the boys.

It was recently estimated that upwards of 30 million people in the United States and Canada pitch horseshoes at family picnics or in their own backyards. Think of these figures and its considerable sales.

Therefore I respectfully request that you give this suggestion serious consideration. A Commemorative Stamp for America's All Family Game, "Horseshoe Pitching", would be greatly appreciated.
