#### 2. Same section, Article VI, Section 1, Pg. 11

a) After — Authorized (first sentence)

Add - Men's division of the

b) Same section, Article VI, Section 2, Pg. 12

#### 3. By-Laws Article 3, Section V, Pg 17

Add Section G: Drinking of alcoholic beverages or smoking on the courts is prohibited. Penalty: A violation could bring a one year pitching suspension at the decision of the N.H.P.A. Executive Council.

#### SUGGESTED CONSTITUTION & BY-LAWS REVISIONS

To the membership:

I have had many recommendations that the Constitution and By-Laws be completely overhauled. The primary reasons are that many of the paragraphs are out of place, that they inhibit the Council in promoting our sport in many instances, that dollar figures or addresses should not be in a Constitution, and the cost to the membership in printing new editions every year is not necessary. Blank pages can be put in the next publication and any future changes can be added to them without publishing a new book.

- Request blanket approval be given to include the feminine gender throughout the entire Constitution and By-Laws. Wherever the word 'he' is used, replace with 'he/she'; 'his' with 'his/her', etc.: 'committeeman' with 'Committeeman/woman'.
- Request blanket approval to more paragraphs to correct heading. Example: Move all references to the World Tournament to one section. Move all references to 'Sanctioning' to one section.
- Pg. 2. Delete: Ellis Cob, Editor, P.O. Box 1606, Aurora, III. 60505. Delete: NHPA Office, 9439
  Camp Creek Rd., Lucasville, Ohio 45648. Replace with: the Secretary-Treasurer. (Addresses
  have no place in a Constitution. All officers and the Editor will be listed on inside front cover.
  As officers change, members will make changes in their book.)
- \*4. Pg. 5, Sec. 10. Add to this: ...N.H.P.A., except, in specific instances, they may waive any bylaw or rule in order to better promote the sport. (Rules have been waived illegally in the past. This addition simply makes it legal. Example: Las Vegas tournament would probably not have been held if portable courts could not have been used. Yes, it is POSSIBLE to cut holes in beautiful carpets, make holes in flooring so the courts would be floor level and then fill them with 6-8 inches of clay. But, is it FEASIBLE? With TV exposure on the horizon, your Council needs to be flexible.)
- 5. Pg. 6 Sec 13. 1st par., delete: ...said appointments to be subject to a unanimous vote of the Executive Council within thirty (30) days. 2nd par., delete same as above.
- 6. Pg. 6. Sec. 14. Change next to last sentence to: ... Said removal to be effected by a majority vote of the Executive Council remaining.
- 7. Pg. 8, Sec. 9. Change last two sentences: The N.H.P.A. First, Second, Third, Fourth Vice Presidents and Chairman of Regional Directors shall be allowed a *minimum* of \$200.00 for attending the World Tournament. The N.H.P.A. President shall receiv a minimum salary of \$300 per year. ADD: The Executive Council shall determine the amounts authorized each year.
- 8. Pg. 9, Sec 10. Change to: The Secretary-Treasurer shall receive a salary as determined by the Executive Council. He/she shall be compensated for personal expenses incurred in the performance of his/her duties. (For 1984, the Sec-Treas receives \$1.00 per member. A successful membership drive could jump his pay from approximately \$7,200 to over \$10,000 which would not be too much for a full time Secretary. Salary should be controlled as membership steadily increases.)
- Pg. 9, Sec. 11. Delete the words: . . . of \$900. Add: The Executive Council shall determine the allowance.
- 10. Pg. 9 Sec. 12 Change to: Within two weeks after the convention, all officers shall turn over to their successors in office, all records and property of the N.H.P.A. which are in their possession. Liability for missing property shall be determined by the Executive Council. (Sec. 12 as presently written is impossible. How would you send books, filing cabinets, typewriters, etc. by registered mail?)
- 11. Pg. 9, Sec. 13 Delete: . . . of \$75.00 annually . . . Replace with: . . . as determined by the Council . . .
- 12. Pg. 9 Sec. 16. Change last sentence to read: The prize list must be approved by a majority vote and published in the Horseshoe Pitcher's News Digest.
- 13. Pg. 10 Sec. 17 Change to: An amount of money shall be set aside each year by the Exec. Council for publicity expenses. (The present 50¢ per member for publicity does not give the Council control of expenditures as membership increases.)
- 14. Pg. 11 Sec. 2. and 3. Changes are due to a 'State' being authorized 3 chargers by the 1983 Convention:

#### REVISIONS — (Continued)

Section 2. A state can at the discretion of the Executive Council be granted more than one charter if the new organization shows the Executive Council it has 50 (fifty) N.H.P.A. members. At any time after a second or third charter is granted, if any of the organizations allows its membership to drop to less than twenty-five (25) members, that membership loss shall constitute grounds for the Executive Council to revoke its charter.

Section 3. In the event a state has more than one chartered organization and more than one apply for the State Tournament, the Exec. Council may sanction the one it considers the most worthy, and the champions of that tournament shall be officially recognized. The N.H.P.A.

members of all charters shall be eligible to compete for the same entry fee.

15. Pg. 11, Sec. 1. Change to: The winner of the authorized World's Tournament shall be declared Champion Men's Horseshoe Pitcher of the World, and shall hold the title until the next authorized World's Tournament.

At any World Tournament, the Champion shall contest for the title, on the same basis, and under the same condition as all other contestants. The N.H.P.A. Executive Council shall decide the method of qualifying, 32 or more to qualify for the Men's World Championship, 16 or more for the "B" Championship.

Pg. 12, Sec. 2. Change first sentence in par 1 to read: A Ladies Tournament shall be held...
 Par. 2. A Junior Tournament for boys and girls shall be held...

Par. 3. Delete: ... 27 feet from foul line to the opposite stake.

17. Pg. 13 par. 2. Change to read:

A Senior and Intermediate tournament shall be held for both men and women in conjunction with the World Tournament whenever the tournament committee feels there are sufficient entries. The winners shall be declared the Men's Senior World Champion, the Women's Senior World Champion, the Men's Intermediate World Champion, and the Women's Intermediate World Champion. They shall hold their title until the next World Tournament.

18. Pg. 13 par. 6. Change to: The Points system is to be optional in any and all pitching activities except in World and State Championships. In these two, the Cancellation System must be us-

ed.

 Pg. 14, Sec. 5. Change to: The N.H.P.A. may conduct any Sectional, National or International Tournament under its own auspices in strict accord with the rules herein stated.

20. Pg. 14 Sec. 7. Change to: Issue's pertaining to future World Tournament sites, Candidates for Office, and changes in the Constitution and By-Laws shall be submitted so as to be published in the Horseshoe News Digest a minimum of three (3) months prior to the National Convention.

\*21Pg. 16 Sec. 3. Change to:

3a. The title of Champion Horseshoe Pitcher of the World can be contended for only in tournaments authorized by the Executive Council.

b. The title of Match Game Champion Horseshoe Pitcher of the World can be contended for

only as authorized by the Executive Council.

- 22. Pg. 17 Sec. 4 Change to: In the World tournament, games won and lost shall determine the order in which the winners are listed. Ties between contestants for first place shall be decided as follows:
- 23. Pg. 17, Sec. 5 Sol Berman has corrected that. If two tie, one playoff game of 40 points. If more than two tie, first place shall be decided by a ladder-type playoff based upon ringer percentages. In all other ties, trophies shall be awarded based upon percentages but the monies shall be divided equally.

25. Pg. 18. 2nb par. Change to: In submitting a new model of a horseshoe, or a change in an old model to the N.H.P.A. Secretary for sanctioning, a complete written description shall accompany the sample of shoes. The Executive Council shall determine the fee for sanctioning.

25. Pg. 18, Sec. 1. delete: . . . of \$7.00 . . . Par. 1.

- Par. 2. Change to: Junior dues shall be the amount set by the N.H.P.A. Counbis plus the amount set by his/her State Charter. Members will be designated as Juniors on their membership card.
- \*26Pg. 18, Sec. 2. Change to: The annual cost for a twelve month subscription to the Horseshoe Pitchers' News Digest shall be determined by the Exec. Council.
- \*27Pg. 18, Sec. 3. Change to: The qualifying and entry fees for the World Tournament shall be as determined by the Executive Council. Entry fees will be put back into each respective class cash prizes.
- Pg. 18, Sec. 4. Change to: Executive Council shall determine the amount of money to be added
  to the World Tournament cash prizes. This money may come from any source available to the
  Council.

#### REVISIONS — (Continued)

- 29. Pg. 19 Rule 1, Sec. b. Delete: Foul lines in front of pitcher's boxes shall be in a straight line across the entire layout.
- \*30Pg. 19, Rule 2, Sec. a. Delete: ...three feet in front of ... Replace with: ...even with ... Sec. b. change to same as above.
- 31. Pg. 20, Sec. c. Replace the word 'possible' with the word 'feasible.'
- \*32Pg. 20 Rule 6 Foul Lines. Change to: Foul lines shall be clearly defined by a line drawn even with each stake. Foul lines muyobz used if feasible. They are required in all National, State, and World Tournaments.
- Pg. 20, Rure 7, Sec. a. Delete: No contestant shall move his own or opponents shoe or shoes. (See next item.)
- 34. Pg. 21, Sec. c. Change first sentence to read: No contestant shall move their own or . . .
- \*35Pg. 21, Rule 8, Sec. a. Foul Lines. Change to: Any shoe pitched while the pitcher's foot from which heshe steps extrads over or on the foul line shall be declared foul and removed from the counting area. All foul shoes shall be called by a referee.
  - Sec. b. Add: He/she may stand with one or both feet behind the foul line. In delivering a shoe, the pitcher's foot *from which he/she steps* must remain behind the foul line until the shoe has left his/her hand.
- 36. Pg. 21, Rule 9, Delete. It is stated in above.
- 37. Pg. 22, Rule 14, Change first sentence to read: A regulation game shall consist of 40 (forty) points in all contests where a National *or State* title is involved.
- Pg. 24, Rule 18, Sec. a. Count All Scoring. Change to: A regulation game shall consist of fifty shoes by each player (25 innings).
  - However, the number of shoes pitched in other games may be set by league or tournament officials to fit their conditions.
- 39. Pg. 24, Rule 18, Sec. c. Add: The double alternate first pitch may be used if desired.
- 40. Pg. 24, Sec. d. Change to: Ties shall be broken by pitching as many extra innings as are designated in the tournament rules.
- 41. Pg. 25, Rule 22, Sec. b, 2nd paragraph. Delete.
- 42. Pg. 25, Rule 22, Sec. e. Delete. Same rule on page 10.

#### ATTENTION MEN AGE 70 AND OVER

Interest has been expressed in having classes at the Ron Frakes Tournament of Champions in Springfield, Mo. for men 70 years and older who desire to pitch less than 40 foot distance. The tournament committee has agreed to include this division if several entries are received.

Any distance between 30 and 40 feet is acceptable. Use the regular entry blank and simply make a note that you wish to play in the "70 and Over" class. Should we not receive sufficient entries, your entry fee will be returned.

To submit a candidate's history to the Hall of Fame Committee of the NHPA, send 15 copies of the resume to: Ruth Hangen, 630 Heim Road, Getzville, N.Y. 14068. All histories to be considered in the voting should be received not later than May 31, 1984.

The requirements for a candidatea are: That one be an adult member in the NHPA for a minimum of 10 years. That one has established an exceptional record.

#### SELECTIONS ARE MADE IN 3 CATEGORIES

One that through his devotion to the game has contributed time and effort to the advancement of the sport of horseshoe pitching. Two people will be elected in this category.

As the league program grew it became necessary to set certain minimum criteria for each award category; those criteria will be obvious from the number of pitchers and the figures in each category.

The compiling of these awards became my last official act as League Coordinator. The compiling and announcing of these awards over the past six years was one of my most enjoyable chores. My congratulations to all pitchers, whether you made "Top Ten" or not. Placques are on the way to the first three finishers in each category.

#### SPOTLIGHT ON THE LADIES

Our spotlight is on our Women's World Champion Phyllis Negaard. Phyllis lives in Springfield, Minn. with her husband Ron and son Randy.



In her early 20's Phyllis bowled for two years, releasing the ball off the wrong foot and averaging 102. That was her first athletic experience. She expected little when she tried the horseshoe pitching set she bought her husband Ron, for Father's Day. When Phyllis changed her approach so that she pitched off the correct foot, pitching began to feel good and when she learned that women could pitch from 30 ft., it began to feel even better. Her percentage of ringers increased 20 in 15 minutes.

In her first year of pitching she won the Minn. State Women's Championship. In her third year she won her first World Championship. She has won the World Championship three times. She practices horseshoes two hours a day. There are horseshoe divots in the plasterboard ceiling in the basement where she practices in the winter. Her husband

knocked down a wall so she could pitch on a regulation 30' court.

Because she won the World Championship so early in her career, people wonder if it's easy. Phyllis said that if it were, anyone could enter a tournament without practice and pitch well, but it can't be done. "I'm very determined," she said. "I intended to win it some day. I just didn't think it would be that soon."

Those close to her say Phyllis has done well because she is a perfectionist. Phyllis also works full-time in the basement on the family's monogram business..

# "From Out Of The Mail Bag"

To: President, NHPA Secretary/Treasurer, NHPA All Vice-Presidents, NHPA Regional Director (UT, AZ) Editor NHPA News Magazine

Dear Sirs and Madam.

This letter is in regards to NHPA's way of doing things.

1. Sanctioning of Tournaments: If the NHPA is going to keep the last paragraph of the form that sanctions tournaments, about the TV and Video Tapes being the property of the NHPA and requiring in writing from the NHPA, the right to show it on TV on their stations, then the State of Arizona will not sanction any more tournaments. The TV stations in Arizona are just now beginning to give us some coverage and I can imagine what they'll say if we tell them they can't show their tapes on their TV stations without written permission from the NHPA.

2. Printing of only Sanctioned Tournaments in the Digest: I imagine the NHPA will probably receive as much adverse comments and letters from members over the printing, in the Digest, of only sanctioned tournaments, as it did over the printing of only the first three place finishers in each class. We have always thought the News Digest was printed for the information and enjoyment of the Horseshoe Pitchers. It seems to us that the NHPA is dictating what will and will not

be published. If this is the case, most of Arizona's subscriptions will not be renewed.

3. The YUMA, AZ CHARTER: I still don't understand how the (Leadership) of the NHPA could do such a thing to the Arizona Horseshoe Pitchers Association. I still haven't quite thought out the whole mess. The Arizona Horseshoe Pitchers Association didn't receive any knowledge until the middle of January 1984 of the Yuma deal. Then the State Secretary from Arizona receives a call from Donnie Roberts asking if the Arizona Horseshoe Pitchers Association has any problems with Yuma receiving a Charter. He was told the State Secretary has no problems with it. Since when does telephone calls between the NHPA Secretary and the State Secretary dictate State Association policies? Why didn't the NHPA write a letter to the State Association? The State President of the Arizona Horseshoe Pitchers Association then instructs the State Secretary to call Donnie Roberts back and say we have some problems and objections with the YUMA Charter. Then Donnie Roberts asks the State President to write him a letter stating the objections. On 25 Jan. 84, the State President sent the letter about the YUMA Charter to the NHPA Secretary. On 30 Jan. 84, Mr. Roberts wrote a letter to the President of the Arizona Horseshoe Pitchers Association questioning all the objections. He stated in his letter that, Mr. Glen Portt, the NHPA President would attend the Valley of the Sun Tournament. Well 3 or 4 days before the Valley of the Sun Tournament, Mr. Glen Portt called the State Secretary and said he wouldn't attend the tournament because he hadn't received an invite. On 17 Feb. 84, the President of the Arizona Horseshoe Pitchers Association finally found out what was going on from the Regional Director. The President of the Arizona Horseshoe Pitchers Association was scheduled to go to YUMA on 20 Feb. 84 to meet with the YUMA Club regarding their Charter. The Regional Director then showed the President of the Arizona Horseshoe Pitchers Association the YUMA CHARTER with a cover from the NHPA President congratulating YUMA on their Charter and stating what a great day this was for Arizona. THIS WAS ALL DATED 1 JANUARY 1984, which means that this was already done before the Arizona Horseshoe Pitchers Association knew what was going on. I gues; it's still a big SECRET huh? If this is the way the NHPA is doing business, count us out.

We, in Arizona, have always thought the NHPA was an organization dedicated to setting some guidelines to follow, not dictate what State Associations could do, especially within the boundaries of their own State. We also thought the NHPA was there for the good of Horseshoe pitching, not Horseshoe pitching for the good of the NHPA. We will at our State Meeting be discuss-

ing these and other things.

I hope we receive an answer to this letter from the "NHPA." I also hope this gets printed in the News Digest and we get some input from other State Associations.

It took a lot of time and thought to write this letter, but we feel it had to be done. Maybe this will keep some other State Associations from going through the same thing.

Judges are needed in present foul line rule, so that point is not a change. I see many violations of foul line as it is now, but being allowed to move only one of your feet in windup and delivery, I would estimate even more violations — needing that much concentration on foul line (if that is not your preference of standing location) could hurt one's percentage. I guess if horseshoe courts could get as sophisticated as bowling lanes, with their buzzers, we could eliminate the need for the judge for foul line!

Earlier in my pitching I had been standing even with the stake, but was always so conscious of stepping on foul line, so moved back some. Also, because of observing pitchers of higher percents using more, or most of the pitching platform, which I believe may be part of their exper-

tise. I thought it could help me improve.

I hope the proposal will not pass — perhaps I would be considered a hard headed old dog, and it is also said you can't teach an old dog new tricks. But I do not like to see changes that are not for the better, and I believe not being allowed to have your normal arm and leg movement would hamper your game.

I like to compare horseshoe to other sports — a basketball player comes down the floor full speed and doesn't stop to shoot, a baseball pitcher has his good windup, bowlers each have a

delivery pattern, and all are on the move while delivering the ball.

It is mentioned that foul lines have been a problem for seventy years. Enforcement of the rule may be what we need, rather than trying to put the pitcher in a rigid position. At the basketball game I was at last week, a player's toe went past the foul line — he was not allowed to shoot for his basket; but never have I seen that the players must all use the same pattern of delivery.

I appreciate that when proposals are made, it is well ahead of the national tournament, giving

time for pro and con explanations, and rush decisions are not made.

Dear Ellis.

I couldn't believe that the President of the National Horseshoe Pitchers Association would propose to define the foul line on a horseshoe court as "a line drawn even with each stake," (p. 3, March News Digest). Do I interpret correctly that the distance proposed between the two foul lines will measure 40 feet? I wonder who, besides the President Glen Portt, considers this a solution to eliminating fouls.

It is evident to myself and most horseshoe pitchers that such a proposal would, in addition to being costly to implement, radically affect the sport as we now know it.

- 1. Court pitching platforms would have to be extended to the rear. (Who uses a three foot stride?)
- 2. The pitching distance would be extended to a maximum of three feet.
- 3. Strides would need to be altered to three feet. Did the President consider these ramifications before proposing this cure-all to the Fouling problem?

If in fact a problem exists at all, there are many better ways to resolve the situation. I have always taken the position that if an opponent occasionally fouled — it was accepted as part of the game — the same with myself. Frequent or intentional violations could always be brought to the attention of the judge or scorekeeper, who in

Frequent or intentional violations could always be brought to the attention of the judge or scorekeeper, who in turn warns and otherwise enforces the nullification rule.

So what is the big deal? Who's complaining? World Tournament losers? If this is where the problem is at, and I suspect that it is, they should be subject to the same rules and conditions applied to all clubs and pitchers.

If our sport is becoming a cut throat and gripe session, perhaps it will be necessary to install an electric eye warning system at the foul line in the next World Tournament. Even if it cost a few dollars it would be far better than trying to revolutionize the sport, as has been proposed.

Further I disagree with the proposal that would permit the striding foot to cross the foul line after the delivery. This being a subjective call, if necessary, should read...to either foot crossing the foul line, until after the shoe is released.

Come on there horseshoe pitchers, let's hear from you, if you don't make yourselves heard I can envision the game being set back about a hundred years or more by these proposed changes.
