FROM YOUR PRESIDENT — Glen A. Portt

For the 1985 World Tournament Convention, the NHPA will operate as follows:

June 1-5. The NHPA Secretary will mail to each State/Charter President, a number of brochures specifically prepared for the delegates. The number mailed will equal the number of delegates the state is authorized plus 2 additional copies for alternates. Included in the package to each President will be two lists of all members from his charter who have entered the World Tournament. Delegates and alternates will be selected and each one chosen shall be given or mailed one of the brochures by June 20, 1985. This gives each delegate approximately 30 days in which to study all proposed changes to the Constitution and By-Laws and be ready to vote intelligently on each. The brochures will contain the Constitution and By-Law proposals which were tabled in 1984 plus all proposals submitted for 1985 which were approved for submission to the delegates.

July 1, 1985. Each President shall return one copy of the list to the Sec.-Treas., NHPA and indicate thereon the delegates and alternates from his charter. This list will be used for controlled access to the convention floor by Bernard Herfurth, Credentials Chairman, who will be assisted by Hazel Shuck. Identification as a delegate will be required. Each delegate is responsible for bringing his/her brochure to the convention. There will be no additional brochures available at the World Tournament.

If your President's recommendations for 1984 (which were tabled) are brought back to the floor, the convention will be long. Using the above system, the delegates can come to the convention prepared to vote 'yes' or 'no.' If they are not happy with the proposals as written, rather than proposing amendments to them, it is suggested they wait and submit **their** proposals the following year.

NOTICE TO ALL WOMEN, JUNIOR GIRLS & JUNIOR BOYS

The Executive Council was asked to resolve the question of whether the ladies had to comply with playing rule 7, section e and rule 8, section b, page 21 of the Constitution and By-Laws. The Council voted yes.

Rule 7, Section e states: A player, while not pitching, must remain on the opposite side of the state to the player who is pitching, and on the rear one-fourth of the pitcher's platform, back of the stake. If standing back of the pitching platform, the toe of one foot must remain on the rear one-fourth of the platform.

Rule 8, section b states: In pitching shoe, the pitcher shall stand on the pitcher's platform, at one side or other of the stake. (The above ruling applies to Junior Girls also.)

The executive Council was asked if the Junior Boys had to comply with the above two rules.

The Council voted no, because the boys are working their way back to 40 feet. However, the pitcher's opponent must stand behind the pitcher and on the opposite side of the stake.

The Council recommends that if the ladies wish to change this rule to one which allows them to pitch from any distance back of the foul line, and require their opponents to be a minimum of 3 feet behind them and on the opposite side of the court, a change to the rules should be proposed at the '86 convention.

DAVE'S COURT REPORT

In the April issue I asked pitchers to "Stake Your Claim" if they had pitched a perfect game in sanctioned play. Unfortunately, the response to that request has been poor. Only four claims have been submitted.

A committee of well known pitchers was established by Glen Portt to determine the guidelines for official recognition of a perfect game. It was felt that the NHPA should keep a record of all perfect games known to have been pitched in a sanctioned tournament. The two pitched in W.T. play are a matter of public record. However, those pitched in local or State tournaments often don't get recognized out of their general area. My request to "Stake Your Claim" was an attempt to bring the accomplishment to a level of national recognition.

The committee will soon give its recommendations to the NHPA president. Shortly thereafter, the executive council will make its decision on perfect game qualifications and how to recognize the accomplishment. Unfortunately, unless more claims are submitted very few pitchers are going to get the recognition they deserve. In addition to the W.T. games of Zimmerman and Hohl, I have heard that the following people have pitched perfect games: Walter Ray Williams, Mark Seibold, Donnie Roberts, Clyde Martz, Carl Steinfeldt, Earl Winston, Kevin Cone and Jr. pitcher Bob Allen. Only copies of the games by Williams and Allen have been submitted for national recognition. If you are one of the above mentioned pitchers, or a friend, or know of someone else who has pitched a perfect game, please write to me with substantiation. The required details and the address for mailing are mentioned in my article published in the April issue of the News Digest.

World Tournament. As most members know, the 1985 World Tournament will be held Lafayette, Indiana,former site of the 1975 event. Great plans are being made to make the 1985 World Tournament a big success. NHPA Publicity estimates an entry list of 650 to 700 pitchers.

Horseshoes and Bowling. NHPA Publicity has a plan to try to work with the National Bowling Association to further our increase in membership. I personally met with three National officers who were touring the east. They were not negative to my plan to contact their Public Relations Director in regards to understanding how they acquired a huge membership and also to use their hundreds of bulletin boards in the Spring-of-the-Year regarding horseshoe pitching activities. Bowling has much in common to our sport. I will not contact the Public Relations Director until I get the thoughts of our Executive Council.

NHPA PROMOTION COMMITTEE REPORT

We learn more from our failures than we do from our successes. The following is a list of many of our failures and opportunities that we failed to take advantage of and opportunities that we failed to follow thru on.

The first major failure that I'm aware of took place in 1949. NHPA Pres. Arlo Harris spent many hours working out a deal with General Motors to hold the 1950 World Championship at the Indianapolis Fairgrounds. The executive council voted not to move the 1950 tournament from Murray, Utah. The deal fell thru, also tentative deal with Sears for 1951.

In the 1960's Miller Beer supplied the trophies for the World Championship and State Championships. They discontinued the practice when they were told that they could not put up posters at the World Championships because they were held in public parks.

The World Championship in 1971 was held in Middlesex, NJ. Schaefer Beer helped sponsor the tournament. The sale of beer made the tournament a financial success. The annual dinner was free to all contestants and their families. 3,000 to 4,000 people attended the tournament daily. Schaefer beer said they'd sponsor the next tournament at Middlesex. Middlesex tried three times to get the tournament but never did get it.

The professional horseshoe pitching assoc. was formed in 1971. They failed because they didn't hire professional help.

In 1976 I was successful in interesting Michael O'Hara (O'Hara Management) in promoting horseshoes. He arranged to have Joe Goldstein Public Relations handle our publicity for three years (1976-1977 & 1978).

Mr. Goldstein gave us excellent nationwide T.V. newspaper and magazine coverage. He was successful in getting Debbie Michaud an invitation to compete on Superstars. He was unable to compete. He was working on getting us on Wide World of Sports and had several soft drinks interested when his service was terminated.

Michael O'Hara arranged a meeting with Richard Moore, V.P. of International Management Group. They had Civitan interested in sponsoring tournaments. We were unable to find tournaments where we could charge admission.

In 1979 I contacted ESPN-TV while they were still in the planning stage. They have blossomed into America's biggest cable network. They offered to cover the 1980 Tournament in Huntsville and pay us \$1,000. The executive council failed to act promptly and we lost the coverage.

In 1984 I initiated the Wheaties Search for Champions II contest. We failed again. With over 8,000 NHPA members were were only able to submit 2,355 ballots for which we received \$2,355. With a little effort we could have realized as much as \$11,000 and Boni Boser's picture on the cover of over 1,000,000 boxes of Wheaties.

I met with P.J. Johnson of International Management Group in October, 1984 and later arranged a meeting for Pres. Glen Portt. They were interested in promoting horseshoes. The executive council voted against the promotion.

The failure in Springfield, Mo. this year could probably have been avoided if our constitution and by-laws was more specific as to facilities and details of payment of the bid. Qutoe Article VI Section 4 (to be eligible to get the bid) The facilities available for conducting the tournament are stated.

I believe the constitution should state what facilities are necessary. The winning bid should include down payment of at least \$5,000 that would be forfeited if the bidder failed to meet the contract agreement.

WALLY SHIPLEY — PRESIDENT EMERITUS, NHPA

Webster's Third New International Dictionary defines Emeritus as an honorary title bestowed upon one retired from a position of merit. The adjective Emeritus is not misused here, for horseshoe pitching involves a lifetime of learning, a period of self-schooling that leads to better pitching. Wally has had a firm hand in directing the course of the NHPA during the past ten years, whether or not actually engaged in teaching per se.

Wally is not boastful of his many years of service to the NHPA even though his colorful red and white jacket is emblazoned with reminders of that fact. He is grateful for having been permitted to serve those many years in a meaningful way.

Wally never dreamed that his fantastic sport and its members would bestow the following four greatly esteemed honors upon him, and he continues to be touched deeply by being so honored: In 1957, accepted as an NHPA member; in 1970, granted the Stokes Memorial Award (second highest award in the sport), for having contributed most to the development of the game during the past year; in 1973, elected NHPA president and, with popular consent, held the position for ten years; in 1979, inducted into the NHPA Hall of Fame, an honor given in recognition of significant and outstanding contributions to the game in an administrative capacity.

Incidentally, 1985 was Wally's 20th consecutive year attending and pitching in the Valley of the Sun tournament in Mesa, Arizona; obviously a favorite haunt.

He has not detoured far, if at all, from participating in worthwhile activity for the good of the sport. Today, he continues to serve in a conspicuous, helpful manner as a designated distributor of Game Related Items. His stand set up at the Mesa games could be called a bazar, a one-table bazar covered with orderly rows of paraphernalia needed to make the possessor at least appear to be a professional pitcher.

Besides selling items through his set-up bazars at tournaments, Wally does a substantial mail order business. From his deep reservoir of thoughtfulness, ever mindful of his goal to proliferate and perpetuate the sport, he mails out to each new customer (non-members of the NHPA), league books, By-Laws, NHPA Flyers and the name and address of the customer's State Secretary of the NHPA.

Not only do his goods present a tempting array, but Sally, his helpful, cheerful wife, lends a pleasing note of affability to the sales force of two. Sally's abilities lie not only in salesmanship, but in her homespun, wholesome way, makes delicious looking noontime sandwiches on a corner of the same table, with a side dish of hard boiled eggs.

It is a trifling detail to mention that Wally learned his ABC's and the Times Tables in a little one-room school house in a little one-horse town in Nebraska. This was away back in the era that brought forth the then-great invention, the fountain pen, by Schaefer, Conklin and Parker.

The call of the West beckoned this lad at age 18 and California became his new home state. His first association with organized horseshoes came in 1957 when he joined the National as well as Southern California's pitching group. It is known that, for a while, Wally was an 'A' pitcher (would you ever believe it?), but like so many others, he is no more.

After thirty five years of responsibility with Pacific Telephone, he retired in 1983 from his last niche in the company, that of Administrative Services Manager.

When the cry of the game is to get and and to keep motivated people to further the sport of horseshoe pitching, Wally voluntarily is setting a continuing and enviable example of encouragement that cannot be denied. To engage conspicuously in the distribution of horseshoe pitching items may appear, to some, as crums after the banquet, but to him, it is a means of keeping in close touch with individuals themselves, the ones who throw the shoes. This is the utmost in conscientious service and concern for a beleaguered sport.

TIPS FROM THE TOP

By SOL BERMAN

John Rademacher — The back swing is more important than the front swing if it is not right, the front swing will have to be forced, and ringers will be harder to come by. Keep your eye on the stake, and do not flaten the shoe prematurely, but try to drag the shoe thru the swing.

Jim Solomon — I continue to watch the top of the stake and do not watch the shoe in flight. In this way I am aware only of the stake. It helps to keep out of my mind all interferences, the spectators, my opponent, the score or the situation.

Danny Kuchcinski — Generally speaking, a shoe that turns too much may be slowed down either by pitching it lower or leveling it up sooner. A shoe that turns too little may be speeded up either by pitching it higher or waiting longer to level it up.

Bob West — As you prepare to pitch your horseshoe, glance down at your feet to see that they are pointed directly at the opposite peg.

Don Titcomb - Attempting to hold the shoe flat through the swing will destroy the alignment.

Sam Sutton - I aim at the top of the stake, step straight at the stake and keep my eye on the stake throughout the complete delivery.

Donnie Roberts — Don't get all uptight during a game. This causes you to pitch much worse than your normal ability.

Bill Henn — Relax and pitch your game even if your opponent is pitching 80 or 90 percent. If you tighten up you will pitch short.

Sol Berman, M.D. — Alignment and depth perception. Depth percention or the ability to judge distance depends on good vision in both eyes. With poor or no vision in one eye, pitching a lower shoe will help. The higher you pitch a shoe the more you depend on depth perception.

With no vision in the right eye, a right handed pitcher would benefit by pitching from right side of the stake. If you have poor vision in one eye that can be corrected by eye glasses, you'll find that your depth perception and alignment will improve.

HE WAS THERE!

From WW I in 1918 through WW II, Korea and Viet Nam, NHPA men and women served their country faithfully and honorably. Many of their stories will never be told because many made the supreme sacrifice. They never came back. This is the true story of one who did.

January 6, 1945. A B-17 Flying Fortress heavily loaded with bombs lumbered down the fog covered runway on the fortress island of England and, as it came to the end, slipped gracefully into the air and disappeared out of sight. It climbed steadily and at 15,000 feet broke through the overcast and joined a stream of others for an attack on Hitler's Germany. "Captain to crew. This is our 35th mission and if all goes well, we'll be back in the statess next week. Good luck to each of you." "Tailgunner, do you have it with you?" "Yes, sir, Captain. Wouldn't fly without it." The captain could hear the crew chuckling over the interphones. "Well, it's carried us through 34. Guess it's good for one more." "Yes, sir, Captain. It sure is."

The Captain thought back to the day his green crew was assembled, the ceaseless hours of training they had gone through together, and particularly about his young 18 year old tail gunner. He remembered their first mission. As he lined them up under the wing and checked each crew member's equipment, he came to the tail gunner.

"What in 'H' have you got in there?"

"A horseshoe, sir."

"A horseshoe?"

"Yes, sir. I feel it's lucky and I'm going to carry it on every mission. That is, with your O.K., sir."

"Lucky? Well, okay. We'll see."

After completing 10 missions and returning from almost every one with considerable flak damage but with no crew casualties, the B-17 was christened 'The Lucky Horseshoe' and there was no way it would leave the ground without that good luck omen. The entire crew saw to that.

The B-17's 4 engines purred in complete synchronization as it neared its target, Ludwigshafen. Fighters were now making passes at the formation from every angle and the innocent looking black puffs containing the

deadly shrapnel were becoming increasingly heavy and closer and closer. A B-17 off the left wing took a direct hit and started spiraling downward. The Captain counted silently—one—two—three—four. Four parachutes. Only four. Intelligence would want to know that. He had seen many B-17's go down and could not help wondering if there might not be something to that horseshoe bit. After all, it had carried them through 34 missions.

At that instant the plane was hit. Number 4 engine burst into flames and number 2, minus a propeller, was quickly shut down. The plane left formation and like a crippled bird started downward.

"Navigator, give me a heading."

"Heading 270°. Laone, France."

"Engineer?"

"Don't know, sir. With 2 engines out and another failing, I don't think we can stay airborne too long. Fire's out on number 4." "Captain to crew. Any wounded?"

As negative reports came in, he could not help thinking that their luck still held in that area. As he nursed the plane along, it gradually lost allitude. "Captain to crew. I don't think we're going to make it. You can bail out now over enemy territory or take your chances on a crash landing." "Captain from tail gunner. Captain, we're going to make it. I got our luck right here in my hand. I'm staying." "Me, too" was heard from every crew member.

The 'Lucky Horseshoe' did make it with a crash landing at Laone on 'a wing and a prayer' as the saying goes. But every member of the crew added 'and a horseshoe.'

January 31, 1945. Our tail gunner, now 20 years old, a hardened veteran of 35 combat missions, is back in the states and upon discharge, quickly turned to horseshoes, the game he learned when he was just 16 as a protege of Alvin Gandy. For 40 years, this NHPA member has promoted the sport in his own home state, has directed an annual event for 31 consecutive years, has pitched in 'A' class in many W.T.'s and is a member of the lowa Hall of Fame. His name? You'll find it somewhere in this issue.

A PRO'S CORNER... A GAME OF HORSESHOES

When I visit a fellow horseshoe player, we usually play a game of horseshoes. What kind of game? Sometimes cancellation and sometimes count-all. Most horseshoe players realize that there are several ways to play a game of horseshoes. In the World Tournament, the official game is 40 point cancellation. A few years ago, it used to be 50 point cancellation. Many players, including myself, have been trying to shorten the length of a

game of horseshoes because they feel that the games are too long and drawn out. Still, a good number of players prefer the "marathon" games of yesterday.

It is my opinion that tournaments are conducted to see who the best horseshoe players are for that particular time and place. It might be said that some tournaments are not won by the best players in those tournaments. But for the rules of that particular tournament, the champion did the best at meeting the requirements.

In competition, I feel that the person who has the best average should be declared the winner of a tournament or class. I believe that I am not the only person who feels this way. However, tournaments are conducted on a match play system. In other words, the player who wins the most matches is considered the best, which does make some sense. In most tournaments, the title usually comes down to one or two particular matches out of the entire tournament played, which can make for an exciting finish if those key matches are scheduled at the end of the tournament. There are, however, other ways to run a tournament.

One way is based on count-all games. There have been a couple of tournaments which used this idea, but with 50 shoe games were ringers count 1 point. Even though I think that this is a better system, I think that these tournaments could be improved upon.

My biggest complaint is that the ringer is counted as 1 point. I understand the reason for using it, but it is only practical for the better players. I believe that the same format should be used for all levels of players (no discriminatino). If a ringer counts 1 point system were used for beginners, the low scores might prevent them from continuing in what I consider one of the toughest sports to learn. With the count-all system (3 for a ringer, 1 for a close shoe), a beginner can usually score a few points. I believe that the phrase "close counts in horseshoes" is a trademark which every non-horseshoe player can identify with our sport.

Another complaint I have is with the tournament scoring system. In determining who the winner was, the scores were tabulated to the formula of all ringers totaled together plus 3 points for each 50 shoe match won. My personal opinion is that the matches should have been worth at least 8 if not 10 points. I also believe that in the event of a tie, the bonus should be split and added to the players totals respectfully. My reason for the higher bonus points is because the other system (cancellation) we use gives the equivalent of a million points for each win and the percentage then breaks any ties. I believe that the players and officials who decided the bonus point value didn't think about that.

It also bothers me to pitch at one stake one more time than at the other stake. I know that seems pretty insignificant, but it throws off a possible symmetry. I also believe that the games are statistically too long. In a regulation 40 point cancellation game, only about 30 players have a slim chance of defeating the very top players. Even for a 50 shoe game, the number of players who have even a slim chance of defeating one of the top players us about 40. However, if the game was to 20 shoes, the number of players who would have a slim chance of defeating one of the top players would jump to over 100. This would mean many more upsets in the tournaments. Again however, most people think that a 20 shoe game is way too short for competition. However, with shorter games, more games could be played enabling playing more people or more "grudge" matches. One big advantage of the count-all system is that the scores will always be closer than a cancellation game and shut-outs would not occur except possibly in a beginner's class. Another advantage of the count-all system is the ease of which a handicap can be applied.

No matter how the game of horseshoes is played, I think it is the best competitive sport to play. I do believe that if we are to get any serious money into this sport, we have to make it more appealing to the spectators. And the count-all system is much easier to understand than the cancellation system.
