

FROM YOUR PRESIDENT — DAVE LOUCKS

If people contribute money to a common cause, then their interests are also common. With this comes a reasonable expectation that a voice will be allowed to speak for the common good. That voice is the ballot. In the absence of a vote the individuals who are selected to represent the common good must be benevolent enough to seek the best possible cause of action that in fact represents the greatest good for the greatest number. That group is and has been the delegate assembly! It doesn't work, and the record is very clear!!

A delegate must be present at the World Tournament to have that voice. If delegates are nested from one geographic region, then that is the voice that speaks. A simple majority becomes a very powerful voice at the World Tournament. They may not care about the common good, rather only what is good for them! Keep it close to home.

If the game is going to grow because of the common interest, then a voice by way of a vote is going to be the order of business to survive. Who wants to contribute time and money without a voice in the common good?

The Executive Council has the need to make decisions without the delegate assembly vote just as the NHPA member in Good Grief, Idaho, needs the council to protect his time and money in the common good for the greatest number of members.

This writer would much rather place major decisions affecting the NHPA upon the Council if they were placed there with a vote by every card holder who chose to express his franchise...the right to be governed by a vote and the simple majority of all.

The time is long overdue to organize our decisions through the Executive Council. That group should be placed in office by a national vote of card holders. Give them the responsibility to run the show and allow them to operate in the best interest of the common good...by John Huntzinger, Editor and Publisher of the Double Ringer, Windsor, Colorado.

Thanks John for telling it like it is and allowing me permission to reprint your article which appeared in the January issue of Double Ringer. I only hope the majority of delegates in Ainsworth will have read and remembered this article when they vote. Anticipating initial support from the Constitution and By-Laws Committee, I plan to present a Proxy Vote amendment to the delegates in Convention. All members must be represented!

ENTRY FEE MUST BE ENCLOSED!! Juniors are free. All adults regardless of division must send \$25.00.

It is very important that you enter the correct division. Any male regardless of age may enter the Men's division. Any female regardless of age may enter the Women's division. Juniors who enter the adult divisions must pitch the adult distance and will forfeit their junior standing. If you are 17 years old or younger on or after January 1, 1986 you may enter the Junior divisions. You may enter the Intermediate division if you are between 59 and 66 years of age by July 20, 1986. That is you must be 60, 61, 62, 63, 64, or 65 years old as of July 20, 1986 to enter the Intermediates. To enter the Senior division you must be 66 years old or older by July 20, 1986. If you become 66 during the tournament you will be allowed to finish the competition in the Intermediates and may not enter the Seniors until 1987. To enter the 70 and older division you must be 70 years of age by July 20, 1986. The 70 and older division may pitch any distance from 30 feet on back. Please *Circle* the division you are entering. RINGERS REMEMBERED

The two current NHPA officers who have perfect records in Jr. Boy's World Tournament Championship Division play are 1951, 1952-1953 Jr. World Champion, President of the NHPA, Dave Loucks, with a 15-0 record and NHPA Sec.-Tres. Donnie Roberts, 1959 Jr. Boy's World Champ with a 7-0 career record.

Two perfect games to report. The first one by 3rd place World Women's finisher Debbie Pickering of New Hampshire. She pitched an 18 shoe perfect game on August 17, 1985. Congratulations Debbie!

The other is by a man who won the 1935 Men's class B World title with a 22-1 record and 68.3% average. He won the Missouri State title three times. He was inducted into the Missouri Horseshoe Pitcher's Hall of Fame in 1985. This great athlete is probably the only person to ever accomplish 4 "perfects." His 22 shoe perfect game in August 1941 at the MO State Fair, a 300 game in a sanctioned bowling tournament, a 9 inning no-hitter in baseball and a hole-in-one in golf on a 318 yard par four. This outstanding individual: Bob Bales of Kansas City, MO, born June 1, 1909, died January 27, 1986, is truly a ringer remembered.

This month's "trivia question" comes from Hugo Lenz of Wheatland, Wyoming: When is the only time in World Tournament history that two different men from the same hometown won the World Championship back to back?

Are you doing your job? As 5th V.P. of the NHPA Regional Directors are under my leadership and the guidelines require that activity reports be made to me. Activities in your regions and your involvement in your respective regions.

I am pleased to say that there are RD's that have sent in reports but there are also those of you that have neglected your obligation for whatever reason. I am printing reports from those few who have sent their activity summary to me. It is my hope that others will follow suit and let us know what is going on in their areas.

JIM SCHILLING: REGION #12, INDIANA — The Tournament of Champions under the direction of three Regional Directors from Indiana, Michigan and Illinois had 89 entries, a big increase over previous years. Camp Atterbury will be the permanent site. The name Midwest Invitational has been suggested as a name change.

REGIONAL DIRECTORS REPORT — (Continued)

The **1986 Indiana State Fair Tournament** will be under the leadership of Dve Herring.

Jim Shilling appeared on Fort Wayne television twice promoting horseshoes. He also helped in organizing three new clubs. Increased the number of indoor courts from four to six at Metters. He has sold new memberships and has horseshoes and game related items available. Jim says, "Remember, if you want to keep a horseshoe pitcher pitching, just inflate his or her ego."

DON KOSO: REGION #14, NEBR. & WEST. NEBR. & IOWA attended the Iowa State tournament as RD for the region and as an NHPA representative. Listed in the "Educators Index of Free Materials." This publication is nation wide covering public schools. Distributes all related publications to schools for distribution to children. An Introduction to the National Horseshoe Pitchers Association. Working hard along with Al Hodges to make the W.T. in Ainsworth a success.

LEN LIPOVSKY: REGION #9, MINNESOTA — I was a little skeptical about playing on the non-clay portable courts at **State Tournament**. Much to my surprise, these courts were more fun to play on. We could not have held our State Tournament this year outside because of the steady rains. Ringer % in most cases was better than clay courts. Most of the time clay courts are not in good condition anyway. Pitchers don't like to dig up their own courts! Met with some Minn. State Officers for a discussion on the sportsmanship end of our sport. An area that should be improved.

CLARENCE GILES, REGION #10, UTAH & ARIZONA — Yuma, Arizona has now completed 27 courts in Kennedy Park, in Yuma. Assistant RD's Sam & Shirley Finfrock of Welton, Ariz. work as a team in joint capacity. Do any other regions have husband and wife teams?

Reports such as these published in the Digest is a great tool in overcoming the communication gap that the NHPA experiences. By the very nature of our geographical areas communication is a problem and the Digest is our media for talking to all of our members. I believe that the RD program was started for just such a purpose and I would hope that ALL RD's will make every effort to let us all know what is going on in their parts of the country.

Effective January 1, 1986 I appointed Les Burroughs of Perris, Calif. as Regional Director for Region #25, Southern Calif., Eastern Sierra Calif., Nevada and Hawaii. These were the charters and regions that I was serving as their Director but in my new capacity as 5th V.P. my new duties dictated that I appoint a new RD.

If I asked you, "Who is Phyllis Negaard?" or Debby Michaud... or Vicki Winston... or Ruth Hangen... you'd tell me in a minute! But Diane Cantin? Well, Diane is a 'Quebecoise' who came to our '85 World Tournament with little if any publicity... and almost walked away with it all.

DIANE CANTIN — (Continued)

When I think of Quebec, I can still hear my 8th grade history telling us how Jacques Cartier in 1535 sailed up the St. Lawrence and discovered an overhanging 350 ft. cliff, almost straight up. Surprised, he exclaimed, "Quebec!" (what a beak!)... and from that incident, the city, which built upon it, and around it, took the name of Quebec. And how, 224 years later in 1759, General Wolfe, with an army of 8000 men or so, carried out the most daring project ever conceived by a military commander by scaling those same cliffs under cover of darkness, attacking the French from the rear, and defeating them on the Plains of Abraham. (Is there a boy alive who did not imagine himself scaling those same cliffs and defeating the enemy in glorious battle?) Shortly afterward, the whole of Canada was ceded to the British.

Quebec, today, is still about 80% or more French... and Diane, living close by in St. Raymond with her husband and children, is one whose ancestors were some of the earliest settlers. Diane started pitching horseshoes with her sister in 1978. She soon found that she enjoyed it so much that she began pitching in local festivals and tournaments. In 1979, she entered the Provincial Tournament (Province of Quebec)... and won. From then on, she never looked back. In 1980, she placed 10th in the Canadian Championships and from 1981 thru 1985, she finished first.

This 'Quebecoise' finished second with the second highest ringer average ever thrown in the women's division...83.3%...second only to Phyllis Negaard's world record of 84.1.

Will this gracious lady be able to travel the 1900 miles to compete at Ainsworth in July? I hope so. The NHPA needs her. With Michaud, Negaard, Winston, Hangen, Carnahan, and Pickering standing in her way, could her dream of a World's Championship possibly come true? The odds are against it...but don't bet that it can't!

HORSESHOE PALLADIUM A UNIQUE SPORTS OPPORTUNITY

"People think that if something's never done, it can't be done," said John Davis, president of Sports Enterprises Inc. and the soon-to-be-built Horseshoe Palladium.

What Davis is referring to is an enormous (\$1.5 million) indoor horseshoe

pitching facility complete with snack bar, fine restaurant, media pod, game rooms, conference room, first aid and emergency facilities, daycare, electronic scoreboards posted throughout the building, a pro shop, instructors and a resident pro. The building is designed so the related facilities will be located on a glass-front mezzanine overlooking 60 courts.

To the uninitiated, pitching horseshoes is a barnyard sport or something to do at a Sunday afternoon picnic. To the initiated, horseshoe pitching is a league sport or a profession. Prize money eventually will be comparable to professional bowling and golf, Davis said.

Many of the better players are executives, doctors and professors. The leading horseshoe authority on the subject is a retired judge from the Cincinnati area. The sport appeals to young and old, male and female, and skilled and unskilled.

"Pitching horseshoes is probably more difficult than golf," said Davis. "A horseshoe has a three-inch opening on one side, and you're throwing it forty feet at a high rate of speed. For a good pitcher, 60-90 percent of their throws are ringers. It's a technical sport."

Davis has been researching the horseshoe market for nearly 15 years. He's done the national demographics and reports that Ohio, along with several other states, is a top horseshoe market. There are 30 million pitchers in the country. "It's the largest untapped market any business has ever ventured into," Davis said. "Many people like to play horseshoes, but they've had to play outdoors until now. We're engaged in an enormous undertaking, but if we were operational right now, I believe we could fill the house."

Sports Enterprises Inc., is an investment company which plans to franchise operations first throughout the state, then throughout the country, after their pilot facility is operational. The projected opening date is June or July.

We are close to obtaining our 36,500 square foot building in Stow, Ohio and are very excited at the prospect of opening this year.







THE OLD PITCHER'S LAMENT**By STEWART SNYDER**

Exhaustion! Even with no recognizable body defects, OLD horseshoe pitchers (age 80, plus or minus) just play out, become pooped more and more as the day goes by waiting to pitch in their afternoon group. When they finally do pitch, the loss of coordination and concentration brings down the ringer percentage, and this assures, further, the late-playing berth.

More often than not there's no opportunity to lie down for an hour's snooze to recharge the OLD battery, what with scorekeeping, pit turning and picking up trash carelessly thrown down by thoughtless pitchers. A pitcher rarely knows in advance his time to pitch, hence cannot defer his arrival.

Now! Here's where the rub comes — the later in the day the OLD man pitches the poorer he pitches because he's tired already, and the poorer he pitches the lower his ringer percentage and the low percentage assures him a continuous stand in afternoon competition (in succeeding tournaments) when the sun is high and the breeze is gone; same with shade.


I've already said, the later the hour, the more tired he is and the poorer he pitches and the lower his ringer percentage. It's a vicious cycle, seemingly beyond the OLD guy's control. Perhaps, to fully express his status for all to more fully comprehend, he could carry a scythe over his shoulder as he mopes listlessly around the courts. The vicious cycle seems to be unchangeable, BUT, the consensus of opinion is, "It would be nice to be allowed to pitch first in fresh morning hours."

It has been a standard procedure, it seems, in tournament planning, to have the younger, high percentage pitchers perform first, in cool morning air while shade covers the courts by the sun's low slant over surrounding trees. Early in the morning these high percentage pitchers are full of vinegar, having only recently got out of bed, fresh in early-day air before summer's sun starts to take its toll... as if saving its heat for the clumsy OLD duffers who have drawn an afternoon berth in the pitching schedule... percentage gets the mark of acknowledgment over age.

Time comes to all pitchers, I'm sure, when enough's enough. There are but few fortunate, super humans who are spared the debilitation so apparent in most of their octogenarian colleagues. Some know when to quit, others suffer along pitching, disdaining the down-slump in which they unwittingly find themselves—magnetism of the game is not easily denied; it keeps many an oldster in there pitchin', nonetheless.






