

2023 President's Message NHPA Council Is Fully Staffed By Gary B. Roberts, NHPA President

As you read this, we are approaching the end of 2023. There have been many changes during the year. First, we have had many changes in the Council membership. Jim Kinney, Jr. resigned as Secretary/Treasurer and was replaced by Brian Poole who was the First Vice President at the time. Jim has been very receptive in helping Brian with necessary training. Austin Bailey, who was elected as Fourth Vice President, moved to the First Vice President position. Austin was



very interested in working with the Rules/Bylaws area. Jerry Smith retired as of December 31, 2023. Ben Webb of Kentucky was voted by the Council to replace Jerry. Jerry will provide necessary training for Ben. The council also voted to retain Barb Carson as the Fourth Vice President. Her experience will assist the council during this transition in many Council positions.

One bright spot of the year was the World Tournament held in Lansing, Michigan. The facility and the closeness of adequate hotel rooms nearby was very convenient. Our Lansing hosts were exceptional. Anything we needed was provided to make our stay very successful. The attendance exceeded expectations as we received 947 entries. The result was some excellent pitching in all divisions. We should not forget our set-up crew who had all the courts available for starting time. Pep Plummer, Clarence Lassiter, Roger Vogel, and many Michigan charter members helped with this effort. We should also thank Empire Photography and Ron and Polly's Horseshoe Pitching Supplies for their presence at our tournament. Hopefully, Lansing will ask us to return in the future.

Another important happening was officially designating the 2024 World Tournament to Tri-Cities (Kennewick) Washington. Our old friend, Kevin Lewis, is now the President and CEO of Tri-Cities Washington. As many of you know, Kevin was our host for the St. George Tournaments. We will be happy to work with Kevin and his staff. The Council has been working on the details of this tournament. Kevin will be willing to host another Tournament in 2027. Shortly thereafter, the 2025 World Tournament was awarded to Salt Lake City, Utah. This will be one of the most beautiful settings you have visited. The Tournament will be held at the Mountain America Exposition Center in the Sandy area. If you have time, please look at the facility on the Internet. Salt Lake City will be willing to host another Tournament in 2028.

The bad thing that happened in 2023 was the continued decline in membership and the lack of new Junior pitchers. The ability to change this decline relates to the NHPA, State charters, and local clubs. One of our major efforts in 2024 will be to look at any ideas that could have a major impact on membership. We can look at areas who have increased membership and those that have successful clubs.

Two new rules were passed in 2023 that are worthy of discussion. One rule was allowing women over 65 to pitch up to the 20' line. This will be voted on at the 2024 Convention as to the experimental results that we obtain prior to that date. We are working on tracking the results of this experiment on e-shoe. In Ohio, we are already tracking all such people to get credible data. Another rule was allowing people from one State to play in the State Tournament of another state under certain difficult circumstances. Difficult circumstances could be driving a long distance in your state when you live and pitch in a neighboring State. Also, people who live in more than one State may choose which state they want to pitch in. The Council has decided that a pitcher should submit evidence as to why they want to pitch in a neighboring State. This rule was not implemented to allow people to switch to another State just because they have a problem with their home State. Let's see how this goes.

As the year of 2023 comes to an end, I would like to wish everyone a Merry Christmas and a healthy and prosperous 2024.

Jerry Smith—A Remarkable Member of the NHPA

Jerry Smith has been a member of the NHPA Council since July 2014 and has resigned as of December 31, 2023. None of us are happy to see him go. Once you meet Jerry, you realize that you are dealing with a person who loves our sport, and one who has spent many hours of his life helping to support it.

Jerry, a native Ohioan, was married to Diane who passed away on July 14, 2019. This was a very tragic event for Jerry. Jerry and Diane had two children, Douglas (Yanette), who resided in California with Jerry's special grandchildren, Howie, who is still in high school and Kayla who is on her own. His daughter and her husband Rob, reside with Jerry in Reynoldsburg, Ohio with two other special grandchildren, Savannah, and Olivia. His daughter also has an older grandchild, Rebecca, who resides in Chico, California.

Jerry graduated from West Liberty Salem High School in Logan County, Ohio in 1964. Jerry was a good athlete and played on the varsity football team in every game throughout all four years of high school as a running back and was also the captain of the team his Senior year. His speed also helped in track and Jerry still holds the school record of 10.3 seconds in the 100-yard dash. After high school, Jerry attended Ohio State University for 11 quarters and later graduated from the University of San Francisco with a degree in public administration.

You may hear us referring to Jerry as the "warden" because of his career working in the Department of Corrections. He started his career in California in 1974 as a Supervisor for Correctional Industries, and then became a Vocational Instructor and followed that by becoming a Supervisor of Vocational Instruction (Principle). When a new prison opened in Vacaville, California, Jerry became responsible for over 20 Vocational Programs. He continued in this capacity for the next 19 years until he retired.

Jerry's contact with formal horseshoe pitching was accidental. He was practicing pitching horseshoes in a park when a NHPA member told him there were 24 horseshoe courts with clay only 8 miles away. Jerry discovered that the Yolo Horseshoe Club operated this facility. He went there in 1985 and then became

President in 1986. Jerry was a natural administrator and ended up running several California State Tournaments and was also a statistician. In 1989 the California State Tournament had about 350 pitchers. Once Jerry retired from the Department of Corrections, he moved to Idaho in 2004. He became the Secretary/ Treasurer there and ran several state tournaments. He also became the newsletter editor as well as the statistician.

With all his experience, it is not surprising that Jerry became an NHPA Council member in 2014. As many of you know Jerry has been very active as the Sanctioned League Director. Jerry would like to thank Pat and Kevin Snelgrove for their help with this task. Jerry also ran the Sanctioned League Horseshoe Tournament for several years.

In his spare time, Jerry was involved with writing two horseshoe related books. He wrote the "World Horseshoe Tournament; Volume II" that updated the results of the World Tournament results since Gary Kline's Volume I. He also wrote "The Legendary Don Titcomb: His Life, His Game, His Way". Both were very good books.

Because of Jerry's involvement in horseshoe pitching, he has been rewarded many times for his efforts as follows:

- 1995 Jerry was inducted into the Yolo HPC's Hall of Fame
- 1999 Jerry was inducted into Northern California Hall of Fame
- 2012 Jerry received the NHPA Achievement Award
- 2013 Jerry was appointed to the NHPA Hall of Fame Committee
- 2018 Jerry was inducted into the Idaho Hall of Fame
- 2018 Jerry received the coveted Stokes Award
- 2018 Jerry became an NHPF Board Member
- 2019 Jerry is appointed as NHPA Historian
- 2023 Jerry was inducted into the NHPA Hall of Fame

As I prepared this article, I am amazed at the time and effort Jerry has contributed to our sport. Fortunately, although he will not be on the Council, he will be available in his other duties. Jerry is truly a remarkable member of the NHPA.

SETTING GOALS FOR MEMBERSHIP IN 2024/CLUB MEMBERSHIP IDEAS and SUGGESTIONS

We can never hear this enough, with a new pitching season upon us it's time to think of recruiting new members. So, what works in your club? We all are struggling to get new members out to play horseshoes. So, what do successful clubs do to attract new members? Others are getting the news out through their local newspapers in the "Community News Sections" or by using Social Media outlets, Brochures, etc. Contact your local newspaper and ask what the fee is to publish your weekly league results or a general message to announce your upcoming Horseshoe events.

You may be surprised that some newspapers do this as a "Free" service. Remember, most clubs are non- profit, and sometimes these things can be donated and/or used as a tax right off. Results of local tournaments or leagues are getting printed in the papers about players that won tournaments and championships. Submit your weekly results to be added with the other local sports, look for local sponsors to offset the expense of placing the ad in the paper on a weekly basis. It also helps to build a working relationship with your local Sports Editors.

Clubs are always looking for ways to grow and recruit new members, there are many things club members can do to attract new members. Here, you'll find a few viable approaches that a local club or organization could use to recruit more members.

- Simply ask someone, such as family members, co-workers.
- Update or improve your charter websites and have them linked to other sports groups or City Parks and Rec departments and city websites, state Travel and Tourism offices.
- Contact your state Travel and Tourism office (CVB), give a list of all the clubs in your state and physical addresses and GPS information and have them list it on their website. You never know who may be traveling through your state and want to stop and pitch in a tournament.
- If you have any local clubs such as a Rotary Clubs, Masonic Lodges, American Legions, your local schools, churches, send out invitations to pitch on one night a week. <u>"Club vs Club."</u>
- Create a Junior/Cadet group. Have your Junior Directors, if applicable, get into the schools and host a tournament/challenge between the Football Teams and Basketball Teams or other groups in the schools. "Club vs Club" format and bragging rights.
- Advertise in Newspapers & local T.V. Stations, Radio. Invite these same media people to your tournaments and leagues each week. Create a media contact list.
- Create your own Social Media pages and posts for your own clubs, and charters such as Facebook, Tik-Tok, Instagram, Twitter, etc. Create a Social Media director position in your clubs.
- Have open to the public tournaments. Anyone and any age can pitch,
- Have a booth at malls, local county and state fairs, festivals etc., also hold public exhibitions of pitching on portable pits.
- Place pamphlets/brochures in doctors' offices, hospitals, cafeterias, libraries, local grocery stores, convenience stores, or as inserts into your local newspaper, etc.
- Hold a membership drive, give prizes for the member that recruits the most members to join in a calendar year. Set a goal of how many new members you want to attract this year, Make it a goal.
- Send letters to people in the news with an invitation to visit the club when your hosting events. NHPA has a one-time sanctioned tournament with a "Free" trial membership, or you can try the provisional membership as an incentive.

PLEASE - UPDATE YOUR CONTACT INFORMATION WITH YOUR LOCAL CLUBS AND **CHARTERS**

With a new year around the corner and new officers on board, it's a good time to begin getting your "charter members" contact information updated with your charter books and record keeping and on your charter websites and social media pages. Many people do not have or want a computer, and cell phones can be tedious. It is a nice gesture to print out a hard copy of the current Newsline and share with your

members, so you can place a copy on the bulletin board at your local courts. Blaine Scott is the NHPA newline editor, and we have been discussing how many email addresses are getting kicked back/returned from not being corrected or updated. He has done some research recently to see how many people actually "READ" and receive the Newsline. He compared the numbers of how many people receive the Newsline and how many people do not receive it due to emails not being current or updated or that no longer are active with your charter secretaries. When this happens, the news and infor-

mation is not getting out to the charters and their members.

Here is what Blaine has found in his research:

The biggest issue is that people aore not taking the time and reading the messages in the Newsline. If 60% are not being read, there is a lot of information they don't know about. As a friendly reminder, I would like to encourage everyone to please check with your charter secretaries/treasurers to make sure that your contact information is updated, current and correct. It's your responsibility each year/ season to keep your contact information updated with your local clubs and

charters when things change. Most importantly for safety reasons, we would like to make sure that your mailing addresses, phone numbers and email addresses are correct and current so that everyone can receive the Newsline, and for your local clubs to also be able to contact a family member in case of an emergency. For the charters that need assistance or guidance with their current websites, here are a few suggestions.

We understand that not every charter or club has the finances, computers, technical background, or knowledge to create or maintain a charter website. Contact your local IT Department head at your local community college, university, and ask them to have their class assist your organization in setting up and maintaining your website, this will be a "FREE" service, or you can contact the NHPA Newsline editor Blaine Scott for assistance or the NHPA IT director Josh Olsen for suggestions and any technical questions or concerns you may have to get your charter website updated and current. The NHPA relies on the local charters and clubs for local information. We truly appreciate all your hard work.

Some people include a vacation when traveling to a World Horseshoe Tournament, some do not. However, for those that are die-hard attendees, here are some suggestions and recommendations to help you plan accordingly and hopefully keep you safe while traveling.

REMINDER: Passport Processing Time – U.S. State Department and TSA

Per TSA, Some people will travel domestically with a passport versus a "REAL ID" which is faster as well as getting Pre-TSA on your airline tickets to avoid long waiting lines. The Passport processing time can take as long as 11 weeks for routine requests and 7 weeks for expedited service. Be sure to give yourself plenty of time to get a valid passport before you travel whether you are traveling domestically or internationally. If you already have a passport, you will just need to "Renew" it or if you are applying

for the first time. You can drop by your local Post Office or go online at https://travel.state.gov/ and follow the instructions.

TRAVELING & SUGESSTED CELL PHONE APPS TO USE

Traveling to and through various time zones whether you are flying or driving can take a toll. For safety purposes, here are a few suggestions to help you along your journey. If you have AAA or any other travel companies that you use when traveling, contact them as well to get the most current and updated information on the highways.

There are also apps you can download on your cell phone that you may need while you travel or on vacation that you may not know about! Here are some suggestions:

<u>Citymapper</u>: This one helps you find the fastest route to your destination, even giving you step-by-step instructions on where to find the nearest bus or train station. I find this really helpful when you're in a new city and you have to navigate new transportation.

When we travel by car, truck etc., we try to stay hydrated and we tend to consume liquids such as water, coffee, sodas, etc. When traveling with children you will always need to locate a bathroom at some point. Here is an app to help you with that.

Flush: Trying to find a public bathroom in a new place is tough. This app has a database of more than 200,000 bathrooms and it'll let you know where the closest one is to you, even without an internet connection. It also lists which ones you can use for free, which ones need a key and which ones will make you pay.

Now, depending on your destination, "jet lag" can be an issue for some people. Here is an app that you can download on your cell phone to help you avoid jet lag.

Timeshifter: This app helps you avoid the jet lag battle. It gives you personalized recommendations on when you should sleep, avoid sunlight and coffee, etc. You can enter your flight information and details and it will do all the work for you. You can try the app "**Free**" for the first trip you take.

RV TRAVELING

Before you begin your journey, whether you are headed to a World Tournament or any other destination, check the "**Transportation Cabinet**" websites in each state that you plan on traveling through. On these transportation websites, you will find highway construction information and notices, road closures, construction zones, and detour information to make your trip easier to navigate and save you time before you hit the road. If you have AAA, contact them as well for information. Always remember to have plenty of gas and keep your phones charged.

AIRLINE HACKS

If you are a frequent traveler/flyer, and you use rewards points or have joined an airline rewards system, try this tip! "*Delta Airlines*" offers a baggage claim reward. If you're checking a bag, when your flight gets to your destination, if your bag takes longer than 20 minutes to get to the baggage claim, you get bonus miles!

The clock starts when the boarding door opens. Immediately start the timer on your phone as soon as the boarding door opens and take a screen shot as proof of time. You submit your name, SkyMiles information on this website form within three days of your arrival and if you qualify, you get 2,500 bonus miles. A review of the determinants and trends of participation in sport for older adults:

According to the National Library of Medicine, Sport, and ageing: a systematic review of the determinants and trends of participation in sport for older adults how many men and women 65 or older compete each week in a league, tournaments etc. How many do not compete in sports because of health and safety issues or the insecurities of falling? Given the negative stereotypes towards aging and the elderly that prevail in Western society, perhaps the tendency of seniors to avoid physical activity and sports is not overly surprising.

Certain studies have suggested that seniors themselves internalize these negative attitudes and stereotypes, which in turn influence their decisions to partake in any physical activity, sport, and other health-promoting behaviors. In particular, evidence suggests many older women believe activities that involve exertion and are physically fatiguing are too risky for their health; consequently, they tend to avoid sport and exercise. *Populations throughout the world are ageing, and the number of people aged over 65 years is shortly expected to outnumber children under five years old.* As people age, they are more likely to suffer from ill health, including chronic disease. Physical inactivity is a significant contributor to the development of chronic diseases, therefore regular physical activity is important for older adults' health and quality of life.

The health benefits of physical activity, specifically for older adults, have been comprehensively researched. For older adults, physical activity can be beneficial for physical, mental, and social health. Besides the health benefits of regular participation, other aspects of participation among older adults have also been reviewed. Previous systematic reviews on physical activity in this population group have for example focused on: the physical health risks involved in participation, the differences between determinants of physical activity and exercise, whether older adults are meeting the recommended physical activity participation levels, the health benefits, strong social networks and the effect of physical activity in alleviating depression in older adults. Although the health benefits of generic physical activity have been extensively researched for older adults, there is little research on sports as a form of leisure-time physical activity for this population group.

This limited research has largely focused on Masters/Senior Games sport participation or on specific sports, such as bowls, golf, curling, rather than general community sport. As the determinants of participation may vary for different forms of exercise, specific research for older adults and general community sport participation is required. A community sport is defined as "a human activity capable of achieving a result requiring physical exertion and/or physical skill which, by its nature and organization, is competitive and is generally accepted as being a sport".

Deriving benefits of physical activity can influence continuation of participation. In sports, there have been a number of systematic reviews examining the concept of sport being beneficial for health for younger age groups, but not specifically for older adults, who may have different health outcomes. Therefore, with the expected declining health of an ageing population, it is important to investigate the determinants of initiating and continuing sport participation for older adults, to diversify the physical activity options available to this age group.

Using sport as a tool to develop a social/community connection for older adults using sports for the development and maintenance of community engagement for older adults; and using sport to foster social connections had a very positive effect.

Horseshoes and the use of computers has come a long way when it comes to putting stats together with Walter Ray Williams Jr's program that was DOS based to the program we know and use to today, HSMaster/ HSScorekeeper that Kurt Whaley created. One thing that has also evolved is going from NATSTATS to eShoe, instead of waiting for that weekly Tournament update, we now can update and send tournament results instantaneously with eShoe right from HSMaster after the tournament has concluded. Now we are on the verge of using a popular mobile app Scoreholio to keep track and keep score of games both cancelation where you can keep track of ringers and points, to just playing games to 21 like we



do in the backyard. One thing that I hope we can see in a few years is the use of Scoreholio at large Horseshoe Tournaments. My own personal goal is to use the app more starting in 2024 to get better familiar with the app. Scoreholio has some great resources available on their website <u>www.scoreholio.com</u> and also on Facebook. They have multiple support pages that have super users and even the creator Ben monitors when it comes to answering any and all questions that might arise.

Live Streaming the game we all know and love, and we haven't even scratched the surface. One thing that we are continuing to run into is which pathway we should take when it comes to replacing and updating the cameras of old that have been used for over 10 years at the World Tournament. The NHPA was very fortunate to get some help from the NHPF and many other gracious donors when it comes to the purchase of the Nest/Dropcam wireless cameras that we used for many years up until this World Tournament in 2024.

Cadets graduate to Junior classes while Reynolds ages out

2024 will see at least 4 youth pitchers move into different divisions as Eli Sullivan, Tom Grose and Landon Morgan all move from the Cadet Boy's divisions to the Junior Boy's divisions, while defending Junior Boys champion Derek Reynolds graduates from the youth ranks into the adult division. With the absence of the class favorite in Reynold's, who will step up and claim the world championship in the tri-cities this summer? Landon Morgan made his mark with strong games and a strong finish at the 2023 world tournament in Lansing, Michigan, proving to everyone he was a big game player on horseshoe pitching's biggest stage. Tom "TJ" Grose also made waves, defeating 2-time world champion Eli Sullivan in the first round of their preliminary class last year. TJ finished the year strong with an appearance and class win on the horseshoe tour while observing the 30' foul line to compete on the tour. Defending Cadet Boy's world champion Eli Sullivan also finished the year strong defending his Virginia state championship. Eli would have to be the favorite moving into 2024 amongst the three boys due to him observing the 30' foul line this past year and averaging 80% from that line in the Cadet Boy's World Championship class. Another key player who will by shooting for that allusive Junior Boy's World Championship is Hastiin Begaye. Hastiin has been right at the top in recent years and this coming year could be Hastiin's year to take the World Championship home with him. Will Hastiin capture the Boy's World Title this year, will there be another breakout junior boy in Washington, or will one of the three cadet transfers hammer their way to a World Title their first year in the new division?

Same game different experiences

The holiday seasons have now passed and hopefully everyone has had a phenomenal season with family and friends. With many states already setting their schedules for 2024 tournaments, have you begun planning your 2024 horseshoe season yet? Top 64 Juniors – March Madness

I mentioned in the previous Newsline that I would be getting our World Tournament Predictions group back together to determine the best Junior Pitcher in world tournament history. The 64-player bracket has been set and will be picked and included in the next Newsline, just in time for March Madness. The seeding was done based off these factors:

World Tournament Championships World Tournament Prelim Class Wins (A-class) Averages in World Tournament Appearances Strength of class at time of performance

Game by Game predictions will be determined by the opinions of the group members based on the selection factors along with a more in-depth analysis of each youth pitchers' performances. However, no consideration will be given to what was done after the pitcher entered the adult divisions due to this being only about their youth division performances. It's worth noting that the only active youth pitchers in the bracket are Eli Sullivan and Hastiin Begaye. Derek Reynolds has subsequently aged out of the division and Sarah Chaffee's previous 2 years of World Tournament performances were in adult divisions. However, Sarah Chaffee is the only Junior Girl to be a #1 seed in the bracket. She joins Jim Walters, Alan Francis, and Walter Ray Williams Jr as the 4, #1 seeds in the bracket with Jim Walters being the #1 overall seed in the entire bracket. Will Jim Walters prevail as the top youth pitcher in World Tournament History, or will our selection group eye a different winner after reviewing the data?



Kentucky's Here - Topeka, Kansas, 2015 WT

An article I've been wanting to put together for a while begins with my home state, the goal is to highlight those rare "turning points" that put charters or individuals in a national light they're either seeing for the first time in a while. The latter would be the case with Kentucky, historically home to many good pitchers, often well represented in the adult divisions of the World Tournament. Charlie Meredith, James "pop" Johnson, Jack Fahey "Kentucky Jack", Sue Snyder, Becky Kemper, Tony Hankins, and many more often travelled to the World Tournament and even claimed championships in different years. With Sue Snyder being the most infamous of the bunch, Kentucky even laid claim to a former Men's World Champion in Don Titcomb at one time. While Kentucky has always been represented well in adult divisions at the world tournament, the youth division wasn't as strong in many years. Tony Hankins claimed the 1986 World Championship in the Junior Boys division, in a field including Alan Francis, before moving into the Men's division claiming several state championships. Son of Kentucky legend Charlie Meredith, Ronnie Meredith lays claim to being the best Junior pitcher in Kentucky's long history with many 80%+ tournaments, and several state

championships. Ronnie would've undoubtedly became a Junior Boy's world champion, had it not been for one of the best Junior Boys in history in Jim Walters standing in the way, along with other top tier Juniors in Vorn Ven. After Ronnie, it had been over two decades since Kentucky put a junior boy in the spotlight at the World Tournament.

Tyler Howard would first appear at the World Tournament in 2009, and I would first attend the World Tournament in 2012 making the championship class with both Tyler and Alex Humes of Kentucky. 2013 and 2014 would be strong years for Kentucky's Junior Boys pitchers as well, I was able to finish 3rd in the 2013 World Tournament, then both Tyler and I would meet in the championship class in 2014, in Buffalo, New York. When 2015 rolled around both Tyler and I had good odds of performing well in that year's World Championship. Being centrally located in Topeka, Kansas, the event drew better numbers than recent years producing a wildly unpredictable field of pitchers who could win that year's championship. Both Tyler and I would find ourselves in the Junior prelims A-class where we would meet in a playoff to determine the preliminary world class champion. In this playoff, I was able to get off to a hot start jumping ahead of Tyler in the first half of the game. After that I just needed to run out the clock in the 40-shoe game, I was able to pickup that win and a world class championship against Tyler on that Friday afternoon. The next day would be the championships and with Tyler being the #2 overall seed and myself being the #1 seed the stage was set for a final game between the two pitchers from Kentucky, if we could get through a tough championship field with perfect records each that was. We would both go through the first half of the championship round unscathed, winning key games against the California boys in Travis Sluys and defending champion Hayden Lee. I would pull out a tight game against New Hampshire's Brandon Pearl, but then Pearl would hand Tyler his first loss of the day.

Then the final game would begin, being my last Junior year and Tyler with 1 to go and a rivalry that was already well documented on the state level. We would both be in a must win situation with Tyler needing to win to force a playoff and my win would end the tournament and an eager Brandon Pearl watching from the court over, the World Championship hinged on this game. Tyler and I would have a 94-shoe marathon to get to 40 points before Tyler took the game, forcing a 3-way playoff. The playoff began with Tyler Howard playing Brandon Pearl again. Tyler quickly dropped Pearl with a 21 ringer for 24 shoe flurry, quickly ending Brandon's championship hopes and setting the stage for another showdown between the two Kentuckians. The picture with the article will show the scene before the playoff: Myself, Tyler, incumbent president Stu

Sipma, incumbent Sec/Treas David Sidles, Junior Director Aleena Lepak (Cook), and legendary judge Bob Beagle standing idly by as we discussed the coming game. At this time, Tyler and I, along with everyone else

had no idea what would happen as every game we played seemed to have a different outcome. The game to come remains the longest game in the last 32 years with the longest game before this coming before either of us were born in 1992 when Jim Walters met Vorn Ven in a 108-shoe battle. Tyler and I would need to pitch a 106-shoe marathon before either of us could achieve the 40-point mark. After several four dead calls in a true battle of wills, at a point where the next missed shoe could end the game, Tyler would have a double laying as I tossed my first shoe covering the double. As my second shoe hit, there was simply too much metal around the stake and with a combined gasp from the crowd, it would come back as fast as it went on, leaving a 3 ringer 3 laying for Tyler. This call at the end of the playoff would give Tyler his first World Championship and put the two pitchers from Kentucky on the World Tournament radar for years to come but wouldn't end the continuous rivalry.

Our pitching careers seemed to run parallel before and after this event with Tyler always staying 1 ringer ahead with me catching him from time to time. After this I would take the 2016 year away from the World Tournament while Tyler would pitch his last year as a Junior, defending the World Championship in another playoff with another fellow Kentuckian Seth O'Nan, who has since fallen off the horseshoe map. After aging out of the boys' division we both quickly met again in the Men's Championship in both of our first appearances in 2018. This was Tyler's first adult year at the world where his talent would be on full display in defeating the goat Alan Francis in both the preliminary and championship rounds this year. While Tyler didn't capture the Men's World Title that year after having a tough third day, he's remained a staple of not only Kentucky horseshoes but big tournament play at the world tournament and ringer classic style tournaments in the years since. We've both had the best of mentors with Charlie Meredith of Kentucky teaching me the vast majority of what I know about pitching horseshoes and the late 3-time world champion Brian Simmons coaching Tyler in recent years, it's only a matter of time until we can once again meet in a battle of wills on a big stage and represent Kentucky horseshoe pitchers until the next generation comes along.

Are there other defining youth battles from the same state that have put your state in the national spotlight? If so, send me an email and I'll likely do another article soon showcasing other states youth history at the world tournament!

Only one (1) event is required for Juniors. Exceptions for US Armed Forces members and family and foreign competitors (other than Canadians) are outlined in Rule 11, Sec D.1 of the RGS Book. Contact NHPA for more information regarding qualifying exceptions. All averages used will be the average on record in eShoe as of **May 20, 2024**. Anyone qualifying under an exception must have those scores recorded by the same date. All NHPA and any special tournament rules apply. Please see note regarding refunds.

READ CAREFULLY: Any adult male pitching from the full distance platform may enter the **OPEN MEN'S DIVISION** regardless of age, just as any adult female may enter the **OPEN WOMEN'S DIVISION**. To enter the **SENIOR DIVISION**, you must be 60 years of age or older before the end of 2024. 


